eFigure 1. Examples of Study Messages and Reminders

The figure displays three example messages in separate boxes, each starting with 'Dear XXX,'. eTable 1. Outcome Definition Table

Unless otherwise specified, all electronic health record (EHR)-based outcomes were assessed within 4 months of the estimated due date (EDD).

Self-reported outcomes occurred at the time of endline survey completion, unless otherwise noted. Endline surveys were sent to participants approximately 5 months after the EDD.

The trial protocol specified an a priori plan to examine outcomes among the different eligibility conditions (e.g., hypertension, diabetes). Those included in the clinicaltrials.gov registry (NCT 05543265) at the time of initial study entry (9/13/22) are designated in the table.
