Appendix A: Policymaker interview guide used and adapted slightly for data collection in each country: India, Indonesia, and Nigeria.

- Types of policies (distancing, PPE, treating COVID-19 cases, price caps, purchasing services from private sector providers, other respiratory diseases)?
- Timing of policies (e.g., still in effect? Only in effect during active lockdowns?)
- Is there any policy in place that allows your department to take over any private facilities for COVID-19 care? If yes, what factors made you and your department decide to take over these facilities or decide not to take them over?
- o Is there any policy in place that allows the federal or state government to implement price caps to private sector providers? If yes, were these policies used during the

pandemic for COVID-19 or other health services besides COVID-19? If yes, what other health services did the price caps apply to?

- 9. How is your agency/department enforcing these regulations/policies?
- 10. Are there any other COVID-19-related legislations/policies/regulations not under your department/agency's purview that directly affect private health facilities?

11. What has been the response from providers regarding these policies/regulations?

- If there has been a negative response, how has your department addressed these concerns?
- 12. How satisfied are you with private sector engagement in COVID-19 so far?

Follow-up/probing questions

- Do you have any concerns about the performance of the private health care sector in the light of COVID-19?
- 13. What are you and your department anticipating as next steps in the coming months?
