Supplementary Text

Methods: parametric g-formula

We used the Stata package gformula to conduct parametric g-computation to estimate the total causal effect (TCE), natural direct effect (NDE) and the natural indirect effect (NIE). G-formula uses Monte Carlo simulations to simulate the outcome, mediators and intermediate confounders under hypothetical interventions or "counter to the fact" scenarios (i.e. contrary to the intervention individuals actually received). The TCE is the value the outcome (e.g. any UI) would take if all individuals had been exposed to a one-unit increase in ACE score versus everyone not being exposed to a one unit increase in ACE score. The NDE is the direct (unmediated) effect of the exposure (e.g. ACE score) on the outcome (e.g. any UI) when the mediator (e.g. IL-6) takes the value it would be in absence of the exposure (i.e. ACE score of zero). More specifically it is modelled as the direct effect of exposure X = x+1 (e.g. an ACE score of 1) versus exposure X = x (e.g. an ACE score of 0) on outcome Y (e.g. any UI) if mediator M (e.g. IL-6) were set to whatever value it would be for X = x. The NIE is the effect of the exposure (e.g. ACE score) on the outcome (e.g. any UI) that operates by changing the mediator (e.g. IL-6). More specifically, it is modelled as the effect on outcome Y (e.g. any UI) if the exposure X = x+1 and the mediator M (e.g. IL-6) were changed from the value it would take if X = x to the value it would take if X = x+1. The proportion of the TCE that is mediated is calculated as $[OR_{NDE} (OR_{NIE} - 1)] / [OR_{NDE} \times$ $OR_{NIE} - 1] \times 100.^2$

Specifically for this analysis we used a Monte Carlo sample size of 100,000 to minimise fluctuations in effect estimates. Standard errors were estimated using 500 bootstrap samples. We also specified the command option *linexp* to specify that the exposure is continuous and its effect is assumed to be linear. For the imputed data we conducted mediation analysis for each of the 80 imputation datasets and output the results to log files. We used R to extract the log ORs and bootstrapped SEs for each of the TCE, NDE, and NIE from each log file. The mean of the log OR was computed and the SEs were calculated using Rubin's rules.³ The 95% confidence intervals were calculated from the combined log OR and SEs. Log OR (and 95% CIs) were exponentiated to represent ORs.


Results: description of sample

Supplementary Table 5 shows the descriptive statistics of study variables for the imputed and complete case samples. Any UI was reported by 5.3% of adolescents, with 4.6% and 4.5% of adolescents experiencing daytime wetting and bedwetting respectively. The most common LUTS were voiding postponement (15.6%) and nocturia (10.5%), while high frequency of urination was the least common (4.3%). All LUTS were moderately correlated (Rho 0.14-1.00) (see Supplementary Table 6). Prevalence of ACEs within the complete case data and imputed sample are given in Supplementary Table 7. In total 61.3% of individuals experienced at least one adversity between birth and 8 years of age within the imputed sample, whereas the prevalence in the complete case sample was 53.4%. Within the imputed sample 4.2% of individuals experienced ≥5 adversities. Due to sparsity of data for scores of seven or more, these scores were collapsed to represent a score of 7+. The most common adversity experienced was poor mental health or attempted suicide of parent(s) (36.2%), while the prevalence of sexual abuse was lowest at 1% within the imputed sample.

Supplementary Figure 1 Directed acyclic graph (DAG) of mediation model 1 and model 2



Mediation model 1 illustrates the mediating effect through IL-6; mediation model 2 illustrates the mediating effect through CRP and including IL-6 as an additional intermediate confounder. Each intermediate confounding path (age at blood draw, BMI, emotional and behavioural problems, and constipation (and II-6 for model 2) were specified separately but are grouped together for clarity. For simplicity baseline confounders are omitted from the DAG as all confounders are proposed to cause all other model variables. ACEs adverse childhood experiences; LUTS lower urinary tract symptoms; BMI body mass index; CRP Creactive protein; IL-6 interleukin 6.
