## S1 Appendix. Model Specification

The first part of the model involved creating a binomial model predicting the odds of TAVR price-disclosure as follows:

Then, using the results from the first part of the model, we extracted a probability of TAVR price disclosure,  $\hat{p}$ . Then for the second part of our model, we used a Log-Linked Gamma Model to model the median TAVR price only within the hospitals that disclosed prices:
