Supplementary Material 2: Discipline-specific results

The results reported here are discipline specific. Ticks indicate that at least one participant engaged in the activity. Given the relatively small sample sizes, absence of evidence from our sample that health professionals have engaged in the specific activity should not be interpreted as evidence that these activities have not been undertaken by allied health professionals.

Occupational therapy

Enhancing outdoor natural environments

Only one social worker in our sample engaged in advocacy for the addition of or improvement to outdoor natural spaces. They reported advocating for the organisation to move their premises to a location with more outdoor space.
