## 30 Abstract

### 31 Objectives

32 Neuromuscular respiratory failure after cervical spinal cord injury (cSCI) can lead to dependence

- 33 on an invasive mechanical ventilator. Ventilator-free breathing after cSCI is associated with
- 34 improved morbidity, mortality, and quality of life. We investigated the use of diaphragm muscle
- 35 ultrasound to predict ventilator weaning outcomes after cSCI.
- 36

37 Methods

38 This is a retrospective case series conducted at a university-affiliated freestanding inpatient

39 rehabilitation facility. We identified patients with cSCI who had a tracheostomy and were

40 dependent on an invasive mechanical ventilator at the time of admission to inpatient

41 rehabilitation. A diaphragm muscle ultrasound was performed, which included measurements of

42 the thickness of the diaphragm and a calculation of the thickening ratio (TR), which reflects

43 diaphragm muscle contraction. The primary outcome measure was the need for mechanical

44 ventilation at time of discharge from the inpatient rehabilitation facility. Successful ventilator

45 weaning was defined as either daytime or full 24-hour ventilator-free breathing.

46

### 47 Results

Of the 21 patients enrolled, 11 (52%) were able to wean successfully (partially or fully) from the
ventilator. Of the ultrasound measurements that were taken, the TR was the optimal predictor for
ventilator weaning outcomes. A threshold of TR≥1.2 as the maximum hemidiaphragm

51 measurement had a sensitivity of 1.0 and specificity of 0.90 for predicting ventilator weaning.

- 53 Conclusion
- 54 Normal diaphragm contractility (TR  $\geq$ 1.2) as determined by diaphragm muscle ultrasound is a
- 55 strong positive predictor for successful ventilator weaning in patients with cSCI.
- 56 Utilizing diaphragm ultrasound, rehabilitation physicians can set precision rehabilitation goals
- 57 regarding ventilator weaning for inpatients with respiratory failure after cSCI, potentially
- 58 improving both outcomes and quality of life.

# 63 1. Introduction

64	Dependence on a ventilator after cervical spinal cord injury (cSCI) has important implications
65	for morbidity, mortality, and quality of life. People with cSCI who rely on mechanical
66	ventilation are almost 40 times more likely to die during the first year after injury compared to
67	those who are not ventilator-dependent, <sup>1</sup> and long-term mortality rates remain up to 3.5 times
68	higher for those who require mechanical ventilation after the first year of injury. <sup>1,2</sup> This excess
69	mortality is predominantly a result of respiratory disorders, and the most common causes of
70	death for ventilator-dependent people with SCI are pneumonia and other respiratory
71	complications. <sup>3</sup> People with SCI who are ventilator-dependent report a more negative perception
72	of their health status, lower social integration scores, and worse quality of life outcomes
73	compared to people living with SCI who do not require a ventilator. <sup>4</sup>

85 clinical tools to both determine readiness for ventilator weaning and serve as an accurate86 predictor for successful ventilator-free breathing outcomes.

88 Current clinical tools used to predict successful ventilator-free breathing include bedside 89 spirometry and respiratory function parameters (such as vital capacity and negative inspiratory 90 force), fluoroscopic evaluation of the diaphragm, phrenic nerve conduction studies (NCS), and needle electromyography (EMG) of the diaphragm muscle.<sup>9</sup> While bedside spirometry and 91 92 fluoroscopic evaluation of the diaphragm are non-invasive methods to diagnose diaphragm dysfunction, they are less sensitive than other techniques.<sup>9</sup> Conversely, while needle EMG and 93 94 phrenic NCS are sensitive tests for diaphragm dysfunction, these methods are more invasive and 95 require a highly skilled practitioner to perform the procedures and interpret the results. 96 Moreover, needle EMG of the diaphragm can be associated with risk of diaphragm injury and 97 pneumothorax, while phrenic NCS has a high false positive rate associated with lack of response on NCS despite intact diaphragm muscle innervation.<sup>10</sup> 98 99 100 Ultrasound of the diaphragm muscle has been used to evaluate diaphragm function and 101 contractility in the context of a variety of disorders including phrenic nerve injury, direct 102 diaphragm injury, lung transplantation, and more recently, respiratory dysfunction after COVID-19 infection.<sup>11,12</sup> Prior work from Boon and colleagues has reported a 93% sensitivity and 100% 103 104 specificity of this mode of diaphragm ultrasound in identifying neuromuscular diaphragm 105 dysfunction from phrenic neuropathy.<sup>11</sup> 106 107 The purpose of this study was to investigate the efficacy of diaphragm muscle ultrasound to

108 predict ventilator weaning outcomes after cSCI in patients dependent on mechanical ventilation.

### 110 2. Materials and Methods

111 This study is a retrospective case series via chart review of data obtained as part of routine 112 patient care where the sonographer was not blinded to the patient's diagnosis. Northwestern 113 University's Institutional Review Board (IRB) approved the study (STU23625789). This 114 included a waiver of informed consent, justified by the minimal risk to subjects and the 115 impracticality of obtaining consent for this review. The IRB's approval ensured compliance with 116 ethical principles, including patient privacy and data confidentiality, in line with the Declaration 117 of Helsinki. 118 119 This study was conducted at a university-affiliated freestanding acute rehabilitation hospital. We 120 identified patients with cSCI who had a tracheostomy and were dependent on invasive 121 mechanical ventilation for any number of hours at the time of admission to the rehabilitation 122 unit, and who were referred for a neuromuscular diaphragm ultrasound. As part of our 123 institution's interdisciplinary ventilator liberation program, all patients with cSCI on a ventilator 124 who have a goal of potential ventilator weaning are referred for a diaphragm ultrasound 125 evaluation. We collected demographic and clinical data including time from injury, American 126 Spinal Injury Association (ASIA) Impairment Scale (AIS) neurologic level of injury and 127 completeness of injury, and number of hours per day spent on the ventilator. 128 129 A practicing physician (CKF) board certified in both Physical Medicine and Rehabilitation and 130 Neuromuscular Medicine (American Board of Physical Medicine and Rehabilitation), and who 131 holds the Neuromuscular Ultrasound Certificate of Added Qualification (American Board of

132 Electrodiagnostic Medicine), performed the diaphragm muscle ultrasound examinations. This 133 study followed a protocol for diaphragm ultrasound evaluation as previously published by Farr et 134 al, based on Boon's original study, since it corresponds to the normative data set, and was taken 135 from a similar population of healthy controls within the same geographic area as our study 136 population.<sup>10,13</sup> Typically, the sonographic evaluation includes a B-mode examination of each 137 hemidiaphragm, with measurements of the thickness of the hemidiaphragm muscle both at 138 maximal inspiration (i.e. total lung capacity, TLC) and at end expiration (i.e. functional residual capacity, FRC).<sup>11</sup> At FRC in the zone of apposition, a diaphragm thickness of  $\ge 0.15$  cm is 139 considered normal, with a thickness less than this cutoff consistent with diaphragm atrophy.<sup>10</sup> 140 141 From these two measurements of diaphragm size, a thickening ratio (TR) can be calculated, 142 where TR = thickness at TLC / thickness at FRC (Figure 1). The TR reflects diaphragm muscle contractility, with a normal TR $\ge 1.2$ .<sup>10</sup> Our sonographic evaluation included examination of each 143 hemidiaphragm using a low intercostal approach (8<sup>th</sup> or 9<sup>th</sup> intercostal space) along the anterior 144 145 axillary line (Figure 2). The ultrasound evaluation included measurements of the thickness of 146 each hemidiaphragm at maximal inhalation (or TLC) and exhalation (or FRC), as well as a 147 calculation of the TR as a marker of diaphragm contractility. These measures are taken 148 bilaterally (one measure for each hemidiaphragm). In general, patients with only one paretic hemi-diaphragm are not expected to be completely ventilator dependent.<sup>14</sup> As such, we preferred 149 150 to use the maximum measurement of the two sides to determine if this function may predict the 151 ability to wean from the ventilator.

After sonographic evaluation, the medical team performed a clinical assessment of respiratory
parameters (including vital capacity, negative inspiratory force, resting tidal volume, and

155 CO2/arterial blood gas results) to determine readiness for ventilator weaning. Once these 156 respiratory parameters fall within safe guidelines, the ventilator weaning process follows a 157 progressive ventilator free breathing protocol, where patients spend progressively increasing 158 intervals of time off the ventilator each day, and which is the most successful method of 159 ventilator weaning for people with SCI (see **Supplemental File 1**).<sup>15</sup>

161 The primary outcome measure was the need for mechanical ventilation at the time of discharge 162 from acute inpatient rehabilitation. The outcomes of patients in our data set could be grouped 163 into two categories: no meaningful ventilator weaning (off ventilator for <1 hour per day), and 164 successful ventilator weaning (including both daytime ventilator-free breathing with nocturnal 165 use of the ventilator, and full ventilator weaning). Because daytime ventilator-free breathing is 166 associated with improved outcomes and quality of life, analysis was performed by categorizing 167 patients as either successfully weaned from the ventilator (full or daytime) or not weaned. 168 Logistic regression models were fit, and the area under the receiver operating characteristic curve 169 was used to determine the best predictor of successful (full or partial) weaning. Sensitivity and 170 specificity were then calculated.

#### 172 **3.** Results

This retrospective case series followed 21 patients who were screened by ultrasound for their
candidacy for ventilator weaning during their inpatient rehabilitation admission (Table 1). There
were 19 male and 2 female patients, with an average age of 44 years (range = 17-78 years). All
patients sustained a traumatic cSCI, ranging from C1-C5 neurologic level of injury, and AIS A-C

177 completeness. All patients required mechanical ventilation via tracheostomy at the time of178 admission to acute inpatient rehabilitation.

179

180 At time of discharge, 11 patients (52%) achieved successful (full or daytime) ventilator-free 181 breathing, while 10 patients did not achieve meaningful ventilator-free breathing. The mean TR 182 calculated from the best hemidiaphragm measurement for patients who achieved ventilator-free 183 breathing was 1.6, while the mean TR for patients who did not achieve ventilator weaning was 184 1.1 (**Table 2**). Median TR was also calculated for both groups given outlier data within the data 185 set. The successfully weaned group had a median TR of 1.4, and the unsuccessfully weaned 186 group had a median TR of 1.0 (**Table 2**). Using a cutoff of TR≥1.2 resulted in 100% sensitivity 187 and 90% specificity for predicting successful ventilator weaning (Table 3). 188 189 Within our study population, all 11 patients who achieved successful ventilator weaning had a 190 maximum TR of 1.2 or greater (Table 3), and 8 of those patients (72%) in this group had normal 191 TRs bilaterally. Of the 10 patients who did not wean from the ventilator, 9 had impaired or 192 absent contractility bilaterally, and only one patient had a normal maximum TR (patient #12), 193 though did have their rehabilitation course complicated by recurrent pneumonia. 194 195 The receiver operating characteristic curve was plotted with an area under the curve of 0.95. 196 which indicates a high overall performance of the best thickening ratio as a diagnostic test for 197 successful ventilator wearing at the chosen cutoff of 1.2. The sensitivity at this cutoff was 100%, 198 indicating that all successful weaning cases were correctly identified using this cutoff. The 199 specificity was 90%, indicating that 90% of the failures were correctly identified as such when

200	using the cutoff of 1.2. A high sensitivity and specificity suggest that a cutoff of 1.2 for the best
201	thickening ratio is a good threshold for predicting successful ventilator weaning.

#### 203 4. Discussion

The use of diaphragm ultrasound provides valuable information about the diaphragm muscle's innervation status,<sup>16</sup> which is especially important in the case of patients with C3 or C4 level injuries where diaphragm dysfunction may be a consequence of mixed upper and lower motor neuron lesions, so retained partial innervation cannot be assumed, and ventilator weaning outcomes are variable. The inability to accurately predict short- and long-term ventilator needs interferes with delivering optimal care for patients after cSCI.

211 Our findings demonstrate that a normal thickening ratio as determined by diaphragm ultrasound 212 evaluation is a strong predictor of successful ventilator-free breathing. Evidence of intact 213 contractility on ultrasound can indicate weaning potential for patients who would typically not be 214 expected to wean from the ventilator based on their injury levels. In our study, for example, two 215 patients with C2 AIS A injuries were found to have intact contractility bilaterally and were both 216 able to successfully wean from the ventilator. Conversely, evidence of abnormal diaphragm 217 contractility can also indicate the need for caution with ventilator weaning attempts. Two 218 patients who would be expected to retain some degree of diaphragm innervation given their 219 injury level (C3 and C4 levels of injury) both displayed absent contractility bilaterally and were 220 ultimately unable to wean from the ventilator.

221

222 For patients unable to fully wean from the ventilator at time of discharge from acute care,

223 options for ongoing rehabilitation are often limited. Many acute inpatient rehabilitation facilities 224 cannot accept patients requiring mechanical ventilation due to inadequate staffing. In these cases, 225 patients who require mechanical ventilation at time of discharge from acute care are sent to long-226 term acute care facilities to attempt to wean off the ventilator prior to admission to an inpatient 227 rehabilitation unit. This results in a delay in intensive rehabilitation therapies, which are critical 228 in the early stages of recovery from SCI. Acute inpatient rehabilitation facilities that can manage 229 patients on a ventilator are thus uniquely able to both provide intensive rehabilitation therapies 230 and potentially work towards ventilator weaning. Clinical tools that can help better identify 231 which patients may be able wean from a ventilator successfully can help guide clinical practice 232 and rehabilitation goal setting.

233

Within our treatment center, the application of our findings has contributed to the development
of a treatment algorithm to guide our approach to ventilator weaning for patients with SCI
(Figure 3). Specifically, our approach includes an evaluation of diaphragm atrophy and
contractility during initial evaluation for patients with cSCI who are ventilator-dependent on
admission.

Patients who demonstrate normal contractility of the diaphragm and no significant atrophy are deemed to be good candidates for eventual ventilator weaning, even when other traditional markers for readiness to wean, such as vital capacity or negative inspiratory force, are not indicative of successful weaning at the time of evaluation. For those with present but impaired contractility of the diaphragm, it is felt they may eventually be able to achieve some degree of

245 ventilator-free breathing but likely require further optimization including respiratory muscle 246 strength training and cardiopulmonary rehabilitation strategies. For those patients, a cautious 247 approach to ventilator weaning is adopted with a focus on cardiopulmonary optimization. 248 249 For patients with significantly impaired or absent diaphragm contractility, diaphragm atrophy 250 becomes an important clinical feature (Figure 4). In general, an upper motor neuron injury that 251 occurs above the anterior horn of the spinal cord results in impaired contractility of a muscle 252 with minimal muscle atrophy in the subacute period when patients with new cSCI are admitted 253 for inpatient rehabilitation. By contrast, lower motor neuron injuries occur due to damage to the 254 anterior horn cell, the nerve root, or the peripheral nerve, and often result in severe muscle atrophy in the subacute period due to muscle denervation.<sup>17</sup> 255 256 257 Patients who demonstrate absent contractility but normal thickness of the diaphragm (i.e. no 258 atrophy) are identified as potential candidates for diaphragm muscle pacing, which involves 259 implantation of electrodes to either the phrenic nerves at the neck or at the phrenic motor points 260 within the diaphragm muscle itself. Both techniques require intact phrenic nerves, and 261 denervation of the diaphragm is a contraindication. The benefits of diaphragm muscle pacing 262 include partial or complete ventilator-free breathing, reduction in pulmonary infections, and improved comfort and speech production.<sup>18-21</sup> At our center, a thoracic surgery team performs 263 264 this evaluation and implantation of the pacer system. 265

Findings of lack of diaphragm contractility in conjunction with significant atrophy indicatedenervation atrophy and axonal loss. In these cases, diaphragm pacing is not indicated. Other

268	surgical interventions, such as nerve transfers, may be a possibility, and were recently considered
269	in a prospective case series by Kaufman and colleagues. <sup>22</sup> Additional studies are needed to
270	further investigate the role of surgical interventions in achieving ventilator-free breathing after
271	cSCI.
272	
273	Limitations of our study include the retrospective study design and the single center setting.
274	Though our sample size is relatively small, the patient population in question (ventilator-
275	dependent patients with cSCI) is itself small in size, and our study represents a unique case series
276	investigating the use of diaphragm ultrasound in this patient population.
277	
278	Our data suggests that diaphragm ultrasound is a highly promising tool in prognosticating the
279	ability to wean from a ventilator after cSCI. Future prospective studies are needed to better
280	assess the impact of diaphragm muscle ultrasound as a tool to predict ventilator weaning
281	outcomes.








Figure 3. Clinical algorithm for ventilator weaning based on measurements of contractility and muscle thickness on diaphragm muscle ultrasound evaluation. Of the 21 participants in our study, 12 demonstrated intact contractility without significant atrophy, and were considered for ventilator weaning. Of the 9 participants with absent contractility, 7 showed normal diaphragm muscle thickness (no atrophy), and 2 of these eventually underwent diaphragm pacer placement. Of the patients with absent contractility, 2 also demonstrated significant atrophy, and were not




candidates for diaphragm pacing.

**Supplemental Figure 2**. The Receiver Operating Characteristic (ROC) curve has been plotted with an area under the curve (AUC) of 0.95, which indicates a high overall performance of the best thickening ratio as a diagnostic test for successful ventilator weaning at the chosen cutoff of

1.2. The sensitivity (true positive rate) at this cutoff is 100%, meaning that all successful weaning cases were correctly identified using this cutoff. The specificity (true negative rate) is 90%, indicating that 90% of the failures were correctly identified as such when using the cutoff of 1.2. A high sensitivity and specificity suggest that a cutoff of 1.2 for the best thickening ratio

is a good threshold for predicting successful ventilator weaning.
