Objectives:	
To draw the veterinary drug value chain with the identification of all stakeholders involved in it and to characterize interactions and roles of each stakeholder	
First step: identify all the stakeholders involved in the value chain	
Topics	Information required
<ul style="list-style-type: none"> - To identify all the stakeholders involved in the veterinary drug supply chain ➔ Post-it on the dashboard (different colors for private/public) <p><i>Focus on Abs and then ask if the stakeholders are the same for the alternatives feed additives</i></p>	<ul style="list-style-type: none"> - Please, try to identify all the stakeholders involved in the Veterinary drug supply chain - Public regulators (from central to local): MARD, DAH, DLP, ... - Research institution, university - International organizations (research institutions, projects, cooperation, ...) - Private sectors (importers, pharmaceutical industries, feed industries, animal drugs sellers, integrators, farmers, ...) - Informal sellers
<ul style="list-style-type: none"> - What are the roles of each stakeholder in the value chain? ➔ Group all the stakeholders with the same roles on the dashboard 	<ul style="list-style-type: none"> - Regulation - Production/Importation - Distribution - Prescription - Selling - Usage - Research/Project
Second step: draw the veterinary drug value chain	
Topics	Information required
<ul style="list-style-type: none"> - To draw the ABs flow in poultry production (including medicated feed) ➔ Draw the arrows of the flow of products - To complete the map flow with proportion (<i>if possible, depending on the respondent</i>) ➔ Write the proportions on the arrows <p><i>Draw the Abs flow and alternatives feed additives if different</i></p>	<ul style="list-style-type: none"> - Where the farmers can buy ABs for their poultry? - Who are the sellers? - How is organized the production/distribution/wholesale for ABs? - Where do the ABs come from? <i>What is the proportion of imported products?</i> - Are ABs sold abroad? <i>Where? What is the proportion?</i> Do you know of any illegal importation? <p>Do you know of any informal source of AB (middlemen, reselling....)?</p>

<ul style="list-style-type: none"> - Identify the chain of advice ➔ Draw the arrow of the chain of advice ➔ The formality of the interaction: formal (ex with a contract), informal, both ➔ Strength of interactions 	<ul style="list-style-type: none"> - What are the different users (different kinds of farmers can buy drugs from different sources)? - When selling ABs, do they give advice? -
<ul style="list-style-type: none"> - Identify the interactions between stakeholders ➔ Directions of interactions from one to another one, in both directions, network (include more than 2 stakeholders) ➔ The formality of the interaction: formal (ex with a contract), informal, both ➔ Strength of interaction 	<ul style="list-style-type: none"> - What are the interactions or influences between the different stakeholders? - Who works with whom? - Who interacts with whom? - What is the nature of the interactions? - What is the link between the public and the private sector? (public-private partnership)
Third step: Identify the legislation	
<ul style="list-style-type: none"> - Identify the existing legislation 	<ul style="list-style-type: none"> - What are the main legislations related to ABs that you are aware of related to Abs manufacture/sell/use? - Are they applied?
<ul style="list-style-type: none"> - Identify the position regarding new regulations (if time) <p><i>Ban of AB in the feed for prevention</i> <i>Mandatory prescription</i></p>	<ul style="list-style-type: none"> - Are you aware of what is going to change in terms of regulations related to ABs? - With this new regulation what is going to change in the interaction between the stakeholders? At which level?
