Integrated farm	+	++	++	More than 2000 chickens, intensive system in contract with a chicken company or integrated to the company, confined system, use AB for treatment and prevention according to the instruction of the technician hired by the company, produce mostly exotic chickens (white chickens)
Family commercial farm	+	+	++	From 100 chickens to thousands, predominance of the semi-confined system, source of AB varies according to the size, use AB for treatment and prevention according to drugstores' instruction or from their own experience, produce mostly hybrid chickens (or colored chickens)
