Symptom Cluster Profiles among Community-residing Older Adults with Heart Failure: Findings from the U.S. Health and Retirement Study

31 ABSTRACT

32 33

Background: The incidence of heart failure (HF) rises significantly as people age due to the

34 accumulated influence of risk factors in cardiovascular structure and function. Among older

adults with HF, symptoms are manifested in clustered symptoms. Few studies have addressed

36 symptoms specifically in older adults with HF and most have been conducted with small samples.

The aims of this study were to (1) describe symptom cluster profiles in older adults with HF in a

nationally representative sample of community-dwelling older adults; and (2) determine the

39 associations between demographic and clinical characteristics and membership in symptom

40 cluster profiles.

41 Methods: A secondary analysis was conducted using data from the Health and Retirement Study.

42 Fatigue, shortness of breath, pain, swelling, depressive symptoms, and dizziness were measured.

43 Latent class analysis was used to identify symptom cluster profiles. Bivariate associations and

44 multinomial logistic regression were used to determine the associations between symptom

45 cluster profiles and demographic and clinical characteristics.

Results: The sample included 690 participants. Three symptom cluster profiles were identified [high-burden, low-burden, and cardiopulmonary-depressive]. Age, gender, BMI, marital status, alcohol consumption, diabetes, lung disease, and arthritis were significantly different across the three profiles. People in the high-burden and cardiopulmonary-depressive profiles, compared to those in low-burden, had higher odds of having lung disease and arthritis, yet lower odds of higher alcohol consumption.

59 **BACKGROUND**

60 Heart failure (HF) is a complex clinical syndrome experienced by approximately 26 million adults throughout the world.¹ The prevalence of HF increases sharply with age due to age-61 associated changes in cardiovascular structure and function.² and the prevalence of HF among 62 63 adults aged 60 to 79 years ranges from 4.8% to 6.6%, and it increases to 10.6% to 13.5% for adults aged 80 years and older.³ Fatigue, shortness of breath/dyspnea, pain, depressive 64 symptoms, and insomnia symptoms are common among older adults^{4–6} and these symptoms are 65 66 often associated with advanced age and multimorbidity. These symptoms may also contribute to poor quality of life and function and difficulty with self-care.⁷ 67 68 Adults with HF demonstrate heterogeneous symptom experiences as evidenced by variations in symptom cluster profiles.^{5,8} While numerous studies addressed isolated symptoms, 69 70 better understanding of the nature of symptoms and how they co-occur is essential to guide interventions.⁸ Symptom profiles encompass physical and psychological (emotional) domains 71 that may differ depending on the demographic and clinical attributes of the participants.^{5,9,10} 72 73 Previous studies have indicated that symptoms among adults with HF (age \geq 18 years) recruited from hospital wards,¹¹ outpatient HF clinics,^{9,12–16} and healthcare centers,¹⁷ occur in 74 75 clusters or cluster profiles. However, these studies were conducted in specific regions, lacked 76 national representation, and had limited generalizability due to their small sample sizes. Limited 77 studies have been conducted with older adults from a national-wide population, which often provides insights into the comprehensive real-world symptom experience of older adults with HF. 78 Addressing symptom cluster profiles among older adults with a large sample size can help 79 80 address the unique challenges in managing and preventing HF in an aging population. This

81 includes identifying risk factors and early symptoms/signs of HF, enabling preventive strategies,

82 and ultimately improving the quality of life and adverse outcomes.

The aims of this study are to (1) describe symptom cluster profiles in older adults with HF in a nationally representative sample of community-dwelling older adults in the USA; and (2) determine the associations between demographics, clinical characteristics, and membership in

86 symptom cluster profiles.

87 METHODS

88 Design

89 This study was a cross-sectional study of data obtained from the Health and Retirement

90 Study (HRS), conducted by the Institute for Social Research at the University of Michigan. The

91 HRS is a nationally representative longitudinal study of individuals over the age of 50 years,¹⁸

92 designed to understand aging at the population level for community-residing,

93 noninstitutionalized adults. Compared to other waves, the HRS 2008 wave included more

94 participants with HF who had subsequent longitudinal data and so, was used as the baseline. This

study used de-identified, publicly available data and was deemed exempt from the Institutional

96 Review Board approval of the University of Connecticut.

97 **Participants and Sample**

98 Participants from the HRS dataset were considered eligible if they resided in the 99 community and were identified as having HF (C048) and comorbid conditions based on the 100 chronic condition codes found in the claims data. We included participants who reported at least 101 one of the following symptoms: (fatigue, pain, shortness of breath, depressive symptoms, and 102 dizziness). We excluded participants who did not report at least one symptom. Participants

provided written informed consent prior to the session and verbally agreed to participate in eachinterview (Health and Retirement Study, 2008c).

105 Variables and Measures

106 The health conditions of participants were evaluated using self-reported health measures

107 in the HRS, and previous studies have confirmed their accuracy and consistency.¹⁸

108 Age, gender, race, body mass index (BMI), marital status, educational level, veteran

109 status, smoking status, and alcohol consumption were elicited from the database. The

110 participants' self-reported age in years was incorporated into the analysis as a continuous

111 variable, while gender was represented by numerical coding: male (1) and female (0). Self-

112 reported weight in pounds and height in inches were converted into kilograms and meters,

respectively, to compute BMI in kg/m². BMI was coded and categorized as <18.5 (underweight),

114 18.5-24.9 (normal weight), 25-29.9 (overweight), 30.0-39.9 (obesity), ≥40.0 (morbid obesity).¹⁹

115 Alcohol consumption was defined as "Do you ever drink any alcoholic beverages such as beer,

116 wine, or liquor?". Participants who answered "yes" were then asked about the number of days

117 per week for alcohol consumption, the number of drinks per day, and how many days they had

118 four or more drinks on occasion (binge drinking). Comorbidities, including hypertension,

119 diabetes, cancer, lung disease, and arthritis, were obtained from the Health Condition

120 questionnaire.

121 Shortness of breath, persistent swelling in the feet or ankles, fatigue/exhaustion, and 122 dizziness were evaluated during interviews conducted as part of the core surveys.¹⁸ The response 123 options for each symptom were "yes", "no", and "don't know." People who answered "yes" were 124 defined by the investigators as experiencing symptoms. Participants were asked about pain, "Are 125 you often troubled with pain?" and participants who answered yes were then asked about pain

126	intensity "How bad is the pain most of the time: mild, moderate, or severe?" Participants who
127	answered yes to the first question and rated the pain as moderate or severe were classified as
128	having significant pain. ²⁰ These symptoms were selected because they are highly relevant and
129	specific to people with HF. ^{9,11,21}
130	HRS investigators assessed depressive symptoms using a short-form eight-item Center
131	for Epidemiological Studies Depression Scale (CES-D). This scale asked participants to indicate
132	the frequency with which they encountered depression-related symptoms in the previous week,
133	with a range of 0-8, and a cutoff point of 4 or more was used to classify depressive symptoms. ²²
134	The cutoff point for short-form CES-D was determined by HRS, aligning with the established
135	cutoff on the full CES-D. ²² The short-form CES-D and the original CES-D exhibit comparable
136	symptom dimensions, and the shorter version of CES-D demonstrates strong validity and internal
137	reliability with a Cronbach's alpha of 0.83.

149	within the HF population. LCA, as a data-driven approach, does not require any prior hypotheses,
150	and a minimum of 100 participants is needed for a well-identified model. ²⁴
151	We performed LCA with the symptoms of fatigue, pain, shortness of breath, swelling,
152	depressive symptoms, and dizziness. The final model was determined based on the relative
153	model fit, including likelihood ratio G ² , Akaike information criterion (AIC), Bayesian
154	information criteria (BIC), calculated Akaike information criterion (CAIC), and the adjusted BIC.
155	For the fit statistics, the favorable model was based on the lowest AIC and BIC, however, the
156	selection of the final model should depend on fit statistics, clinical interpretability, and the size of
157	each profile. We utilized the PROC LCA (Version 1.3.0) for SAS, developed by the Penn State
158	Methodology Center. ²⁵ PROC LCA employs a full-information maximum likelihood method to
159	manage missing data and determines symptom cluster profile memberships for participants who
160	lack symptom data.
161	Chi-square tests and analysis of variance (ANOVA) were conducted to examine the
162	differences in demographic and clinical factors across identified symptom cluster profiles. We
163	examined the residuals for normal distribution in the ANOVA and adjusted for any skewness in
164	the distribution of residuals by applying logarithmic transformation to the variables. Additionally,
165	to understand how demographic and clinical features varied across different symptom cluster
166	profiles, we employed multinomial logistic regression to develop a model. We developed a
167	parsimonious model using stepwise selection of variables that had significant bivariate
168	association with the symptom cluster profiles. Statistical significance was designated as $p < .05$.

195	cluster profiles. Crossing was observed among the three lines, suggesting that the exhibited
196	symptoms in older adults with HF are likely associated with more than one cluster profile.
197	Bivariate Analysis and Multinomial Logistic Regression of Symptom Cluster Profiles
198	We also examined the differences in participants' demographic and clinical characteristics
199	across the three symptom cluster profiles (Table 5). Age, gender, BMI, marital status, veteran
200	status, alcohol consumption, diabetes, lung disease, and arthritis had statistically significant
201	differences across three symptom cluster profiles ($p < .05$). Participants in profile 3
202	(cardiopulmonary-depressive) were the oldest (76.4 years \pm 10.0) and were more likely to be
203	married or partnered (48.0%), to be veterans (27.5%), and to be male (46.3%), compared to those
204	in profile 1 (high-burden) and 2 (low-burden). Most participants in the high-burden profile were
205	overweight (25.7%), obese (36.4%), or morbidly obese (14.6%). Over one-quarter of participants
206	in the cardiopulmonary-depressive profile were overweight (25.9%) or obese (28.3%).
207	Almost one-quarter of participants in the cardiopulmonary-depressive profile had a
208	history of alcohol consumption (24.3%). The average days/week of alcohol consumption per
209	week (2.3 days \pm 2.7) was higher compared to profiles 1 and 2. Participants in the
210	cardiopulmonary-depressive profile were more likely to report hypertension (82.0%), diabetes
211	(55.8%), and arthritis (77.9%). However, having lung disease was the most common in
212	participants in the high-burden symptom cluster profile (53.4%).
213	Table 6 presents the results of the multinomial logistic regression. People in profile 1
214	(high-burden) and profile 3 (cardiopulmonary-depressive), compared to those in profile 2 (low-
215	burden), had higher odds of having lung disease and arthritis ($p < .001$). People in the high-

burden and cardiopulmonary-depressive symptom cluster profiles were less likely to consume more alcohol compared to those in the low-burden profile (p < .001).

218 **DISCUSSION**

219 To our knowledge, this is the first study that evaluated associations between demographic 220 and clinical factors and symptom cluster profiles in a nationally representative sample of 221 community-residing older adults with HF. It extends previous symptom cluster studies that 222 included more geographically localized samples recruited from health care centers and had 223 smaller samples. Two of the identified symptom cluster profiles (high-burden and low-burden), 224 are characterized by either consistently high or low physical and psychological symptoms and are consistent with the symptom cluster profiles identified in previous studies.^{5,9,26} However, the 225 226 membership in the high-burden and low-burden profiles varies depending on which symptoms 227 were selected. In our study, most participants (53.2%) belonged to the cardiopulmonary-228 depressive symptom cluster profile, which is similar to those reported in the literature that found integrated physical and psychological symptoms in patients with HF.^{11,17,27} 229 230 Compared with the low-burden symptom cluster profile, it is not surprising that 231 comorbidity was associated with membership in the high-burden and cardiopulmonary-232 depressive symptom cluster profiles. Notably, we found that the risk of lung disease for high-233 burden symptom cluster profiles is about 5 times higher than that of low-burden symptom cluster 234 profiles. Therefore, assessing CRP and fibrinogen would add additional insight into the risk of 235 lung disease among those with severe HF. Elevated inflammatory markers, such as C-reactive 236 protein (CRP) and fibrinogen, perhaps are the most prominently cited risk factors to explain the associations between severe HF and pulmonary dysfunction.²⁸ In addition to lung disease and 237 238 arthritis, previous studies have also found an association between diabetes and emotional

symptom cluster (depressed, worry, difficult concentration) in patients with HF.²⁹ Hypertension, 239 240 atrial fibrillation, and diabetes were significant predictors of being in the high distress profile (severe physical and psychological symptoms) compared to the low distress profile.⁹ HF. 241 242 especially HF preserved ejection fraction (HFpEF), is associated with a high prevalence of 243 comorbidities.³⁰ Conditions, such as hypertension (65%), atrial fibrillation (45%), diabetes (40%), 244 and chronic obstructive pulmonary disease (40%), are commonly observed in older adults with 245 HF. These comorbidities, in turn, exacerbate the progression and clinical presentation of HF, 246 forming a vicious cycle. The reciprocal relationships can be particularly challenging among older adults and are considered a true geriatric syndrome.³⁰ Age-related changes and cumulative 247 248 comorbidities can be a challenge for older adults to distinguish whether symptoms are arising from HF itself or from its comorbidities.³¹ 249 250 The prevalence of depressive symptoms was quite pronounced. Depressive symptoms 251 were also manifest in two distinct symptom cluster profiles. This may be because veterans

represented over a quarter of the total participants, and over half of these veterans were

categorized within the cardiovascular-depressive symptom cluster profile. Deployed military

254 personnel were twice as likely to suffer depression than non-deployed military personnel.³²

However, previous HRS studies have shown that veterans and non-veterans had a comparable

256 prevalence of depression and anxiety symptoms, and these emotional symptoms vary among

veteran cohorts.³³ Veterans have reported a reluctance to seek care for fear of stigma and
 negative consequences, which could result in fear of admissions of depressive symptoms among
 this population.³⁴ Given the high prevalence and intricate nature of depressive symptoms among

260 community-residing older adults with HF, particularly veterans, it is crucial for clinicians and

health care providers to prioritize the assessment and management of depression and itssymptoms.

263 Older adults with HF who consume alcohol were less likely to belong to high-burden and 264 cardiopulmonary-depressive symptom cluster profiles. One reason might be that older people 265 with high-burden or cardiopulmonary-related symptoms are more aware of the severity of their 266 condition and the impact of alcohol on their daily lives and were following medical advice to 267 avoid alcohol consumption This may also be attributed to several considerations, such as 268 physiological effects, lifestyle modifications, symptom burden awareness, and patient education.³⁵ Consequently, they may be more motivated to adopt lifestyle modifications and 269 270 prioritize medication/lifestyle adherence, such as limiting alcohol intake, to alleviate symptoms.^{35,36} Additionally, current evidence shows that low amounts of alcohol consumption 271 are safe and beneficial for the cardiovascular system.³⁶ However, alcohol consumption can lead 272 273 to either an elevated or reduced cardiovascular risk, depending on the amount consumed, 274 frequency of drinking, and the pattern of consumption, whether it involves heavy/binge drinking or irregular intake.³⁷ 275

276 It is important to note that these findings are nuanced and not uniform across all symptom 277 profiles. Though our limited sample size prevented us from finding statistically significant 278 results regarding drinking frequency and consumption patterns across different symptom cluster 279 profiles, we did observe that, among older adults with HF who consumed alcohol, those in the 280 cardiopulmonary-depressive profile consumed alcohol more frequently per week. Meanwhile, 281 individuals in the high-burden profile showed a higher tendency for binge drinking compared to 282 other groups. Even though the percentage of individuals with alcohol consumption in the high-283 burden profile is relatively lower, their average number of drinks per day and frequency of binge

drink is much higher, indicating they tend to engage in heavier alcohol use compared to other
profiles. The possible reason that alcohol might exacerbate high-burden or cardiopulmonarydepressive symptoms may stem from a combination of direct and indirect physiological effects.
These effects increase the risk of dilated cardiomyopathy, elevated blood pressures, interference
with medications, promoting fluid retention, triggering cardiac arrhythmias and mitochondrial
dysfunction in circulation.³⁸

290 Both physical and psychological/emotional aspects of HF can be addressed through a combination of medication, psychotherapy, and lifestyle changes.³⁹ This may help healthcare 291 292 providers identify the specific symptom cluster profiles that are most affected by depressive 293 symptoms and tailor the treatment accordingly. Several interventions that combine symptom 294 management support and self-care management can assist people with HF in recognizing, responding to, and managing multiple symptoms.⁴⁰ Home-based inspiratory muscle training 295 296 (IMT) has been found to be a safe, flexible, and adjuvant treatment of pharmacological interventions in reducing fatigue and dyspnea in patients with HF.⁴¹ Motivational interviewing 297 298 (face-to-face sessions plus telephone calls) is another effective strategy to reduce discomfort, dyspnea, and early and subtle edema in patients with HF.⁴² Few interventions have intentionally 299 300 targeted symptom clusters/profiles in people with HF. Future studies should consider developing 301 and examining the effectiveness of interventions aimed at reducing the incidence of specific 302 symptom clusters/profiles for older adults with HF. Cognitive training combined with exercise, 303 self-care, and electrical muscle stimulation may be effective as a non-pharmacological 304 intervention for older adults with HF.⁴³

The strength of this study is its large sample size which helps gain insights of symptomcluster profiles among community-residing older adults. Instead of directly assigning people to

307 specific profiles, this study used probabilistic class assignments, allowing for a better evaluation 308 of differences between profiles and the impact of predictive factors on profile assignments. 309 Nevertheless, this study had several potential limitations. Firstly, its cross-sectional nature 310 precludes drawing conclusions on causality and weakens the dynamic analysis of how 311 demographic and clinical factors influence symptom cluster profiles in older adults. Secondly, 312 some symptoms, such as shortness of breath and fatigue, were identified using one single 313 question from self-reported surveys, which may affect the accuracy and validity of the results. 314 Due to limited data in the HRS, sleep or insomnia symptoms were not included. However, most 315 people with HF report poor sleep, and 50% report insomnia symptoms, including difficulty initiating sleep, maintaining sleep, or awakening too early in the morning.⁴⁴ Lastly, the limited 316 317 diversity in race and ethnicity, combined with limited clinical data (e.g., New York Heart Class), 318 might impact the accurate characterization of symptoms. 319 HF clinicians should carefully evaluate older adults with HF who reside in communities 320 for the presence of multiple co-occurring symptoms. It is especially important to assess and 321 manage depressive symptoms among veterans as these symptoms may present within high-322 burden and cardiovascular-depressive symptom cluster profiles. Clinicians and health care 323 providers should also educate older adults with HF, particularly those experiencing low-burden 324 symptoms, about the risks associated with alcohol consumption and the potential negative 325 consequences. Symptoms may change and deterioration can occur in later life, and various risk 326 factors may be associated with dynamic symptom trajectory among this vulnerable population. 327 Future research is needed to determine the longitudinal trajectory of symptom cluster profiles 328 and examine the extent to which risk factors can predict changes in symptom cluster membership.

330 CONCLUSIONS

331	In conclusion, among community-residing older adults with HF, we identified three
332	distinct symptom cluster profiles: high-burden, low-burden, and integrative physical and
333	emotional symptom cluster profiles. Lung disease and arthritis are associated with the high-
334	burden symptom cluster profiles, while alcohol consumption is associated with the low-burden
335	symptom cluster profiles. There is a need to examine these symptom cluster profiles
336	longitudinally and pinpoint older adults at risk for adverse outcomes. Targeted symptom cluster
337	profile intervention should also be explored.
