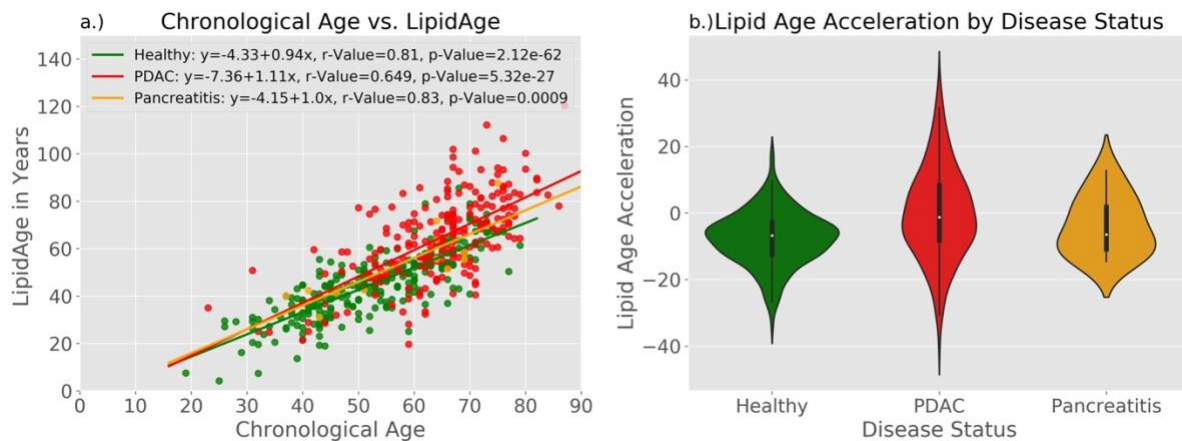

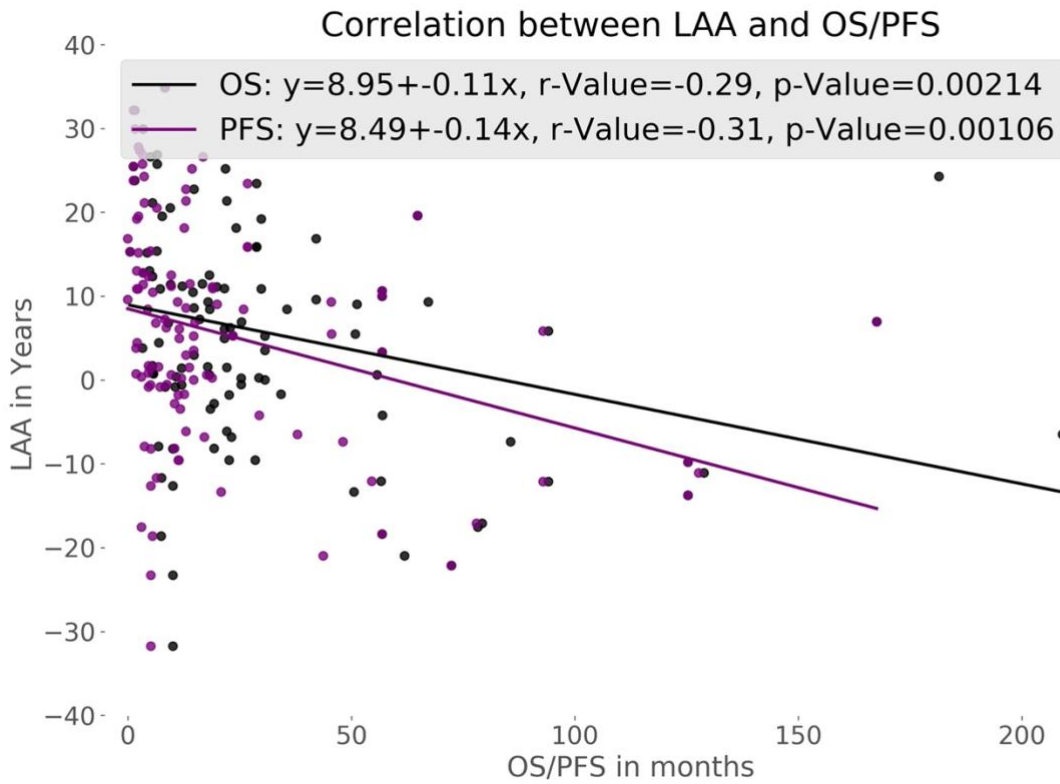

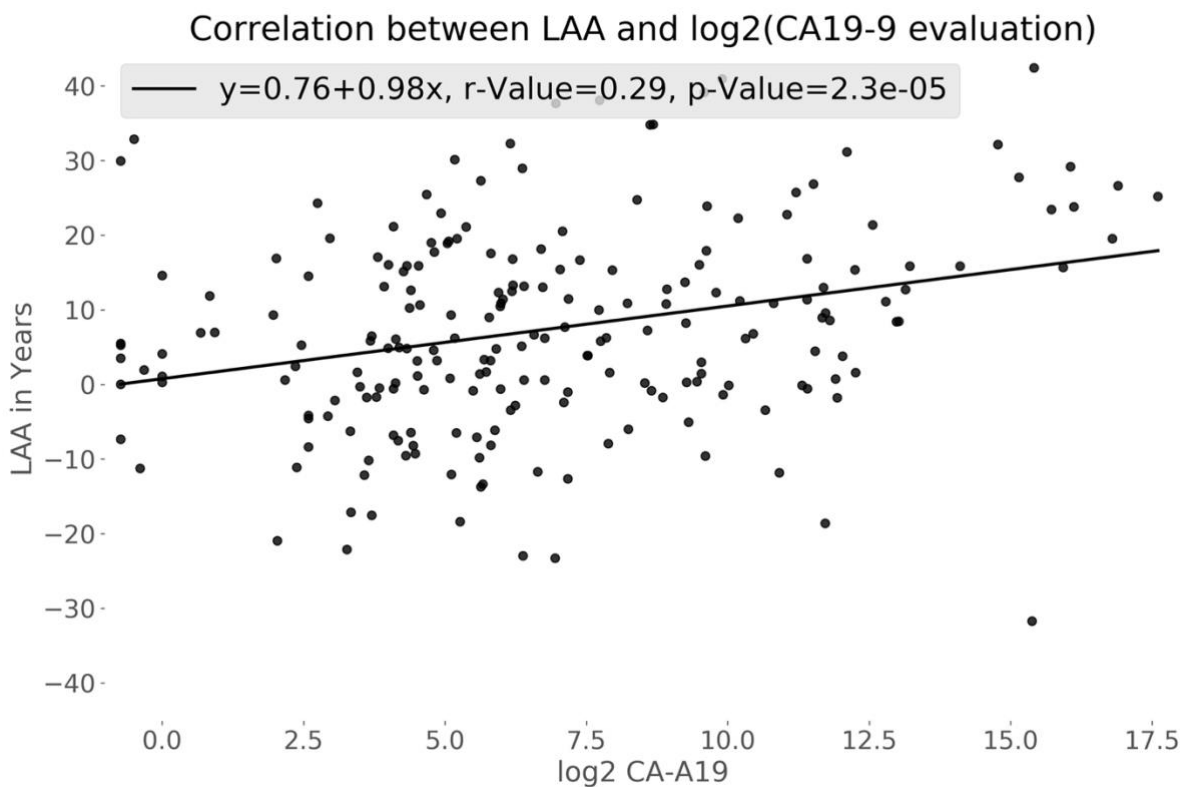

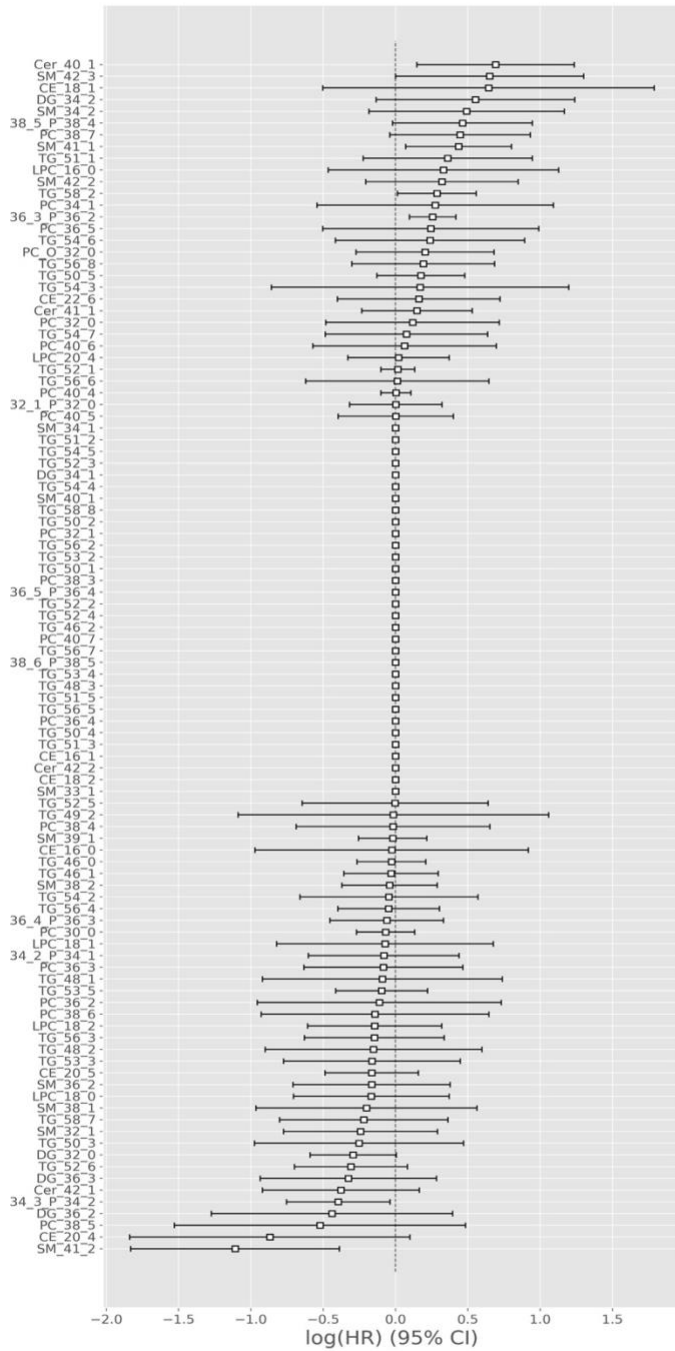
Sup. Figure 1: Uncentered results



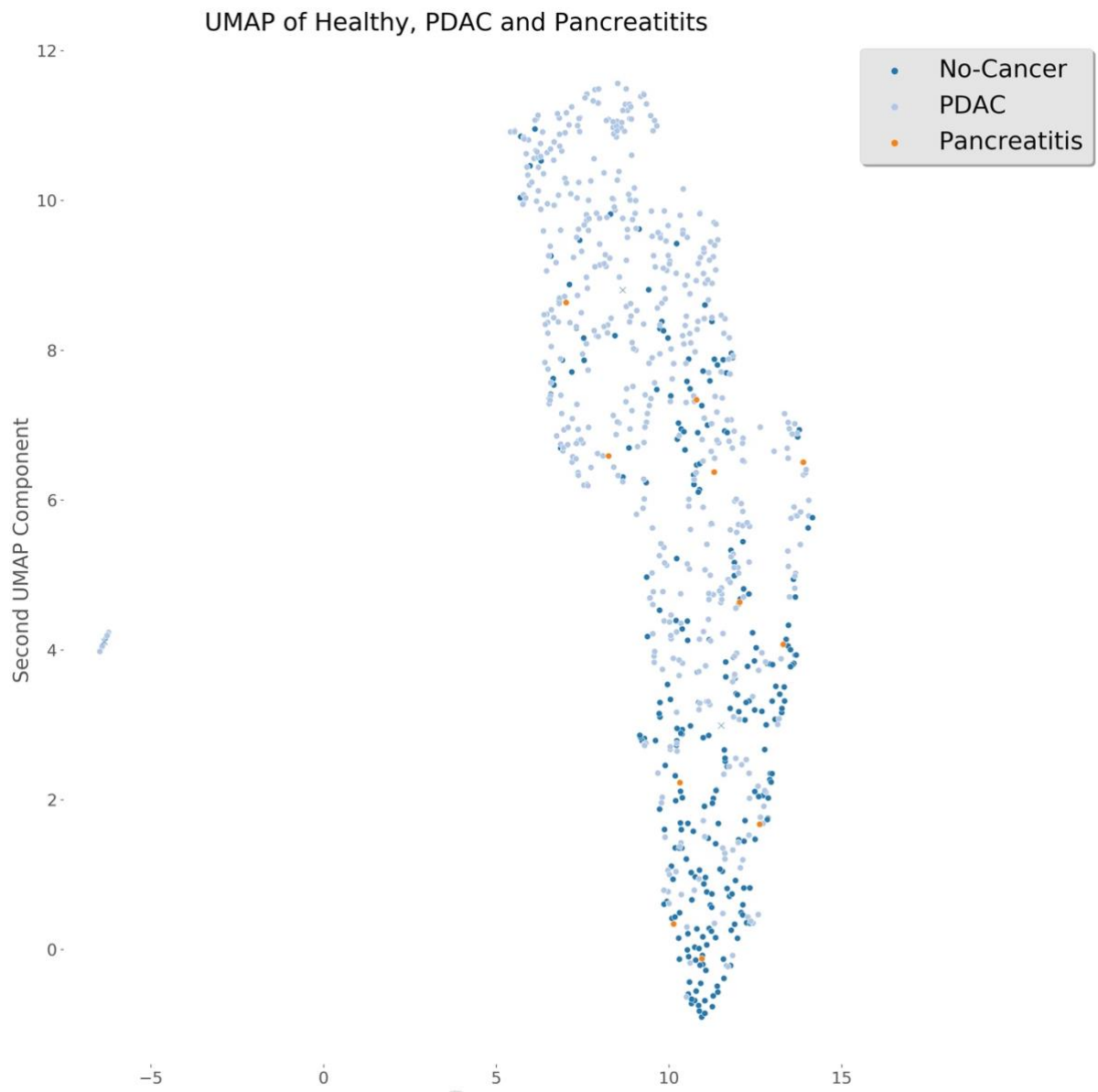
Sup. Figure 2: Correlation between LAA and Overall and Progression free survival
