Infection risk assessment

In this research, the risk of airborne transmission was assessed using the COVID Airborne Risk Assessment (CARA) tool [1]. The CARA tool was originally developed to evaluate the probability of being infected in a given indoor configuration. In brief, the CARA simulates the transmission process starting from the emission of virus-laden particles by an infected host, the concentration of the emitted virus in the ambient air, and then evaluates the risk of infection based on the number of viable virions inhaled by other hosts sharing the same space.

The emission rate from a source is influenced by the viral load in respiratory tract (v), the respiratory particle volume per unit of breathing volume (E_p) and the breathing rate (B), and can be expressed as

$$E_{v} = v E_{p} B.$$

The volume of respiratory particles emitted by an infected host per exhaled volume depends on the expiratory activity, such as breathing, speaking, or shouting, as different activities emit varying respiratory particle size profiles (**Table 1**). Additionally, physical activities influence the breathing rate of the host.

After virus-laden particles are released into the environment, these particles settle, and the pathogens can survive outside the host body for only a limited period. Additionally, viruses can be removed through air management systems. Therefore, the concentration of viruses in well-mixed room air depends not only on their emission but also on these removal mechanisms. The rate of change of the concentration of viruses (C) is derived from the following differential equation:

$$\frac{\partial C}{\partial t} = \frac{E_{v}N_{I}}{v} - \lambda C.$$

The first term in the differential equation represents the viral production term, while the second term represents the removal term of the virus. Here, E_v is the aforementioned emission rate, N_I is the number of infected hosts, and V is the room volume.

The viral removal rate (λ) accounts for removal mechanisms including gravitational settlement (λ_G), biological decay (λ_v), ventilation (λ_{ACH}), and particulate filtration (λ_{HEPA}). Thus, the total removal rate is given by:

$$\lambda = \lambda_G + \lambda_v + \lambda_{ACH} + \lambda_{HEPA}.$$

The calculation of each term of the viral removal rate is summarized in Table 2.

Once another person enters the same space and breathes in the virus-laden particles, the probability of a COVID-19 infection (*P*) is assessed based on the intake dose of the infectious agent reaching the target infection site (D_{ν}):

$$P = 1 - e^{-\frac{D_{v}(1-M)}{ID_{50}/In2}}.$$

Even after the pathogen successfully reaches the infection site, it must survive the immune defenses to cause an infection. M is the fraction of pathogens eliminated by the immune system, so I-M represents the surviving fraction. The infectious dose ID_{50} indicates the dose at which 50% of the population is expected to become infected. It is assumed that an infection can be initiated by a single pathogen reaching the infection site, but if the intake dose equals ID_{50} , the probability of infection is 50%. The calculation of infection probability and associated parameters are summarized in **Table 3**.


