



Supplementary Figure 1. Quantile-quantile plot of the PCa GWAS. The quantile-quantile plot illustrates the discrepancy between the actual P values of GWAS SNPs and the expected P values from a theoretical χ^2 distribution.



Supplementary Figure 2. LocusZoom plots of GWAS top SNPs. Genetic loci harboring top SNPs at the (A) JAZF1, (B) PDILM5, (C) WDPCP, (D) EEFSEC, and (E) TNS3 loci are displayed.
