

An unfortunate natural experiment

in learning how to provide services to those in need:

The case of Ukrainian war refugees with disabilities in

Warsaw and Bucharest

When helping others, experience becomes important, especially in circumstances that involve interacting with a different culture—such as the ones implied in providing services to refugees. When disability is added to

25 *an asset. This paper explores the impact of the Russian invasion of Ukraine on the capacity of the Polish and*
26 *Romanian organizations providing services to Ukrainian refugees in Warsaw and Bucharest, with a focus on*
27 *disabled refugees. Based on 41 interviews with service providers/grass-roots organizations, it turns out that*
28 *this unfortunate event served as a natural laboratory for practicing, acquiring, and increasing skills in multiple*
29 *domains, leading to increased personal and institutional expertise. We inspect the differences between*
30 *Warsaw and Bucharest, the first city having more experience in dealing with incoming flows of immigrants,*
31 *the second being a newcomer in this respect. We also consider the distinction between public providers (public*
32 *administration) and non-governmental organization entities, observing the upscaling of the latter.*
33 *Implications for policy are considered within the framework of curtailing civic society under the illiberal wave.*

42 **Introduction**

43 The lessons learned by civil society and public service providers from dramatic events can significantly
44 improve society in general and civil society in particular, by enhancing procedures, fostering cross-sectoral
45 cooperation, and preemptively addressing crises (Alexander, 2022; Hashimoto, 2011; Sztompka, 2005). In
46 this paper, we ask what lessons can be drawn from the *ad hoc*—or “spontaneous”—enthusiastic phases of
47 helping Ukrainian refugees in Poland and Romania. We focus closely on the encounters of service providers
48 with war refugees with disabilities and treat this negative life event as a natural experiment prompting
49 societies and organizations for quick and efficient reactions.

50

51 In historical terms, the Russian invasion of Ukraine was probably not a surprise, since Russian armies have
52 repeatedly occupied the area, both during the times of the tsars and in the soviet era. Earlier aggression in
53 the Black Sea area (against Moldova and Georgia, for instance), as well as against Ukraine (such as the 2014
54 invasion of Crimea) preceded the beginning of the war in March 2022. However, the scale of the invasion
55 was unprecedented in post-WW2 Europe, and the emotional response across the continent was
56 considerable, affecting both citizens and decision makers, especially—but not exclusively—in the countries
57 bordering Ukraine (Beauregard, 2022; Chudzicka-Czupała et al., 2023; Smith, 2021; Vus & Esterlis, 2022).

58

59 At the same time, despite people with disabilities in Western culture having high deservingness (Assouline &
60 Gilad, 2022; Fang & Huber, 2020), particularly when disabilities are based on medical evidence (Geiger, 2021),
61 post-communist European societies have experienced surges in discontent from the disabled, about how
62 they are treated by societies (Zdrodowska, 2023). The neglect of social policy costs in favor of economic
63 growth and the existing barriers in accessing social services by the beneficiaries have prompted such
64 reactions (Kiss, Primecz, & Toarniczky, 2022), in a context where special needs are still strongly stigmatized
65 (Mikelsteins & Ryan, 2018) and little attention is paid to disability beyond the medical model (Šumskienė,
66 Gevorgianienė, & Genienė, 2021). In times of recession, when state retraction was expected, the
67 professionalization of non-governmental service providers was anticipated to prevail, thereby redressing the
68 growing inequalities in accessing care (Dill, 2014), yet reports show that such organizations are still in their
69 “infancy” phase (Popa, Vlase, & Morandau, 2016).

70

71 Sudden incoming flows of refugees typically put existing healthcare and welfare systems under stress, as
72 demonstrated by other examples across Europe (Gottlieb & Schülle, 2021; Human Rights Watch, 2017;
73 Schottland-Cox & Hartman, 2019), or are averted in the early days of wars by healthcare specialists (Van
74 Hemelrijck et al., 2022). Despite the international regulations concerning the helping of disabled refugees
75 (Duell-Piening, 2018), the implementation is not always smooth, with the pitfalls becoming acute when
76 hazards occur.

77

78 This creates a fruitful field for understanding how the sector of service providers has evolved in Poland and
79 Romania—two EU member states that border Ukraine and are large enough to receive important flows of
80 Ukrainians fleeing the war, while also sharing a common history of being communist and displaying anti-
81 Russian sentiments.

82

83 Our paper is based on 41 interviews that were carried out in Warsaw and Bucharest in 2023, with service
84 providers and regulators in the field of disabled refugees, including state agencies and non-governmental
85 organizations (NGOs). We explore this corpus with the aim of understanding how such providers change over
86 time, as well as seeing whether this unfortunate event has allowed them to increase their capabilities in
87 terms of providing help to those in need, irrespective of whether they are refugees, immigrants, or members
88 of the native population. We focus on upscaling and learning ways of doing; we explore whether and how
89 they develop cooperation within their sector and beyond their sector; and we look for evidence that the
90 acquired experience has been converted into newly acquired or improved competences. While other similar
91 studies have stressed the general impact of the war on NGOs in the region (Bryan, Lea, & Hyánek, 2023;
92 Petrescu, 2023), we go deeper, by considering cross-sectorial effects, intersectionality, and long-lasting
93 changes, as well as comparing the public service providers in two capital cities. As negative societal events
94 provide windows of opportunity (Bogdan, 2023; Hashimoto, 2011; Morgado, 2020), we expect increases not
95 only in terms of internal practices and immediate know-how (Petrescu, 2023; Valentinov, Bolečeková, &
96 Vaceková, 2017), but also in terms of cross-sectorial cooperation and the capacity to extend activity into
97 other areas.

98

99 In the following, we depict a four-fold context, in which we concentrate on the local setups of organizations
100 focused on migrants, while also considering service providers for disabled people, exploring questions of
101 deservingness, and investigating the obstacles that NGOs face under the current illiberal wave. All contribute
102 to the background of our story. A detailed presentation of our methodology explains our empirical sources,
103 which are then extensively commented upon in the findings section. The concluding part of the paper
104 discusses the dimensions of organizational change and upscaling that migration and disability NGOs and

105 public service providers have experienced and explores how they signal organizational, policy, and research
106 implications.

107

108

109 Literature review

110

111 Migration/refugee-centered organizations. Aims and approaches to disability

112 Both Romania and Poland have short histories of receiving migrants, as, historically, these countries have
113 both been known for exporting migrants to other nations. In recent years, however, the number of
114 (economic) immigrants in both countries has been growing (Górny, 2019; Leşcu, 2018).

115

116 In both countries, NGOs are the main providers of assistance and services to voluntary and non-voluntary
117 migrants (Dragan, 2017; Roman, Manafi, Muresan, & Prada, 2023). These NGOs focus on activities that help
118 refugees and migrants adapt to life in a new country, providing support in cultural, economic, and social
119 areas, either complementing the actions of public institutions or replacing them when the state fails to act
120 (Pawlak & Matusz-Protasiewicz, 2015). Although they are the main actors supporting immigrants in the
121 receiving country, their activities are not limited to this area, since they are also focused on the broader
122 society in the receiving country (Dragan, 2017; Nowak & Nowosielski, 2018).

123

124 The scope of NGO activities ranges from short-term help—such as emergency direct aid, legal assistance, and
125 organizing various courses—to long-term involvement in advocacy and advising on policy development
126 (Flanigan, 2022; Podgórska et al., 2023).

127

128 NGOs dealing with migrants and refugees only support people with disabilities relatively rarely, since
129 migrants are typically able to work—and even when they are disabled, they are often invisible (Tofani,
130 Berardi, Iorio, Galeoto, & Marceca, 2022). The intersection of migration and disability is most often

131 experienced by people fleeing from at-risk areas, so NGOs most often encounter people with disabilities
132 during refugee influxes. Even then, the level of support provided to refugees with disabilities depends on
133 various factors, one key issue being the number of people in reception centers. As demonstrated by the
134 example of the Greek islands, which are known for their struggle with significant influxes of people seeking
135 international protection, a large number of refugees can render people with disabilities invisible (AMID,
136 2018). In Austria, where refugee numbers are significantly lower, there are established procedures and
137 solutions for assisting refugees with disabilities (Kreinbacher, 2018). An additional challenge in providing help
138 is the unclear legal status of these individuals, which can prevent access to many services (Kreinbacher,
139 2018). Other factors obstructing effective and efficient support include a lack of data and the absence of a
140 standardized method for assessing vulnerability (Tofani et al., 2023).

141

142

143 **Disability-centered organizations. Aims and approaches to migration topics**

144 Disability researchers have stressed the crucial role played by disability organizations in the post-socialist
145 region, especially given the scarcity of state-provided services intended for disabled persons (Mladenov,
146 2017; Rasell & Iarskaia-Smirnova, 2011). Such disability organizations have therefore been patching
147 significant gaps in the provision of essential medical, welfare, and societal support systems that have been
148 neglected in the evolving capitalist economies of countries like Romania and Poland (Bungău, Țiț, Popa,
149 Sabău, & Cioca, 2019; Kocejko, 2018). This need resulted from the state's failure to offer such critical services,
150 as well as the large costs that were subsequently imposed upon disabled individuals, rendering such services
151 financially inaccessible in heavily privatized sectors.

152

153 This predicament disproportionately affected disabled people in post-socialist regions, who, for a variety of
154 reasons, typically belong to the most economically disadvantaged segments of society. As a consequence,
155 disability organizations have mainly focused their efforts on providing assistance along impairment-specific
156 lines, rather than adopting a more inclusive cross-impairment approach (Mladenov, 2017; Popa et al., 2016;
157 Rasell & Iarskaia-Smirnova, 2011). This tendency partly resulted from the structures of the available state

158 funding grant schemes, which emphasized objectives such as facilitating employment for disabled individuals
159 and integrating them into societal frameworks, primarily through work-related and integration programs. As
160 a result, scholars in Disability Studies have noted the pragmatic approaches adopted by these organizations
161 to secure resources for their vital activities, compensating for the inadequacies of the state. However, the
162 emergence of the Convention on the Rights of Persons with Disabilities (CRPD) led to shifts in some disability
163 organizations, both large and small, toward aligning their objectives with the values outlined in the CRPD.
164 These organizations began advocating for the replacement of medical and charity models of disability with a
165 more comprehensive human-rights-based model—a shift that aimed to address disability discrimination in a
166 systematic way, acknowledging its intersectional and holistic nature (Baciu & Lazar, 2017; Kocejko, 2018).

167

168 Before the arrival of Ukrainian war refugees with disabilities (UWRwD) in Poland, Polish disabled-focused
169 NGOs did not support migrants and refugees, which is reflected in the not very rich literature on health-
170 related issues and migration and refuge. The researchers focused mainly on access to public health services
171 and social security issues (Andrejuk 2017, Strzemieczna 2021).

172

173 The intersectionality between disability and migration appears only marginally in the literature on
174 immigration relating to the two countries (Chłoń-Domińczak, 2020; Goga, 2019; Oltean & Găvruş, 2018;
175 Sterniński, 2019) and, to the best of our belief, has not been thoroughly analyzed. The reports in the two
176 countries depicting the provision of social services almost completely ignored questions of immigration prior
177 to the current Ukrainian refugee crisis (e.g., Ministerul Muncii și Solidarității Sociale, 2023; Radulescu &
178 Paulischin, 2017; Vereha et al., 2022), while the reports of recent years show a completely different side of
179 the service providers involved in matters of dealing with disability and refuge at the same time (e.g.,
180 Centrone, Gromada, & Posylnyi, 2023; Petrescu, 2023).

181

182

183 Experiences shaping the approaches toward aiding refugees

184 Civil society organizations provide services to those excluded by public policies and restrictions in the field of
185 immigration (Ambrosini & Van der Leun, 2015), and their role in the integration of refugees and asylum
186 seekers has been long studied (Bešić, Diedrich, & Aigner, 2021; Collini, 2022). In their activities, they must
187 accord with the rules governing forced migration and the integration of displaced populations, which, at the
188 same time, often result in existing policies or discriminatory practices being reinforced (Ambrosini & Van der
189 Leun, 2015; Bird & Schmid, 2023).

190

191 In terms of their main activity, there are NGOs that specialize in service provision to refugees and asylum
192 seekers and NGOs that mainly engage in advocacy. Similarly, depending on their members, there are
193 majority-led and migrant-led organizations (De Jong & Ataç, 2017). Ultimately, NGOs are dominated by the
194 need to balance state policies of exclusion with the need to offer a proper response to refugees, paying
195 attention to basic human rights (Robinson, 2013). This dichotomy of care versus control is even more
196 stringent when the (limited) funds available to NGOs are distributed/managed by public authorities,
197 decreasing the propensity of NGOs to advocate or uphold stances against their (main) funders (Alejandro,
198 2006; Bendell, 2006; De Jong & Ataç, 2017; Lau, 2021).

199

200 The duality between perceiving refugees as victims/recipients of help, on the one hand, and as individuals
201 with their own agency, on the other, seems to shape the attitudes of NGOs as well as their ways of engaging
202 with their clients/beneficiaries, which are closely linked to the characteristics of the organizations. For
203 example, (migrant-led) refugee community organizations contribute to the empowerment of refugees, while
204 NGOs, as a result of their more formal ways of organizing and delivering services, instead tend to see refugees
205 as recipients of help (Schnelzer, Franz, Mocca, & Kazepov, 2022). When refugees are seen as victims, this
206 actually contributes to making them passive, by stripping them of their agency (Robinson, 2013).

207

208 Existing scholarship has drawn attention to some important elements, such as the attitudes and activities of
209 local authorities (Mensink, Čemová, Ricciuti, & Bauer, 2018); the spaces of interaction between service

210 providers and their clients/beneficiaries and the involvement of refugees and asylum seekers as an
211 empowerment mechanism (De Jong & Ataç, 2017; Elmammeri, 2023); the communication, cooperation, and
212 coordination between service provider entities (Schnelzer et al., 2022); the hurdles of bureaucracy and the
213 need for adequate training for frontline social workers (Robinson, 2013); and the difficulties generated by
214 working in hostile environments, where general attitudes toward immigration and forced migration are
215 negative, especially when governments are not in favor of immigration and establish strict policies as a
216 consequence (Vosyliūtė & Conte, 2019).

217

218

219 **The framework for curtailing civic society under the illiberal wave**

220 In the 1990s and 2000s, Central and Eastern Europe were marked by a large deficit in civic participation, due
221 to their totalitarian pasts (Fidrmuc & Gërkhani, 2008). Institutional steps toward encouraging the flourishing
222 of voluntary associations were not always clear (Meyer, Moder, Neumayr, & Vandor, 2019). And while
223 increases in participation have been reported in the more recent literature (Ekiert, Kubik, & Wenzel, 2017;
224 Murray Svidroňová, 2020; Voicu, 2020), the steps forward have nonetheless been rather modest (Ekiert &
225 Kubik, 2017; Foa & Ekiert, 2017), overlapping with at least a decade of rising populism, illiberal rule (Merkel
226 & Lührmann, 2021; Szelenyi & Csillag, 2015), and aggression toward NGOs (Bryan et al., 2023; Hann, 2020;
227 Pap, 2017; Piotrowski, 2020)

228

229 Paradoxically or not, at the same time, post-communist societies, including Poland and Romania, have started
230 to recognize the important role of civic organizations in providing welfare services complementing those
231 offered by the state, when needed, due to their greater flexibility and adaptability in terms of providing
232 tailored programs (Dill, 2014; Mladenov, 2017; Popa et al., 2016; Rasell & Iarskaia-Smirnova, 2011).

233

234 As a result, there is now a complex setup, with two opposite trends: first, a tendency to expect the booming
235 of the sector, due to its social role, especially given the stress accompanying the war and the emotional

236 reactions towards Russian aggression; and second, a contrary backlash against the sector, due to the
237 influence of illiberal ideology. Let us also note that the latter is coupled with a global perception of a decrease
238 in deservingness relating to migrants, which preceded the Russian invasion of Ukraine (Blachnicka-Ciacek,
239 Trąbka, Budginaite-Mackine, Parutis, & Pustulka, 2021; Kisoová, 2017).

240

241

242 Major negative societal events as structure of opportunity

243 Natural and human-driven disasters have been shown to sometimes provide windows of opportunity for
244 better developing communities and societies (Arcaya, Raker, & Waters, 2020; Bănică, Kourtit, & Nijkamp,
245 2020; Hashimoto, 2011; Morgado, 2020). To cope with the traumatic consequences of disasters, including
246 wars, societies need to react quickly in adapting existing tools to the new realities. Institutional adjustments
247 and organizational development are likely outcomes. Following the social acceleration assumption, that
248 societies always change in an accelerated manner (Bogdan, 2023; Rosa, 2009), we claim that war generates
249 a structure of opportunities for further change, especially in terms of a more flexible civic society that is able
250 to supplement a lack of state action—this, in turn, being hampered by bureaucratic procedures. Similar
251 positions have been stated by other scholars, who see the unfortunate massive flows of refugees as part of
252 the structures of opportunity (Özdora Akşak & Dimitrova, 2021), as possibilities for rectifying the public blame
253 of illiberal discourse and as indicators of NGO resilience (Bryan et al., 2023).

254

255

256 The organizational/institutional ecosystem in Poland and Romania prior to 257 the war

258

259 Migration

260 In both countries, the incoming flow of refugees was accompanied by a strong civic reaction, with regular
261 citizens and NGOs helping them, especially at borders, and shaping the public authority response (Bogdan,
262 2023; Fomina & Pachocka, 2024). This was not unexpected, since, in at least some post-communist societies,
263 NGOs have assumed the major role in terms of migrant integration over the past decade—something that
264 reflects a lack of policy at the national and local levels (Bryan et al., 2023; Cech Valentová, 2018; Voicu, Deliu,
265 Tomescu, & Neguț, 2018).

266

267 In **Poland**, the assistance and integration system for migrants relies on short-term decisions, due to the
268 absence of a developed integration policy for the city. The ecosystem assisting migration involves various
269 stakeholders, but the system is not entirely open and accessible to migrants in Poland. Indeed, access is
270 contingent upon the legal status of the migrant, with two main types of actors involved: city-run institutions
271 offering access to social services and NGOs operating within grant financing systems (Wach & Pachocka,
272 2022; WCPR, 2024).

273

274 At the city level, the key institution involved in migrant integration is social welfare center, which provides
275 support to migrants with refugee or subsidiary protection status, including Ukrainian war refugees, who have
276 had temporary protection status since 2022. In Warsaw it is the Warsaw Family Support Center. Economic
277 migrants with legal residence and access to the labor market are not covered, but are still able to seek support
278 from Employment Office, another local government institution.

279

280 The crucial actors in this process are local and international NGOs, which offer various integration activities
281 to migrants, including legal assistance, cultural integration, psychological support, professional qualifications,

282 language courses, as well as social support for those facing financial challenges. An important and quite
283 recent actor is the Konsorcjum Migracyjnej/Migration Consortium, which is a democratic platform for NGO
284 cooperation.

285

286 A number of NGOs in operation in Warsaw have been established and are managed by immigrants, the most
287 significant being the Ukrainian House. It is noteworthy that an increasing number of NGOs are now employing
288 migrants as part of their workforce (Ukrainian House, 2024).

289

290 In **Romania**, the main public institution in charge of controlling and supervising immigration is the General
291 Inspectorate for Immigration—which is, in fact, a branch of the police force, under the rule of the Ministry of
292 Internal Affairs (IGI, 2024). When it comes to the public provision of (social) services, the most important
293 actor is the General Direction for Social Work and Child Protection. In Bucharest, the institution is
294 subordinated to the Local Council. Another public provider of social services is the General Direction of Social
295 Work of the City/Municipality of Bucharest, which is part of the city hall.

296

297 International organizations such as the United Nations High Commissioner for Refugees (UNHCR) or
298 International Organization for Migration (IOM) are present in Romania and collaborate with local NGOs,
299 developing programs for those arriving in Romania either as economic migrants or asylum seekers. On
300 UNHCR's website, the organizations providing support for immigrants are listed by location (Bucharest and
301 other locations near the border). A significant stakeholder is the Coalition for the Rights of Migrants and
302 Refugees, an entity specialized in advocacy, with NGOs as members. The number of NGOs in the field is
303 therefore not as small as has been reported elsewhere (Flanigan, 2022, p. 10), and during the initial days of
304 the conflict there was a sudden increase, due to the involvement of other civic organizations and NGOs that
305 were devoted to providing social services (Flanigan, 2022). Indeed, civil society mobilized itself in order to
306 contribute to the provision of solutions meeting the needs of the Ukrainian refugees coming to Romania.
307 NGOs from various fields extended their services to refugees, thereby entering a learning and adaptation
308 process, in which they had to overcome various barriers, such as those relating to administration and

309 language (Petrescu et al., 2023). These types of barriers are not new, as they have already been reported by
310 refugees and stakeholders alike, making service provision (for providers) and integration into the host society
311 complex issues (Voicu et al., 2018).

312

313 As far as the authors are aware, there are no migrant-led grassroots organizations in Romania with visible
314 involvement in advocacy and the aim of furthering discussions about the rights of migrants and refugees.
315 This is explained at least in part by Romania being primarily a country of emigration, with scarce experience
316 of hosting immigrants, whether they are economic migrants, asylum seekers, or refugees.

317

318

319 Disability

320 Poland and Romania's disability support systems exemplify the traits that are ingrained in post-socialist
321 disability frameworks (Baciu & Lazar, 2017; Pamuła, Szarota, & Usiekniewicz, 2018). Scholars in Disability
322 Studies have observed distinctive characteristics prevalent in this regional context (Mladenov, 2017; Rasell
323 & Iarskaia-Smirnova, 2011). This approach portrays disabled people as culturally “other” and as economic
324 burdens on society. The prevailing social policies are still mainly based on the medical and charity models of
325 disability. The medical model views disabled individuals primarily as patients requiring medical intervention
326 or rehabilitation, while the charitable model regards them as passive recipients of aid. Disabled people are
327 valuable members of society and citizens of the state, but neither of these models depict them as such.
328 Consequently, both models contribute to the segregation of disabled people into distinct impairment-related
329 groups, thereby failing to identify and address their needs in an intersectional and comprehensive manner.
330 This failure contradicts the requirements of the United Nations' CRPD (2006), as ratified by Romania in 2010
331 and by Poland in 2012.

332

333 Persistent shortcomings in policy formulation and implementation—especially in education, healthcare,
334 living conditions, and societal inclusion—perpetuate barriers that make it difficult for disabled people to lead
335 independent and dignified lives (OHCHR, 2018). It is important to address these issues and ensure that

336 policies and institutions are inclusive and supportive of people with disabilities. Alarming evidence points to
337 nationwide instances where institutions aiming to support disabled people inadvertently contribute to their
338 further isolation and, in some cases, subject them to violence (Bungău et al., 2019; McRae & Szarota, 2018).
339 It can be argued that the responsibility for fulfilling the obligations outlined in the CRPD falls primarily on
340 disability organizations in both countries, rather than state authorities (Bungău et al., 2019; Kubicki,
341 Bakalarczyk, & Mackiewicz-Ziccardi, 2019). However, these organizations face significant challenges in taking
342 action, due to limited funding and resources, relying heavily on grant schemes to exert influence. As a result,
343 the provision of support for disabled people is predominantly concentrated in larger urban centers in Poland
344 and Romania. In summary, despite variations in the impact of disability movements, both Poland and
345 Romania are confronting systemic challenges that impede the establishment and maintenance of supportive
346 ecosystems for individuals with disabilities, in alignment with the human rights and obligations specified in
347 the CRPD.

348

349

350 Hypotheses

351 Prior to the Ukrainian crisis, as a consequence of the flow of Syrian refugees, Valentinov et al. (2017) noted
352 that this sudden challenge helped NGOs in Austria and Slovakia to define a clear identity and better structure
353 their activities. A report on the changes in NGOs providing support to Ukrainian refugees focused on the
354 Romanian NGOs financed by the French CARE foundation, concluding that such organizations report
355 **upscaling** in terms of recruiting staff and investing in infrastructure, intensifying fundraising efforts,
356 rethinking the structure of the organization, and providing more “tailor-made interventions” as a rule of
357 organizational life (Petrescu, 2023). Other reports compare NGOs with the state, stressing the need for
358 flexible interventions in the early days of conflicts (Bryan et al., 2023), something that requires increased
359 speed (Bogdan, 2023).

360

361 We expect similar results and we go one stage further in inspecting the consequences, by looking for specific
362 evidence of **intersectionality** and **cooperation** between sectors. We also consider the state of the sector prior

363 to the war as definitive in terms of the observed impacts. When the war suddenly broke out, the efforts to
364 provide for those in need were still in their initial phases in both countries. Adequate provision for both
365 refugees and the disabled had yet to be achieved. Therefore, we expect the results for intersectionality to be
366 even worse, with migration/refugee organizations and public service providers not adequately
367 accommodating disabled refugees. We also hypothesize that the war resulted in important **changes to the**
368 **everyday lives of service providers**, not only in numerical terms—with upscaling being expected, in order to
369 face the flow—but also in terms of **deriving knowledge and good practices**.

370

371 Two years after the war started, with its ending still uncertain, the knowhow for improving existing methods
372 likely exists “on the ground,” through trial and error as well as the ad hoc “good inventions” of various civil
373 society and public actors, yet it nonetheless requires identification, labeling, and streamlining (e.g. through
374 cross-sectoral recommendations). We also expect to observe an intensification of the cooperation across
375 sectors; that is, organizations providing services to migrants and those dealing with the disabled are expected
376 to engage in exchanges of knowledge and practices. In terms of the consequences for the disabled, we
377 anticipate that social acceleration will have provided both the knowledge and tools for better service
378 provision, including beyond situations of social emergency.

379

380 Finally, given that Polish society was already better prepared to react (Van Hemelrijck et al., 2022), we expect
381 the processes of change depicted above to be found to a more sophisticated extent in Warsaw than in
382 Bucharest.

383

384

385 **Data and methods**

386 In our research, we applied two distinct methodological approaches: participatory research and rapid
387 response research. Our emphasis was on defining local priorities and perspectives integral to the
388 participatory approach, drawing insights from the work of Cornwall and Jewkes (1995). Simultaneously, the
389 rapid response research approach aimed to swiftly develop responses to emerging problems, in alignment

390 with the framework proposed by Stimson, Fitch, Rhodes, & Ball (2009). Ethical considerations, as highlighted
391 by Van Brown (2020), and recommendations in Poland (Trzeszczyńska & Horolets, 2022), led us to focus on
392 helpers, not on refugees. Purposive sampling guided our selection of stakeholders based on two criteria:
393 experience in supporting migrants/refugees and experience in supporting people with disabilities. To
394 maintain balance, we carefully controlled the representation of public and non-public actors.

395

396 The empirical data for this article was collected as part of the [anonymized project; we will add the exact
397 information and link to the website after the reviewing process]. The fieldwork took place between July 15
398 and December 15, 2023, at two research sites, Warsaw and Bucharest. All the participants provided oral
399 informed consent before the interview. Then the consent was repeated and recorded at the beginning of
400 each interview. The research comprised three stages: preliminary research involving an initial workshop with
401 stakeholders supporting either migrants/refugees or people with disabilities; individual in-depth interviews
402 (41); and an extended group interview discussing hypothetical cases of refugees with disabilities. The
403 fieldwork conducted at the two sites followed the same approach. Additional information was collected
404 during research visits to service providers in Bucharest (3) and Warsaw (3).

405

406 The initial workshop served as a valuable resource for establishing connections, constructing a potential
407 database of respondents, and gaining preliminary insights into the day-to-day challenges of professionals.
408 This workshop facilitated the calibration of research instruments and adjustments to the list of potential
409 respondents.

410

411 The most challenging aspect of the data collection proved to be the in-depth interviews with individual
412 stakeholders. Factors such as busy schedules, fatigue, and overwork posed difficulties. In Romania, an
413 additional factor was a lack of relevant cases, which hindered the experience of participants in dealing with
414 such situations. In Poland, the delay was further exacerbated by Parliamentary elections, which caused some
415 public officials to be reluctant to participate.

416

420

421 Most interviews were one-on-one, with a few involving two or three respondents. The specificity of the
 422 research theme probably deterred participants, due to their limited experience with cases of refugees with
 423 disabilities, and the participation of multiple respondents in the same encounter was perceived as an attempt
 424 to maximize the gains of the researchers or help them in gathering more relevant information.

425

426 The response rate was relatively low at both research sites: 20 interviews were completed in Bucharest, after
 427 reaching out to 60 individuals, and 21 were completed in Warsaw, after approaching almost 50 potential

428 respondents. Interviews were conducted face-to-face (6 in Romania, 9 in Poland), online (12 in Romania, 8
429 in Poland), or by phone (2 in Romania, 4 in Poland), according to the respondents' preferences.

430

431 Following the completion of a minimum of 20 interviews, we organized an extended group interview with
432 relevant stakeholders, moderated by an external expert. This workshop focused on discussing potential cases
433 of refugees with disabilities as well as addressing issues such as available resources, access, and possible
434 setbacks. The cases were defined by the researchers and provided to the participants and the moderator.
435 This event served as a means of validating the research findings and enriching them with practical insights
436 from local actors. Its added value resulted from bringing together stakeholders with diverse backgrounds—
437 NGOs (in Poland and Romania), public administration (in Poland and Romania), and academia (in Romania)—
438 as well as from fostering collaboration and reaching consensus on the given cases.

439

440 At each stage of the research, respondents were informed about the purpose and funding, and each
441 participant provided consent for interviews and recordings. All interviews were anonymized to ensure
442 confidentiality.

443

444

445 Findings

446

447 Strategies adopted by service providers

448 Warsaw

449 Both NGOs and public service providers were unprepared to help high numbers of refugees, including those
450 with disabilities. The first stage of helping was based on chaotic responses and a high level of engagement,
451 with mainly grassroots organizations taking part. The main frame of reference for the activities of public
452 institutions was constituted by the legal provisions defining target groups and methods of assistance. When
453 possible, public agencies and NGOs were inclusive in helping: citizenship was not an aid criterion for either,

454 with both having programs for which participants were eligible as long as they legally resided in Poland. There
455 was one exception, however: if a person wished to be eligible for state social security support due to having
456 a disability, then a Polish disability certificate was necessary. In other instances, a declaration of disability
457 was enough. The state agencies did not provide help directly; rather, they transferred money to other
458 entities, such as NGOs or local governments, to directly organize help to UWRwD:

459

460 *(Anonymized) directly does not provide this support in the sense of organizing accommodation,*
461 *meals, or rehabilitation activities for individuals from Ukraine. Instead, (anonymized)*
462 *outsources these services to other entities. (PL19, M, agency of public administration)*

463

464 Building networks of cooperation was a common strategy for local government agencies and NGOs.
465 Organizations did not provide all the support needed: they usually focused on some aspects, and if a
466 beneficiary required help beyond their scope, they knew where to redirect that beneficiary—for instance,
467 one of the disability-focused organizations (PL06) cooperated with a migration organization when a
468 translation was needed, with another organization providing food and another offering financial support, if
469 needed. In turn, the organization supported others when they required equipment for people with physical
470 disabilities:

471

472 *Of course [we have allies], because they also work towards our goals, and that's why very often*
473 *such situations where we can recommend our Foundation to people, like recommending us*
474 *from other foundations, we do the same. (PL06, F, NGO focused on the disabled)*

475

476 However, the cooperation between the non-governmental and public sectors was limited. The main focus
477 was on applying for grants that were called for by public institutions. State institutions were perceived by
478 NGOs as being only temporarily present and slow in organizing help—indeed, after some time, it was
479 observed that they began to withdraw from the assistance (GI).

480

481 Local government, to some extent, and NGOs based their systems of helping Ukrainian war refugees with
482 disabilities on the voluntary work of both Poles as well as Ukrainians. This was especially true during the first
483 few months of helping, when the influx was high but there was a lack of human resources and experience as
484 well as a lack of procedures:

485

486 *we ask the refugees themselves who stay in the hostel to take care of such a person in these*
487 *basic matters [...] Sometimes we have friends who do this work [...] but it's not a systemic*
488 *solution. (PL04, M, NGO focused on immigrants)*

489

490 Over time and with increased funding, the NGOs started to hire new employees and sometimes even open
491 new offices.

492

493 It seems that the main differences in approach to helping Ukrainian war refugees with disabilities are not
494 between public and non-governmental entities, but rather between those state entities that support
495 refugees directly and those that support them indirectly. Direct contacts with beneficiaries created common
496 experiences for actors helping refugees. However, these experiences were not converted into new
497 procedures and regulations that could be used in the future, should Poland receive refugees again.

498

499

500 Bucharest

501 According to our interviewees, the story was similar in Romania with respect to the flow of refugees, with
502 surprise, a lack of preparedness, and chaotic responses characterizing the first few days. Local NGOs, being
503 more supple in terms of their organization, focused on migration issues, with those NGOs dealing with social
504 services intervening and providing unstructured help. Even after the state agencies stepped in and organized
505 refugee camps, the presence of NGOs—this time backed by their transnational branches—continued to be
506 essential, especially in tailoring the interventions to the needs of refugees in general and UWRwD in
507 particular. However, neither the NGO sector nor the state agencies had specific provisions for refugees with

508 disabilities. Intersectionality was increasingly a hot issue, not only in relation to the need to recognize
509 disability certificates, but also when realizing that many other facilities were actually missing from the service
510 provision:

511

512 *we are deficient in providing services to people with disabilities, of any kind of disability. People*
513 *with physical disabilities are more visible, obviously. But we are still far from providing any*
514 *services for people with disabilities. (RO17, F, NGO focused on other issues than refugees or*
515 *disabled)*

516

517 Cross-domain cooperation (migration versus disability) was forced by the particular difficulties being
518 encountered, mainly in terms of the capacity to support refugees. NGOs focused on immigration-related
519 issues, including refuge, started to refer UWRwD to NGOs in the social sector more often, especially those
520 dealing with disabilities. At least until mid-2023, the problem was not one of financing, but related to human
521 resources, the burnout of service providers, skills, the availability of the proper tools and facilities, and the
522 capacity for advocacy. The social acceleration assumption proved to be true, as one of our interviewees
523 points out:

524

525 *cooperation was due to overcrowding; that is the main dominant criterion. Access to funds was*
526 *secondary because, in general, since the war started and until the end of this year, there have*
527 *been more funds than the capacity to help [...] At least that's how I estimate it. That is, no one*
528 *complained about... about a lack of... of funds. On the contrary, there were organizations that*
529 *said, "oh, too many donors come to us"; there were organizations that had to give up some*
530 *donors by directing them to others. (RO14, M, NGO focused on migration issues)*

531

532 Considering the public agencies, they developed creative solutions in order to deal with the lack of
533 regulations as well as funding: bringing resources from home, improvising, and letting NGOs step in and
534 provide the services in spaces run by the public agencies. Again, cooperation occurred mainly as a result of

535 the need to provide services alongside overcrowding. Since this need was apparent early on, public providers
536 were accordingly open to accepting help from NGOs from very early on.

537

538 Both state agencies and NGOs claimed that the legislation was ancillary, slow in evolving, and revealed little
539 understanding of the actual needs of refugees (with disabilities). One of the interviewees clearly pointed out
540 that:

541

542 *If the Romanian state has decided to do this, to make this change, it did a good thing. In my*
543 *opinion, it should have been done a long time ago because they got used to the idea that we*
544 *have rights for too long. And suddenly, on May 1st, the state came with the ordinance [...] you*
545 *must integrate. In my opinion, this should have come gradually, it was a year to stay, you have*
546 *the right, receive everything, and then [...] they were pushed, as they say, onto the streets,*
547 *alone. It was all of a sudden, that's my opinion. They are still people who need help, they are*
548 *still disappointed, disillusioned, frightened, worried. Yes, the change came too abruptly. I*
549 *believe this change should have come after 3, 4, 5, 6 months. (RO09, F, public refugee center)*

550

551 To sum up, intersectionality was considered only in the later phases of refuge, when some cross-domain
552 cooperation also started to exist. Nothing was programmatic—rather, it was reactive, resulting from the need
553 to do something with and for those in need. NGOs came forward to help public service providers, and NGOs
554 focused on migration were more open toward cooperating with the ones dealing with disability issues. We
555 noticed little transfer of knowledge and good practices across domains, but we encountered accounts of
556 cooperation within the domains—that is, service providers in a specific field mainly cooperated with other
557 providers in that field.

558

559

560 Changes observed among service providers

561 Warsaw

562

563 The first change for service providers was to have a new type of beneficiary:

564

565 *Regarding war refugees with disabilities, how long has your organization been involved in this issue?*

566 *For us, the moment of the outbreak of the war in Ukraine, the Russian invasion, was when we started*

567 *thinking about such issues. (PL15, F, NGO focused on disability)*

568

569 This resulted in other changes and caused the NGOs to adopt strategies in response to the new demands.

570 Disability and migration NGOs leveraged existing support networks to boost their efforts, forming new

571 alliances to extend their capacities:

572

573 *I saw a great need to be better prepared both in terms of expertise and, I mean, practically. I*

574 *mean, I'm talking about the expertise that can be applied, right? [...] I think it was a need for*

575 *better information flow between organizations themselves. But we tried to fix it somehow by*

576 *creating these shared files, whether on drives or creating this communication channel. We tried*

577 *to somehow fix it and meet that need. (PL15, F, NGO focused on disability)*

578

579 Using networks provided opportunities to obtain knowledge and solutions:

580

581 *And, honestly, I don't know if we would have taken it on in such an organized way [...] if it*

582 *weren't for the support from organizations that are more experienced in this field. (PL15, F,*

583 *NGO focused on disability)*

584

585 Another aspect of change was expanding human resources. NGOs hired additional staff, many of whom were

586 bilingual or multilingual and could overcome the language barriers between service providers and refugees:

587

588 *I think here many organizations also experienced this sudden growth, and a lot of new people*
589 *were hired, who often had to be trained because, as we mentioned, bilingual individuals were*
590 *in high demand, and many of them, like me, completely changed their profession. So, it was*
591 *necessary to quickly acquire a lot of knowledge. (PL02, F, NGO focused on immigrants)*

592

593 To address the varied needs of refugees, NGOs developed new services and projects, including bilingual
594 hotlines, video services for the deaf, accessible information centers, and customized support services. This
595 development required an expansion and strengthening of the administrative functions of NGOs, to manage
596 operations effectively and ensure compliance with the various regulations:

597

598 *Earlier, we never dreamed of such, such, such large amounts of money in the account, so to*
599 *speak. Such large funding, it sounded nice. And that was such a leap, both financially and in*
600 *terms of staff; our team expanded, and our experience as well. So, we had to learn a lot and*
601 *gain a lot of experience. When I opened the point, which was again a new place, in a new*
602 *location, something completely new, I approached it differently, also more calmly. (PL07, F,*
603 *NGO focused on disability)*

604

605 Employees and volunteers gained new skills, particularly in handling sensitive and complex situations relating
606 to the refugee crisis:

607

608 *not only did we need knowledge and access to information to provide people with reliable,*
609 *good, and up-to-date information, but also psychologically, it was challenging. We learned a*
610 *lot in those first months, but we also understood that the knowledge and so-called hard skills*
611 *we have need improvement. Also, as employees on the first line, we need improvement in the*
612 *emotional sense to take care of ourselves, our rest, and our overall well-being. Improving*

613 *qualifications in working with people in crisis is essential. (PL02, F, Polish NGO focused on*
614 *assisting Ukrainians)*

615

616 A public service provider in Warsaw also experienced upscaling in human resources and the type and number
617 of beneficiaries. However, the latter have decreased:

618

619 *after February 24th, [anonymized] expanded by nearly a hundred employees due to the task*
620 *assigned by the Voivode, involving Long-Term Stay Points for refugees from Ukraine. Initially,*
621 *there were nine points, and currently, we have five, accommodating a total of approximately*
622 *1,020 individuals, give or take. (PL13, F, agency of public administration)*

623

624 The service providers that did not have direct contact with UWRwD created new programs and calls for grants
625 for NGOS directly helping UWRwD, and also created funds, but did not experience upscaling in the human
626 resources area.

627

628 Service providers experienced changes in the types and scopes of their activities as well as their numbers of
629 employees. They gained a lot of knowledge and experience in helping refugees with disabilities. However,
630 such change has been constant, due to the decreasing number of UWRwD and diminishing support from both
631 public institutions as well as society.

632

633

634 **Bucharest**

635 Adaptability and upscaling were the bases for responding adequately to the needs of refugees from Ukraine,
636 who constituted a new category of beneficiary. For NGOs in the field of immigration, the novelty resided in
637 the country of origin, and for disability-focused NGOs, the status of the beneficiaries was new, with their
638 multilayered vulnerability, rooted in being displaced and disabled at the same time. Both public and civil-
639 society-based actors were involved in the provision of services to Ukrainian refugees with disabilities, and

640 most often communication between the various entities proved to be key when dealing with the complex
641 needs that emerged. The cooperation between public providers/structures and NGOs was an effective way
642 of making sure that potential beneficiaries could access the services they required in time, due to the
643 flexibility of the latter. Beneficiaries with disabilities were directed toward suitable service providers, but this
644 was not straightforward and without hurdles:

645

646 *The main difficulty is to find organizations that deal with disabilities, except for the parts of*
647 *autism, where there are organizations that respond. (RO12, F, NGO focused on other issues*
648 *than refugees or disabled)*

649

650 Cooperation was part of the learning process, especially for NGOs that were not in the field of
651 immigration/refugees before the war, which had to adapt to the pace of change quickly. At first, the activities
652 of NGOs were mainly directed by the needs they encountered directly in the field, but, as time went on, they
653 gained structure and coherence as their knowledge about how to handle specific cases increased. Specific
654 types of problems were encountered, and cooperation played a significant part in dealing with them,
655 alongside constant communication with the beneficiaries:

656

657 *With time, the organizations' actions became more structured. We identified the needs and*
658 *aligned ourselves more effectively. However, at the beginning, it was more of an*
659 *improvisational effort [...] We couldn't predict the problems that would arise the following*
660 *week [...] In other words, after offering assistance, we need to get feedback to see if we did*
661 *well or if we need to adjust something [...] I thought that there were some lessons we learned*
662 *from there, and we learned to see them. They are somehow knowledge, experiences that our*
663 *international partners, who usually do this, brought to us. (RO03, F, NGO focused on other*
664 *issues than refugees or disabled)*

665

666 In the case of public service providers, the considerable increase in the number of beneficiaries was usually
667 not followed by an increase in the number of employees, which often resulted in overworking. In the case of
668 NGOs, organizational growth was a direct consequence of expanding the pool of potential beneficiaries. This
669 process was closely guided by the needs that were encountered “on the ground,” and, at least at first, there
670 was a significant share of learning by doing. The existence of various funding schemes allowed for the
671 upscaling process to take place. Teams were expanded with case workers, as well as with administrative
672 personnel, to better pursue financing alternatives. Significant difficulties were associated with finding
673 translators and, as many NGOs increased their scopes, it was sometimes hard to find the best-suited
674 professionals, due to the high number of hiring offers. For public service providers, it was more a matter of
675 being assigned to this new task associated with Ukrainian refugees, so situations that employees were not
676 able to manage for long were not uncommon:

677

678 *We came here for the first time, we got to know each other. In the meantime, we changed*
679 *many people in the team because some didn't want to, some couldn't cope, some had various*
680 *problems. We changed people; we weren't a constant team. (RO011, F, agency of public*
681 *administration)*

682

683 However, what started as exponential growth stopped over time, due to the diminishing of the available
684 funds, leading to insecurities and uncertainties regarding the sustainability of some of the services that were
685 provided and, accordingly, the sustainability of maintaining the newly acquired professionals. In this context,
686 thorough documentation regarding case handling and good practices would probably have been an effective
687 organizational tool for enhancing knowledge retention, beyond economic and systemic/structural
688 fluctuations.

689

690

691 Conclusion and discussion

692 Our research offers a cross-sectional description of experiences of helping refugees with disabilities in the
693 face of negative events, requiring quick actions but, at the same time, creating structures of opportunity. The
694 paper examines how and to what extent these structures of opportunity were used and also introduces the
695 discourse of intersectionality into the field of supporting refugees with disabilities. Our research focuses on
696 two metropolitan areas of countries with only limited experience of helping refugees, including those with
697 disabilities. Furthermore, both these countries are post-communist countries, with relatively weak civil
698 society spheres and ongoing struggles with the illiberal wave. The results of the research based on the two
699 cases can be generalized to other countries with similar histories and experiences of (not) helping refugees
700 with disabilities.

701

702 Based on our analysis, we argue that key institutional changes have occurred in the areas of: material and
703 human resources, networks of cooperation, and programmatic upscaling. The upscaling was experienced by
704 NGOs, and to a lesser extent by public agencies.

705

706 Regarding the material and human resource upscaling, the most significant factor related to the
707 unprecedented financial support received by NGOs, especially those focused on migration and disability in
708 Poland and those focused on migration in Romania. That support enabled the organizations to strengthen
709 their human resources by hiring more qualified staff—both administrative personnel and case workers,
710 including ones with a background in migration. The expansion allowed the NGOs to provide a broader range
711 of assistance and acquire more physical space to accommodate more people in need. In Poland, some
712 organizations were even able to open additional branches, while in Romania it was often the case that NGOs
713 were present at the borders with Ukraine and the Republic of Moldova, to offer on-site assistance, which
714 was a new type of experience.

715

716 In contrast, public providers did not experience the same level of upscaling, except for one in Warsaw. Due
717 to their more structured nature, bureaucratic constraints, and generally less flexible approach, public services

718 continued to operate within their original parameters. However, the new responsibilities assigned to them,
719 such as distributing public funds to NGOs or organizing reception centers, broadened the scope of their
720 material focus, even though their overall capacity did not expand as significantly as that of NGOs.

721

722 The organizations helping disabled refugees were prompted to extend their mission, especially through
723 hands-on learning experiences. The organizations realized that they were very often not capable of
724 addressing the multifaced needs resulting from displacement, disability, age, and other characteristics of
725 refugees. As a result, we observed evolving collaboration between disability-focused and migration-focused
726 NGOs in Poland and Romania. However, the nature of this collaboration varied between the two countries.
727 In Poland, both migration-focused and disability-focused NGOs were strongly proactive in establishing
728 networks and exchanging information. In Romania, by contrast, migration-focused organizations showed
729 much more cross-sectorial initiative than disability-focused organizations. This difference between the two
730 countries could be due to the comparative strengths of the disability advocacy sector, being stronger in
731 Poland than in Romania.

732

733 The organizations acquired knowledge in terms of how to fundraise and how to manage large new projects.
734 Due to the contact with a new kind of beneficiary, they gathered information about and built knowledge
735 relating to supporting refugees with disabilities. In the case of UWRwD, neither legal residence nor access to
736 many public services was an issue, but we observed that support providers had to learn how to help UWRwD
737 in terms of accessibility and language issues, as well as approaches to defining, diagnosing, and treating
738 various forms of disabilities. Gathering this knowledge was one of the most important dimensions of the
739 upscaling of the organizations. However, most organizations have not managed to transform this
740 accumulated practical knowledge into more established solutions, such as written procedures. This pattern
741 confirms the existing trend within civil-society-sector organizations. Due to a lack of funds focused on long-
742 term institutional development, these organizations usually do not have the capacity to turn their acquired
743 knowhow into more organized approaches to action or systematic solutions. Such systematic solutions, as
744 part of institutional knowledge acquisition, would be transferable across other organizations and would not

745 depend on being retained solely by the people who produced that knowledge, meaning that they could stay
746 with the organizations.

747

748 At the beginning of our research, we decided to distinguish between two categories of service providers—
749 public ones and NGOs—and describe their experiences of supporting UWRwD. Our results revealed that, on
750 the one hand, the public agencies were slower and not as flexible in helping refugees with disabilities. On the
751 other hand, though, we could observe a difference between public agencies with direct and indirect contact
752 with UWRwD. The former were mainly local government actors, with frontline workers having direct contact
753 with UWRwD, making their experiences more similar to those of NGOs, since they were forced to introduce
754 non-standard solutions while helping. Therefore, they were occasionally prone to contacting NGOs and
755 building cross-sectional networks of support. They also experienced upscaling in terms of knowledge about
756 supporting refugees with disabilities, which was a consequence of helping. As in case of the NGOs, however,
757 this knowledge has not been codified.

758

759 Analysis of the collected data revealed that patterns of organizational growth can be observed both in the
760 areas of human resources and programmatic assistance in both countries. The first stage of assistance,
761 immediately after the outbreak of the war, was dominated by NGOs, which, despite limited resources and a
762 lack of experience, started to support refugees with disabilities almost immediately. The consequences of
763 these actions were overwork and employees burning out. The funds that quickly followed allowed for the
764 employment of new employees, however, enabling the situation to be normalized and the activities to be
765 expanded. Public actors subsequently joined the field of assistance, only after the creation of legal solutions
766 allowing them to operate. Despite the presence of public actors, though, the main burden of assistance
767 rested on the shoulders of NGOs.

768

769 In terms of programmatic assistance, in the first phase, the following pattern can be observed: recognition
770 of the needs of refugees—diagnosis of one's own capabilities—coming up with a solution—providing
771 assistance or searching for an organization that can help and redirecting a beneficiary. This mode of operation

772 contributed to the creation of a support network between NGOs, which furthered the provision in their areas
773 of activity, allowing for more responsive and effective assistance. In the later stages, as the organizations
774 became more experienced, the process of helping was smoother, as after diagnosing the needs of UWRwD,
775 they usually knew where to direct a person. Recognizing the needs of subsequent immigrant cases allowed
776 information to be collected about the best ways of helping refugees as well as coping with multicultural
777 perceptions of disability.

778

779 This pattern is true for both Warsaw and Bucharest, but there were some specific differences between the
780 two cities. The cross-domain cooperation was low, and it seems to have been higher in Bucharest than in
781 Warsaw, while the within-domain cooperation was more common in Warsaw than in Bucharest. This was
782 probably due to the fact that in Bucharest, the local authorities were more present in organizing help for
783 UWRwD than in Warsaw, while the NGO sector supporting people with disabilities was more visible and
784 involved in providing services to Ukrainian refugees with disabilities in Warsaw than in Bucharest.

785

786 Our research also has its limitations: we interviewed organizations in Warsaw and Bucharest, so our findings
787 can be expanded to other large cities—but the experiences of helping at border areas, as well as in smaller
788 towns, have not been reflected. Another limitation is the fact that the refugees with disabilities themselves
789 and their caretakers who have daily routines of caring were not part of the research. Future research should
790 be foremost devoted to gathering and analyzing the experiences of the refugees with disabilities themselves.
791 Additionally, it should investigate whether and how cross-sectional cooperation continues to be
792 implemented in the evolving national contexts of Poland and Romania, as well as over a broader geopolitical
793 landscape. Another topic would be to examine how the discourse of intersectionality between refuge and
794 disability is developing in Poland and Romania and other countries of Central and Eastern Europe.

795

796 In general, while the "unfortunate natural experiment" that we have documented resulted in capacity
797 building, especially among the NGOs, and while it also led to previously unknown networking and cross-
798 sectional cooperation between NGOs and public service providers, both in Poland and Romania, such

799 upscaling trends could be unstable or reversible. This reversibility might be contingent not only upon the
800 available funds, but also upon the human capacity to work in highly stressful conditions marked by constant
801 change and uncertainty—even if the service providers and their staff are strongly motivated to help people.

802

803 As for policy recommendations, the key issues involves creating long-term policies for supporting refugees
804 with disabilities and including refugees with disabilities in relevant laws and programs at both national and
805 local levels.
