



Definitions

- **Total time in-bed (h)** Total time that the Withings sleep analyser (WSA) registers that someone is in bed between 07:00 and 07:00.
- **In-bed bout** A contiguous sequence of minutes in which the WSA registers that an individual is in bed. An in-bed bout has a start time, an end time and a duration (h).
- Out-of-bed bouts An unbroken period of time in which the WSA registers no information.
- **Sleep bout** A contiguous sequence of minutes in which the WSA registers that an individual is in one of deep, light or REM sleep. A sleep bout has a start time, an end time and a duration (h).
- **In-bed period** A sequential group of in-bed bouts where the gap between successive in-bed bouts is less than one hour.
- **Sleep period** A sequential group of sleep bouts where the gap between successive sleep bouts is less than one hour.
- **Nocturnal in-bed period** An in-bed period where the start time of the first in-bed bout is after 18:00 and before 07:00 and at least 2 minutes are recorded as sleep.
- **Nocturnal sleep period** A sleep period where the start time of the first sleep bout is after 18:00 and before 07:00 and the period is at least 2 minutes long.
- Major nocturnal in-bed period The longest nocturnal in-bed period.
- Major nocturnal sleep period The longest nocturnal sleep period.
- **Minor nocturnal in-bed periods** All nocturnal in-bed periods other than the major nocturnal in-bed period.
- Minor nocturnal sleep periods All nocturnal sleep periods other than the major nocturnal sleep period.
- **Current day** The day leading up to the nocturnal in-bed period. For daily measures (e.g. the total time in-bed, the current day starts at 07:00.

Definitions related to in-bed periods initiated during the day

- **In-bed period initiated during the day** An in-bed period with the start time of the first in-bed bout in the period after 07:00 and before 18:00 and at least 2 minutes are recorded as sleep.
- **Sleep period initiated during the day** A sleep period with the start time of the first in-bed bout in the period after 07:00 and before 18:00 and the period is at least 2 minutes long.
- Total duration of in-bed periods initiated during the day on the current day (h) The sum of the durations of all the in-bed periods that start during the day on the current day.

Definitions related to the major nocturnal period

- **Duration of the major nocturnal in-bed period (h)** The period of time from the start of the major nocturnal in-bed period to the end of the major nocturnal in-bed period.
- Onset time of the major nocturnal in-bed period The start time of the major nocturnal in-bed period.
- Offset time of the major nocturnal time-in-bed period The end time of the major nocturnal in-bed period.

Definitions related to fragmentation

- Number of bed exits Number of out-of-bed bouts during the major nocturnal time-in-bed period.
- Bed exit rate (exits/h) Number of 'bed exits' / Major nocturnal in-bed period duration.
- **Median duration of bed exits (h)** The median duration of out-of-bed bouts during the major nocturnal in-bed period.
- **Median duration of sleep bouts (h)** The median duration of sleep bouts during the major nocturnal in-bed period.
- Median duration of wake bouts (h) The median duration of wake bouts during the major nocturnal in-bed period.
- Wake after sleep onset (h) The sum of the WSA wake state duration and the out-of-bed duration during the major nocturnal sleep period.
- **Sleep efficiency (%)** $100 \times$ The nocturnal sleep duration / duration of the major nocturnal in-bed period.

Definitions related to physiology

- **Mean breathing rate (breaths/min)** Mean breathing rate during the major nocturnal sleep period for minutes that the WSA registers that an individual is asleep.
- **Mean heart rate (beats/min)** Mean heart rate recorded during the major nocturnal sleep period for minutes that the WSA registers than an individual is asleep.
- Std dev. heart rate (beats/min) Standard deviation of the heart rate values recorded during the major nocturnal sleep period for minutes that the WSA registers than an individual is asleep.

Definitions related to the environment

Mean light intensity (lux) The mean light intensity recorded by the multi-sensor between 07:00 on the current day and 07:00 on the next day.

- **Geometric mean light intensity (lux)** The geometric mean light intensity recorded by the multi-sensor between 07:00 on the current day and 07:00 on the next day.
- Hours of bright light (h) The amount of time that the multi-sensor records light levels of 500 or more lux on the current day.
- **Mean daily temperature (°C)** The mean temperature recorded by the multi-sensor between 07:00 on the current day and 07:00 on the next day.
- **Maximum daily temperature (°C)** The maximum temperature recorded by the multi-sensor between 07:00 on the current day and 07:00 on the next day.
- **Minimum daily temperature (°C)** The minimum temperature recorded by the multi-sensor between 07:00 on the current day and 07:00 on the next day.
- **Mean nocturnal temperature (°C)** The mean temperature recorded by the multi-sensor during the major nocturnal in-bed period.
- **Temperature amplitude (°C)** The difference between the maximum and minimum value of the temperature on each 24-hour period from 07:00 on the current day to 07:00 on the next day.



S5 Seasonal desynchrony

The time of the heart rate minimum is a hypothesised marker for the timing of the biological clock with heart rate tending to drop overnight to a minimum and then rising before wake. This can be seen in Fig. 1 and is reproduced in Fig. S5 (a) for the "seasonal" participant. An example for one night is shown in Fig. S5 (b). Around January in the transition from Year 2 to Year 3, the time of the heart rate minimum appears to desynchronise from the 24 h day. Light is the major driver of entrainment to the 24 h day and for the timing of the biological clock. For this participant, the environmental sensors in the home indicate that the indoor light environment is very dim, particularly during the winter months, see Fig. S5 (c), well below recommended light levels [1]. To assess whether the low levels of lighting could be a contributing factor to the observed desynchrony we used a mathematical model which has previously been shown to accurately fit individual mean sleep duration and timing using light collected from wearable sensors [2]. We took the first month of environmental light and bedmat sleep timing data (June of Year 1) and, as in [2], tuned two parameters one for sleep duration and one for sleep timing to create a personalised model. We then took the personalised model and fed in the environmental light to predict sleep timing in all subsequent months in two scenarios. First assuming that there was no feedback from the sleep-wake cycle on to the light-dark cycle. Second assuming that light was gated by sleep. Predicted sleep timing is shown for the two cases in (d). Interestingly, we found that when lights were turned on and off according to when measured bedtime occurred, we found that there was a delay in predicted sleep and circadian timing in the winter months. Whereas, when light is gated by predicted sleep-wake timing, desynchrony in the winter occurs. These two scenarios demonstrate the stabilising effect of imposed lights out / bedtimes on sleep and circadian timing, as highlighted in [3]. One explanation for the difference between the first and seond winter is that a period of ill-health leading to changes in routine, combined with the low levels of ambient light could trigger the observed desynchrony.


