### **Supplemental Note 1.**

While the main analyses of this manuscript focused on comparing healthy controls and clinical controls to participants with recent suicidal ideation or a lifetime suicide attempt, we also performed supplementary analyses in which we compare WM microstructure between healthy controls and clinical controls. These analyses may not reveal new information related to the neural correlates of suicidality, but may help identify alterations related to having a psychiatric diagnosis and contribute to the interpretation of our main findings. These supplementary analyses were performed similar to the main analyses (with age, sex, age-by-sex, age<sup>2</sup> and age<sup>2</sup>-by-sex included as covariates). In order to compare to our main findings, we compared healthy controls and clinical controls in samples included in the analyses on lifetime suicide attempt ( $N_{CLC}= 1871$ ,  $N_{HC}= 642$ ) and in samples included in the analyses on recent suicidal ideation ( $N_{CLC}= 1184$ ,  $N_{HC}= 1240$ ). Results are presented in supplemental tables S41-48. Results showed no significant differences between global or regional AD, FA, MD or RD between healthy controls and clinical controls in samples included in the analyses on suicide attempt (supplemental tables S41-44). In samples included in the ideation analyses, we observed lower global AD and regional AD in the ACR, CGC, GCC and SLF in the CLC group compared to HC (Cohen's d range: 0.112-0.184; supplemental table S45). In addition, we observed lower global FA and regional FA in the GCC in the CLC group compared to HC (Cohen's D=0.123 and 0.127 respectively; supplemental table S46).

## **Supplemental note 2.**

The ENIGMA-Suicidal Thoughts and Behaviours consortium is transdiagnostic, and includes participants with various types of psychiatric illness, including major depressive disorder, bipolar disorder, anxiety disorders, obsessive-compulsive disorder, posttraumatic stress disorder and psychotic disorders. We were interested to examine if the association between suicidality and WM microstructure differed according to diagnosis type. In supplemental analyses, we aimed to examine interaction effects between group (clinical controls and recent suicidal ideation or clinical controls and lifetime suicide attempt) and type of lifetime psychiatric disorder. Healthy controls were not included in this analysis as they did not have a psychiatric disorder. As information on lifetime type of psychiatric disorder was only available for a subsample of participants (some sites only assessed current disorders), these analyses were performed as supplemental analyses.

Lifetime diagnosis type was categorized into six main lifetime diagnosis types: MDD, BD, anxiety disorders, PTSD, OCD and psychotic disorders. In the suicide attempt-by-diagnosis interaction analyses, we were only able to include MDD (N=1139, of whom 355 attempted suicide), BD (N=553; of whom 141 attempted suicide) and psychotic disorders (N=198; of whom 44 attempted suicide) given the small sample sizes per lifetime diagnosis type. Similarly, in the recent suicidal ideation-by-diagnosis interaction analyses, we were only able to include MDD (N=1128 of whom 424 had recent suicidal ideation) and BD (N=225; of whom 114 had recent suicidal ideation).

Similar to our main analyses, we used multiple linear regression models in R, in which we included the group-by-diagnosis type interaction term, and main effects of group and diagnosis type. Results of these analyses are presented in supplemental tables S49-56. Results show that there are no significant interaction effects between suicide attempt group (clinical control or lifetime suicide attempt) and diagnosis type (MDD, BD or psychotic disorder) on WM microstructure (supplemental tables S49-52). In contrast, we observed many significant interaction effects between suicidal ideation group (clinical control or recent suicidal ideation) and diagnosis type (MDD or BD) on WM microstructure, specifically on regional FA, MD or RD (supplemental tables 53-56). These findings indicate that the association between ideation and these WM microstructure metrics differs in MDD patients and BD patients. To follow-up on this, we performed stratified analyses, looking at the effect of recent suicidal ideation (clinical controls vs. recent ideation) in MDD patients and BD patients separately (with age, sex, age-by-sex, age<sup>2</sup> and age<sup>2</sup>-by-sex included as covariates) for regions where we found significant interaction effects. Results of these stratified analyses are presented in supplemental table S57. For most of these associations, the strength of the association appeared to differ between MDD and BD patients, but the associations were not significant in the MDD only sample or BD only sample. Plotting the results showed that the difference between clinical controls and ideators appeared larger in the BD group, than in the MDD group.
