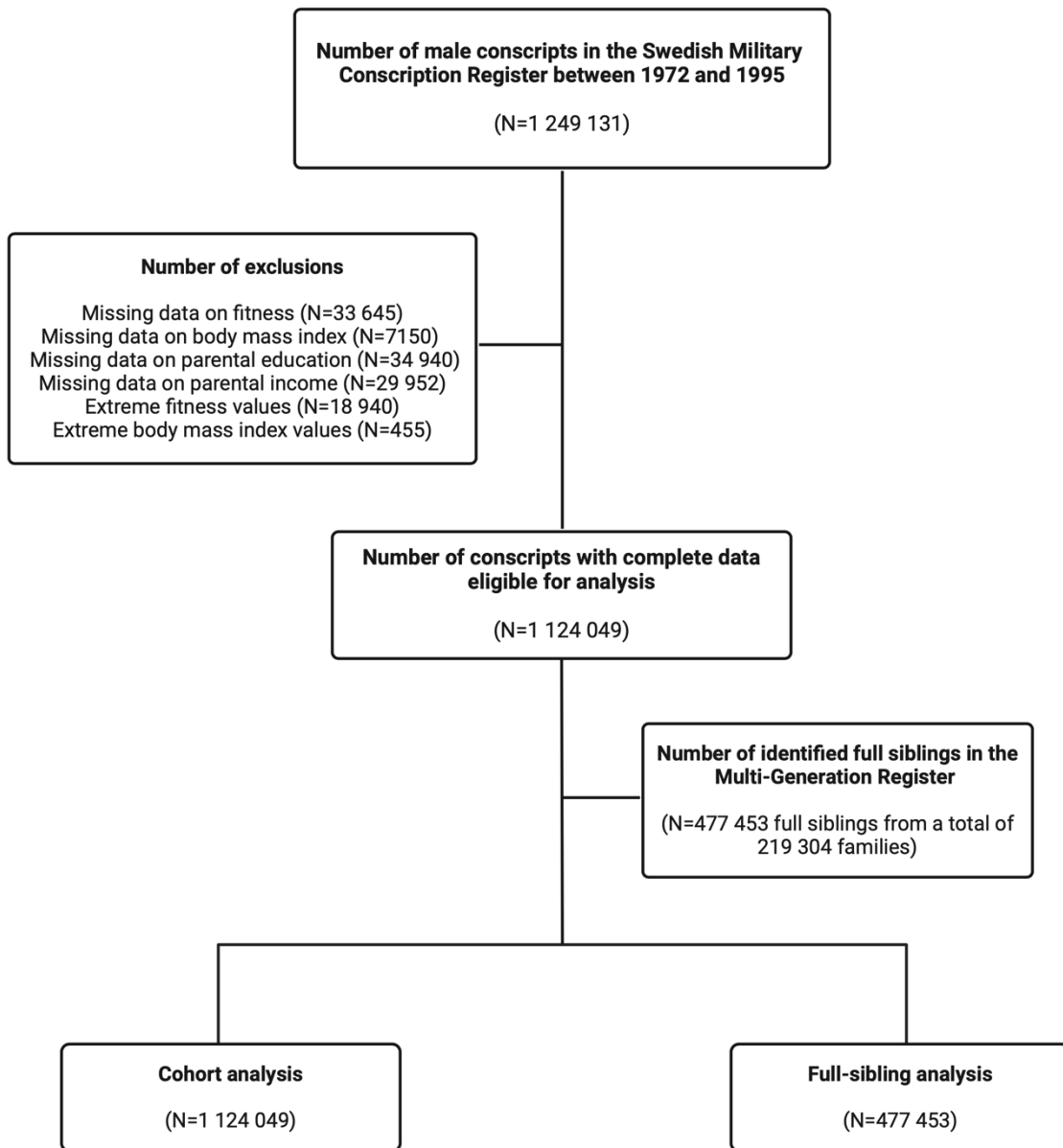

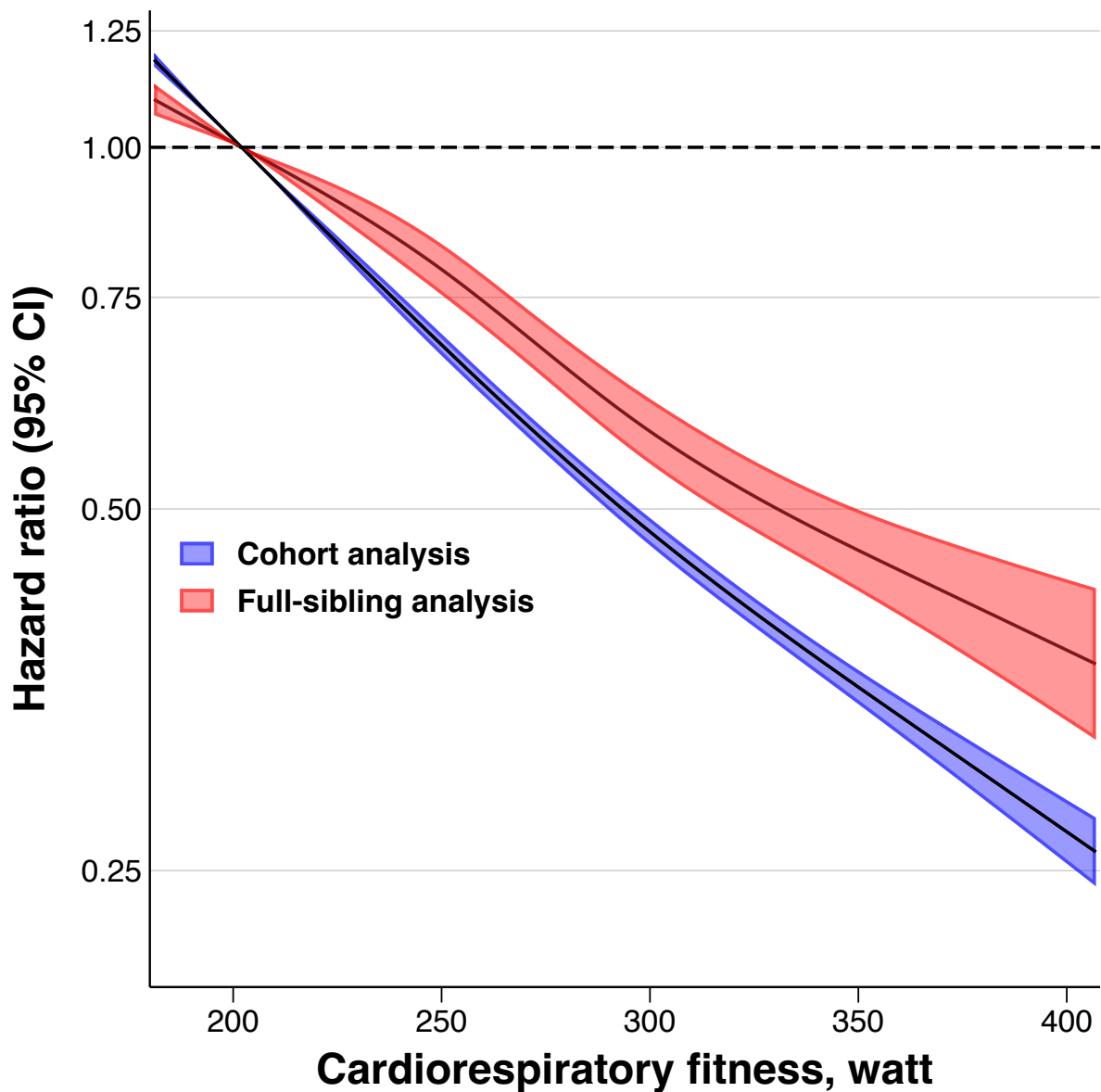

**Supplemental Figure 2. Hazard ratios for type 2 diabetes diagnosis only (thus not considering dispensation of antidiabetic medication as in the main analysis) across restricted cubic splines of cardiorespiratory fitness in cohort and full-sibling analysis.** Estimates were obtained using flexible parametric survival models, extended to a marginalized between-within model in the sibling analysis, with knots placed at the 5<sup>th</sup>, 35<sup>th</sup>, 65<sup>th</sup>, and 95<sup>th</sup> percentile, and using age as the underlying time scale. The referent was set to the median value of the bottom decile (202  $W_{max}$ ). The models were adjusted for age at conscription, year of conscription, body mass index, parental education, and parental income. For graphical purposes, the x-axis was limited to span from the first to the 99th percentile of the exposure distribution.
