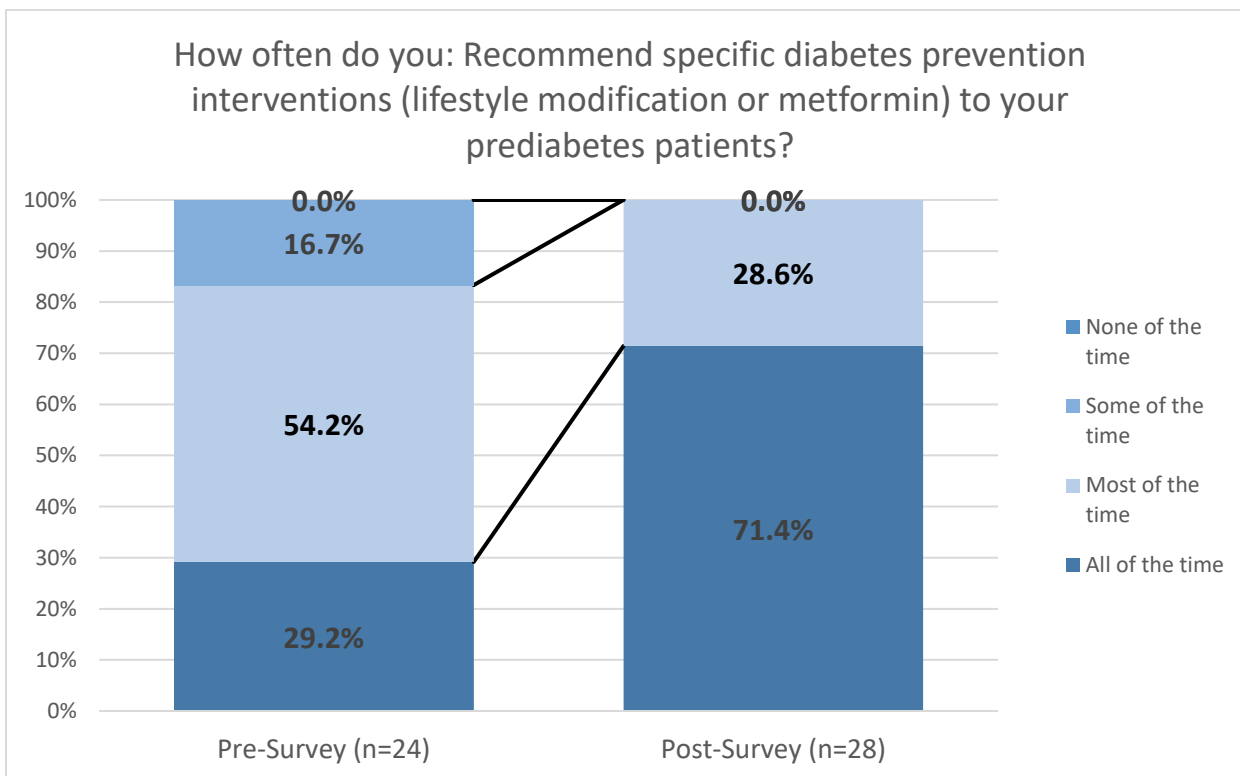
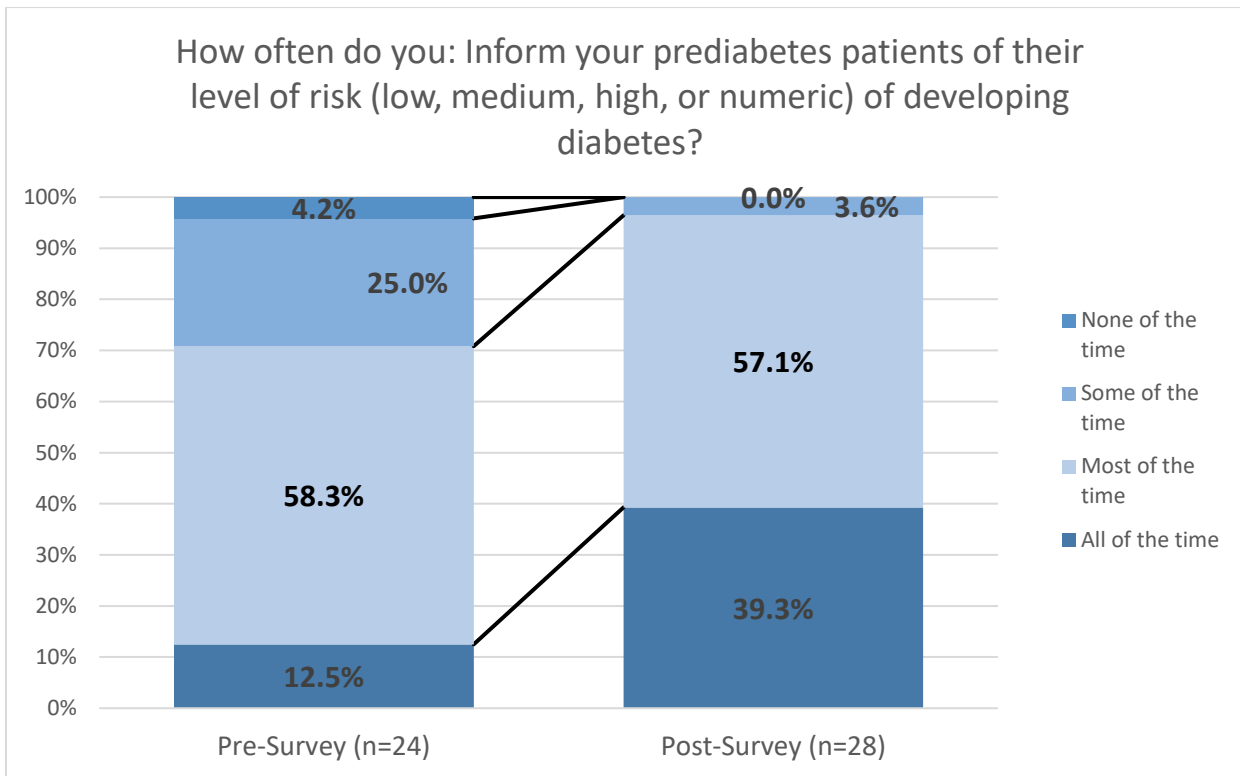


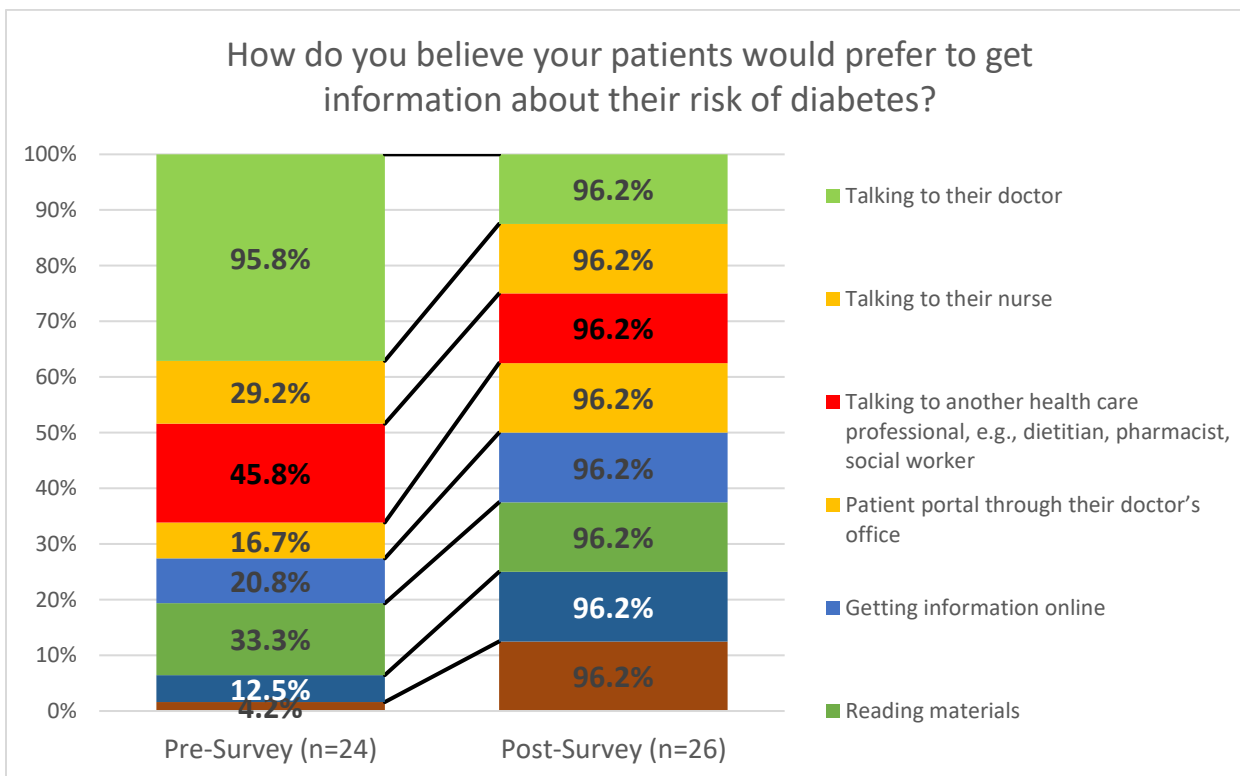
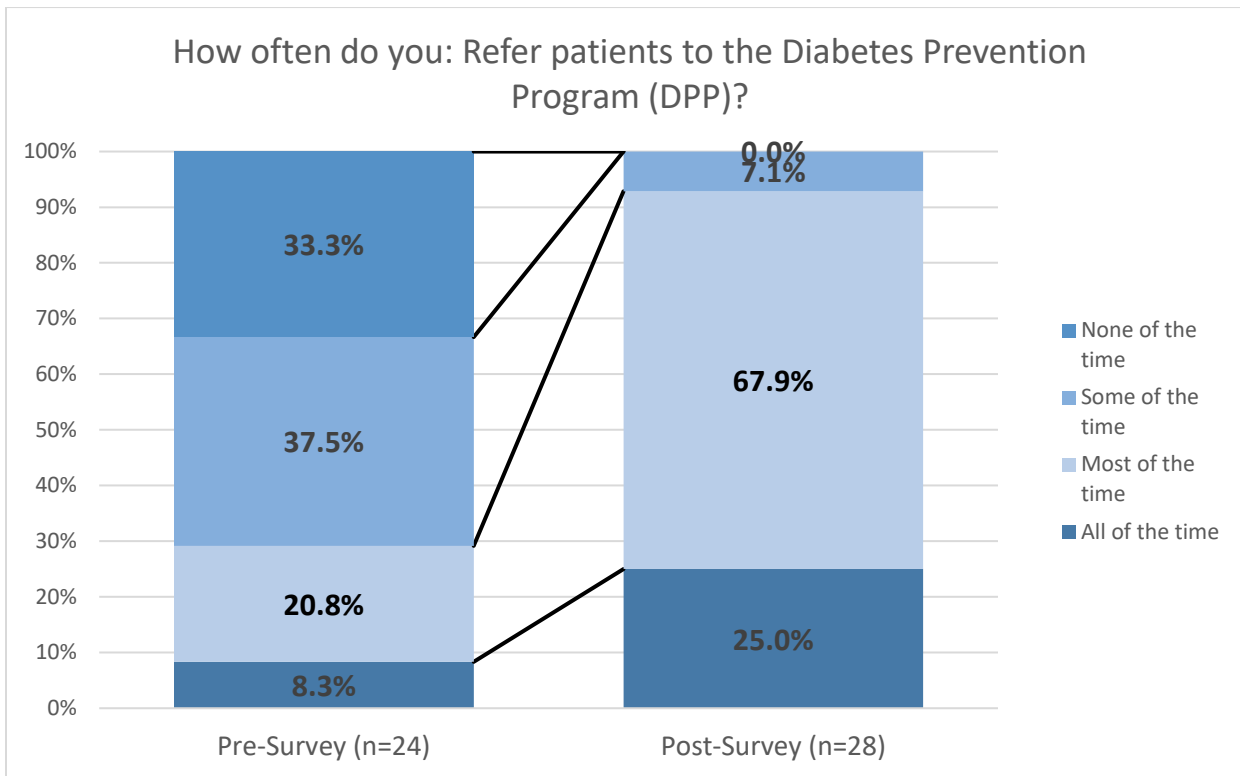
How confident do you feel about: Directly communicating the degree of benefit a prediabetes patient should anticipate if they attend a DPP lifestyle modification program or take metformin?
