## 30 ABSTRACT

- **Background:** Hong Kong has one of the longest life expectancies in the world but
- 32 was heavily impacted by COVID-19 in 2022.
- 33 Methods: We constructed sex-specific life tables from 1998-2023 using parametric
- 34 bootstrapping to account for statistical uncertainty in mortality rates. We used
- 35 Arriaga's decomposition method to estimate age-specific contributions to overall
- 36 changes in life expectancy over this period. We also estimated cause-specific
- 37 mortality rates.
- 38 **Results:** Hong Kong reported 50666 deaths in 2020, 51354 in 2021, 63692 in 2022,
- and 54731 in 2023. Estimates of life expectancy in males and females in 2020 and
- 40 2021 were similar to the pre-pandemic trend from 1998-2019 but declined
- 41 significantly in 2022. Life expectancy for males was 82.3 years in 2021 and 80.4
- 42 years in 2022, and for females it was 87.9 in 2021 and 86.4 years in 2022. Compared
- 43 to the pre-pandemic trend, the 2022 values corresponded to reductions by 2.22 (95%
- 44 CI: 2.08, 2.36) years in males and 2.30 (95% CI: 2.17, 2.43) years in females. The
- 45 loss in life expectancy in 2022 was mainly attributed to increased respiratory
- 46 mortality rates in adults aged 65 or above. In 2023 life expectancy increased by 0.60
- 47 (95% CI: 0.46, 0.75) years in males and by 1.10 (95% CI: 0.95, 1.26) years in
- 48 females.
- 49 **Conclusions:** In 2022 a very high respiratory mortality rate in older adults in Hong
- 50 Kong during the COVID-19 pandemic was associated with a reduction in life
- 51 expectancy by more than 2 years. In 2023 life expectancy increased towards the
- 52 pre-pandemic trend.

# 56 INTRODUCTION

57	Life expectancy from birth is a common measure used for international comparisons
58	of population health <sup>1</sup> . With advancement in healthcare resulting from successful
59	economic development, Hong Kong's life expectancy has risen significantly over the
60	decades, making it one of the longest in the world <sup>2</sup> . A decrease in life expectancy was
61	observed in several Asian countries with high life expectancies in 2022 after the
62	spread of Omicron, including Japan <sup>3</sup> and South Korea <sup>4</sup> .
63	
64	Hong Kong used public health and social measures to minimize COVID-19
65	transmission for the first two years of the pandemic <sup>5</sup> , but experienced a major
66	epidemic of Omicron BA.2 in early 2022 resulting in around half of the population
67	being infected and more than 10,000 confirmed COVID-19 deaths among Hong
68	Kong's 7.3 million population <sup>6,7</sup> . The majority of the deaths were observed in older
69	adults $\geq$ 65 years of age <sup>8</sup> . The reported number of COVID-19 deaths might not reveal
70	the full picture of the impact of the pandemic because some confirmed deaths might
71	have occurred with COVID-19 rather than because of COVID-19, while the control
72	measures used to reduce transmission also had a substantial indirect impact which
73	may have affected mortality <sup>9</sup> . The World Health Organization estimated that 14.83
74	million excess deaths occurred in the first two years of the pandemic <sup>10</sup> . The Institute
75	for Health Metrics and Evaluation estimated that global life expectancy decreased by
76	1.6 years from 2019 to 2021 $^{11}$ , which was a dramatic reversal from the slowly
77	increasing trend before 2019.
78	

To explore how the COVID-19 pandemic affected mortality in Hong Kong, a cityhaving a high proportion of older adults, in this study we estimated patterns in

81 mortality rates and the consequent life expectancy changes in Hong Kong during the

#### 84 **METHODS**

#### 85 Sources of data

86 Age-specific weekly deaths from 1998 to 2023 were obtained from the Census and 87 Statistics Department of the Government of the Hong Kong Special Administrative 88 Region. For analysis of cause-specific death rates, we selected 9 major primary causes 89 of death, including malignant neoplasms, cardiovascular, respiratory, kidney diseases, 90 diabetes mellitus, chronic liver disease, dementia, septicemia, and external causes. A 91 final category, "other causes", included all other deaths. These ten cause of death 92 groupings were coded according to the International Classification of Diseases, Ninth 93 Revision (ICD-9) and Tenth Revision (ICD-10) (Appendix). Almost all deaths in 94 Hong Kong occur in hospital, which facilitates accurate coding. The age-specific 95 mid-year population sizes from 1998 to 2023 were obtained from the Census and Statistics Department and were used as the denominators for the estimation of 96 mortality rates <sup>12</sup>. The population sizes for ages 85 to  $\geq$ 100 years in 1996, 2001, 2006, 97 98 2011, 2016, and 2021 were obtained from the censuses and by-censuses conducted by the Census and Statistics Department<sup>13</sup>. These data were used to estimate the 99 100 population size from age 85 to  $\geq$ 100 years from 1998 to 2023 (Appendix). Our study 101 received ethical approval from the Institutional Review Board of the University of 102 Hong Kong.

# 104 Statistical analysis

105 We constructed life tables for each year from 1998 to 2023 based on local mortality

106	rates by age and sex (Appendix). We used a parametric bootstrap approach assuming
107	that age- and sex-specific mortality rates followed Poisson distributions, allowing us to
108	construct uncertainty intervals for the estimated life expectancy. We used simple linear
109	regression models to fit the change in life expectancy between 1998 and 2019 and
110	extrapolated this linear fit to the pandemic years.
111	
112	Arriaga's decomposition method was used to investigate the contribution of different
113	age groups to changes in life expectancy in 2020, 2021, and 2022 $^{14}$ . The age-specific
114	contribution consists of both direct and indirect effects taking the preceding year as a
115	reference. However, the last age group only gives a direct contribution, as there is no
116	older age constituting an indirect effect. The sum of effects from all ages and the total
117	change in life expectancy in years should be equal. The change in life expectancy by
118	age was estimated for six age groups: 0-4, 5-14, 15-44, 45-64, 65-79, and $\geq$ 80 years.
119	We did not conduct this decomposition analysis for 2023 versus 2022 because the very
120	high mortality rates in 2022 would affect the comparison. All statistical analyses were
121	conducted in R version 4.3.3 (R Foundation for Statistical Computing, Vienna,
122	Austria).
123	
124	RESULTS
125	Figure 1 shows the all-cause mortality rates from 1998 to 2023 for males and females
126	in six age groups. From 1998 through to 2021 the age-specific mortality rates
127	generally declined over time for both males and females. The mortality rates increased
128	substantially in 2022 in all age groups except in 5-14 years. In particular, the

- estimated mortality rates among males and females  $\geq$ 80 years increased dramatically
- 130 from 2021 to 2022. For males, mortality rates increased from 8120 per 100,000 in

131	2021 to 10800 per 100,000 in 2022, and for females it increased from 6590 per
132	100,000 in 2021 to 8340 per 100,000 in 2022. The long-term decreases in mortality
133	rates over the study period resulted in a steady increase in the life expectancy of both
134	sexes, from 77.3 in 1998 to 82.3 in 2021 for males, and from 83.1 in 1998 to 87.9 in
135	2021 for females in Figure 2. In 2022, life expectancy declined to 80.4 years in males
136	and 86.4 years in females. Using linear regression models, we projected the trend in
137	life expectancy from 1998 through 2019 into the three pandemic years, shown as
138	dotted lines in Figure 2. Compared to those secular trends in males and females, life
139	expectancy decreased slightly in 2020 and 2021 in females while it remained similar
140	to the projected trend in males in those two years. Life expectancy then declined very
141	substantially in 2022 by 2.22 (95% confidence interval, CI: 2.08, 2.36) years in males
142	and by 2.30 (95% CI: 2.17, 2.43) years in females, compared to the extrapolated value
143	from the slowly increasing trend from 1998-2019.
144	
145	In 2023, life expectancy rose in males and females back towards the pre-pandemic

146 trend, increasing by 0.60 (95% CI: 0.46, 0.75) years in males and by 1.10 (95% CI:

147 0.95, 1.26) years in females. The life expectancy estimates of 82.2 (95% CI: 82.1,

148 82.3 years in males and 87.8 (95% CI: 87.6, 87.9) years in females were still lower
149 than the pre-pandemic trend which under our simple linear extrapolation would have
150 corresponded to life expectancies of 82.8 years in males and 88.9 years in females in
151 2023 (Figure 2).

152

In our decomposition analysis by age group, the statistically significant reduction in female life expectancy from 2021 to 2022 was largely attributed to the increase in mortality rate among females aged 80 years or above, followed by those aged 65-79

156	years (Figure 3). Similarly, the decrease in male life expectancy from 2021 to 2022
157	was also attributed to increased mortality rates in males aged $\geq 80$ years, followed by
158	those 65-79 years.
159	
160	Figure 4 shows the mortality rates by cause and by sex from 1998-2023. The largest
161	increase in 2022 was observed in mortality from respiratory causes, and smaller
162	increases in mortality rates were observed in 2022 in several other cause of death
163	categories, except cancer for males, in 2022. From 1998-2023, most of the
164	cause-specific mortality rate of males were higher than that of females, apart from
165	diabetes, kidney diseases, and septicemia. In 2023, cause-specific mortality rates
166	returned to levels that were comparable to those prior to the COVID-19 pandemic for
167	some causes although respiratory and cardiovascular mortality remained elevated.

169	DISCUSSION

184 2022 has been discussed at length elsewhere, and can be attributed to lower

185 COVID-19 vaccine coverage in older adults and strain on healthcare resources  $^{6,16,17}$ .

186 By early 2022 the vaccination rate among individuals aged 80 years or above was the

lowest among all adult age groups in Hong Kong, with 20.5% of males and 17.1% of

females in this age group receiving at least two doses of SARS-CoV-2 vaccination at

the beginning of 2022, compared to over 80% for adults  $\geq 18$  years overall <sup>5,18,19</sup>.

190 SARS-CoV-2 Omicron BA.2 infections spread explosively in early 2022, causing

191 severe strain on healthcare resources leading to a three-fold increase in case fatality

rates at the peak of the epidemic in March compared to earlier or later in that

193 epidemic <sup>16</sup>. The loss of slightly more than two years of life expectancy in both males

and females during the COVID-19 pandemic in Hong Kong implies there were a

195 substantial number of years of life lost.

197 Life expectancy is calculated from a life table where the observed age-specific

198 mortality rates are applied to a standard population of one million births, as if the

age-specific mortality rates would apply to that cohort as they progress through life.

200 This allows a somewhat standardized comparison of age-specific mortality rates

among population with different age structures. In Hong Kong's ageing population

the COVID-19 pandemic caused a very substantial number of deaths in older adults,

- 204 capita rates in the world. Estimating the change in life expectancy enables a form of
- 205 age-adjusted comparison with mortality rates in other locations.
- 206

207	Prior to the COVID-19 pandemic, global life expectancy increased from 62 years in
208	1980 to 72 years in 2015 <sup>11</sup> . Hong Kong has also experienced steady increases in life
209	expectancy over the last 25 years, but the COVID-19 pandemic had a drastic impact
210	on life expectancy in 2022 (Figure 2). COVID-19 likely impacted life expectancy in
211	almost every country, for example the life expectancy of males (females) in the
212	United States decreased significantly by 2.1 (1.5) years in 2020, by a further 0.7 (0.6)
213	years in 2021, and then increased by 1.3 (0.9) years in 2022 to a level still 1.5 (1.2)
214	years below that in 2019 <sup>20</sup> . The United Kingdom reported reductions of life
215	expectancy by 0.1-0.3 years each consecutive year in 2020, 2021 and 2022 $^{21}$ .
216	Locations with high COVID-19 mortality rates in 2020 and 2021 would tend to have
217	reductions in estimated life expectancy in those years. In contrast, Hong Kong along
218	with several other locations in the Asia-Pacific region was able to minimize
219	COVID-19 mortality until 2022 $^5$ and did not have substantial changes in life
220	expectancy until 2022. Similar to Hong Kong, South Korea had slight increases in life
221	expectancy in 2020 and 2021 but then had a reduction in life expectancy by 0.7 years
222	in males and 1.0 years in females in 2022 <sup>22</sup> . Singapore reported almost no change in
223	life expectancy in 2020, reductions by 0.4 and 0.5 years in males and females in 2021,
224	and by 0.3 and 0.1 years in 2022 respectively <sup>23</sup> . Australia and New Zealand reported
225	almost no change in life expectancy over the period 2020-22 <sup>24,25</sup> .
226	
227	There are several limitations to discuss. First, we were not able to obtain mid-year

229	the distribution of population in this range (Appendix). Second, Arriaga's
230	decomposition method is a common approach to assess changes in life expectancy but
231	it is limited to decomposing the discrete changes such as changes from one year to the
232	next. In Arriaga's decomposition method, the timing of changes within the time
233	intervals is not captured, and the effects are averaged over the discrete periods. Third,
234	we were not able to separate the direct impact, referring to deaths from COVID-19,
235	and indirect impact, referring to the consequences of intervention policies implemented
236	during the pandemic for example delays in ambulances responding to heart attacks, or
237	increases in underlying medical conditions due to social isolation, change of lifestyles
238	and delay of healthcare seeking behaviors, etc. We previously reported an increase in
239	cardiovascular mortality in 2020 likely attributable to changes in healthcare seeking
240	behaviors <sup>9</sup> . In a future study it would be of interest to separate the direct and indirect
241	effects of the pandemic by including more covariates, including the effectiveness of
242	the intervention policies, the long-term health impacts resulting from SARS-CoV-2
243	infections, and changes in access to and utilization of medical services.
244	
245	In conclusion, we estimated a substantial decrease in life expectancy in males and
246	females in 2022, associated with substantial increases in all-cause mortality rates
247	particularly in males and females aged 80 years or above, followed by those aged 65
248	to 79 years, when a substantial drop in life expectancy occurred compared to the

249 gradually increasing trend in the pre-pandemic years. Life expectancy increased

somewhat in 2023 although it did not return to the pre-pandemic trend.


