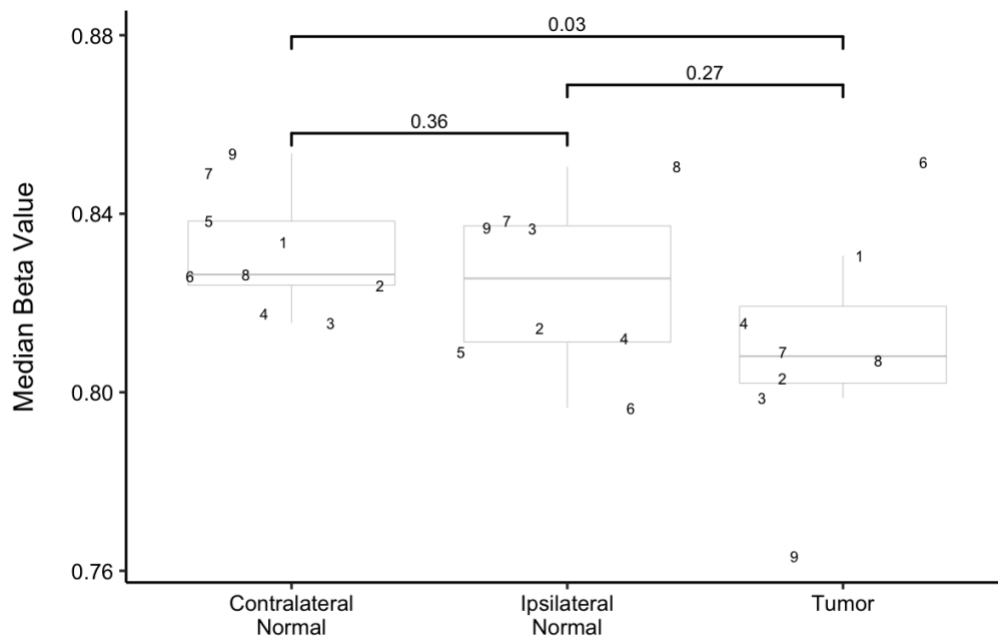


A Median methylation of *Alu* repetitive elements by tissue type



B Median methylation of *LINE-1* repetitive elements by tissue type

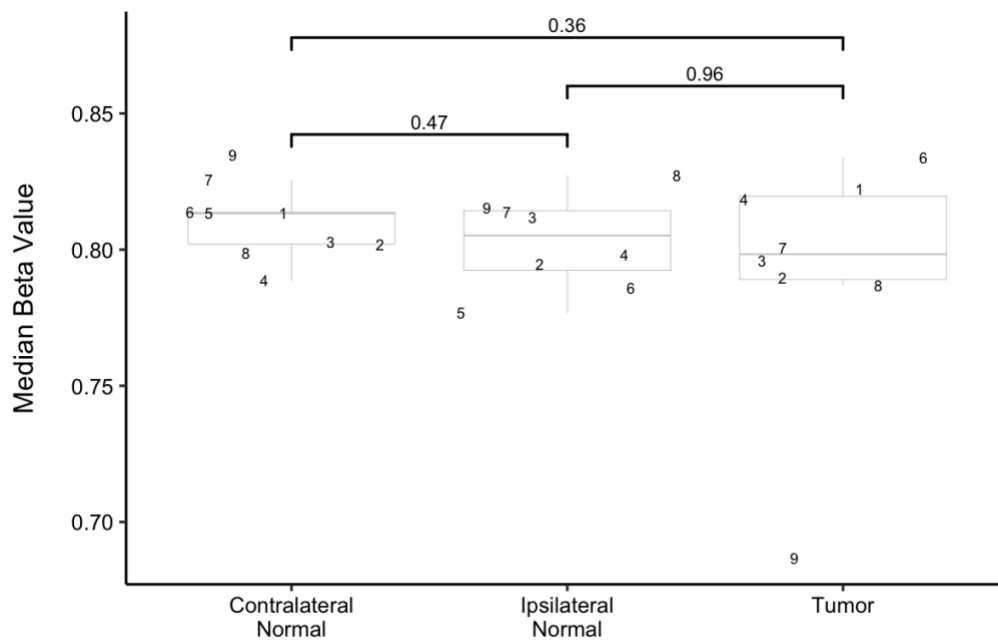


Figure S1 Distribution of the median predicted beta values for each subject by tissue type for (A) *Alu* and (B) *LINE-1* repetitive elements respectively. The number of each point reflects the subject from which the tissue was collected (corresponding to the subject numbers in Table 1). P values reflect the results of a Wilcoxon rank-sum test between each tissue type.

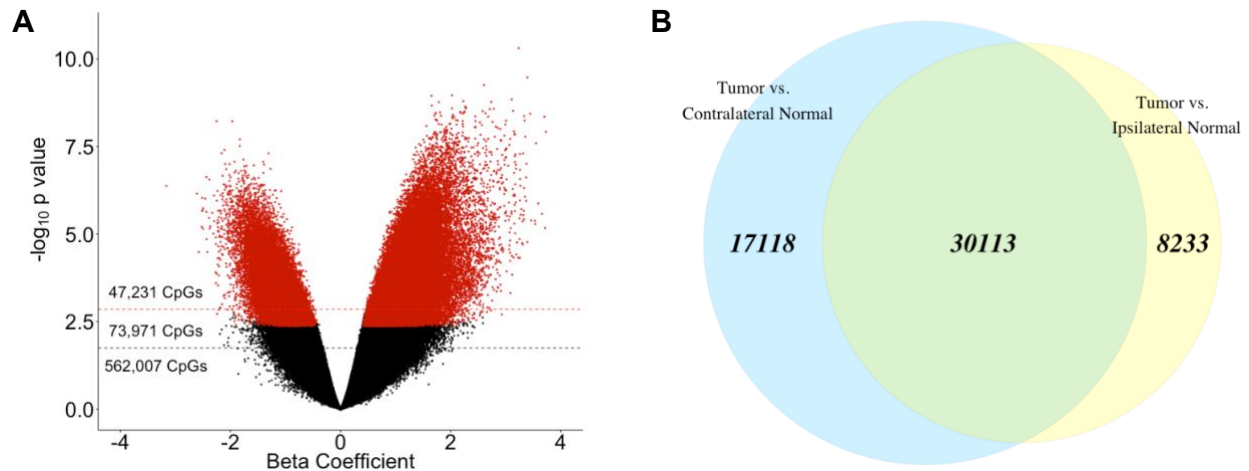


Figure S2 Sensitivity analysis of epigenome wide analysis restricting to contralateral normal samples ($n = 8$) with matched ipsilateral normal samples. (A) Change in methylation M-value for each CpG locus in tumor relative to contralateral-normal tissue. The red dashed line indicates a significance threshold of $q < 0.01$ and the black dashed line indicates a significance threshold of $q < 0.05$. CpGs are colored (red) by loci that were identified as significant in the tumor versus contralateral-normal tissue ($q < 0.01$) analysis including all available samples. (B) Overlap (green) between significantly differentially methylated CpG loci ($q < 0.01$) in tumor versus contralateral-normal and tumor versus ipsilateral-normal tissue.
