Legends to Supplementary Figures:

Supplementary Figure S1. FPG-sensitive site standard curve. Double stranded oligomers containing different (0-4) 8-oxo-dG residues were digested with FPG enzyme, and qPCR reactions were performed on cut and uncut templates. Values for ΔC_q (C_q cut – C_q uncut) different templates were calculated and used for drawing the standard curve based on the numbers of 8-oxo-dG per kb telomere sequence (y = 0.08 X + 0.423).

Supplementary Figure S2. Correlation between ADI-R total scores and telomeric oxidized bases among autistic subjects. Correlation between ADI-R total scores and telomeric oxidized/FPG-sensitive sites are shown for: (A) autistic children irrespective of gender (squares); (B) autistic male children (triangles); (C) autistic female children (circles); and (D) verbal and (E) nonverbal autistic children. In all plots except for panel a, closed and open symbols represent verbal and nonverbal subjects, respectively. Spearman's correlation coefficient (r_s) values and *P*-values are noted for each graph.

Supplementary Figure S3. Expression stability analysis of the candidate reference genes in the saliva samples from female subjects. In phase I (A-C), the stability of expression for eight candidate genes were tested in four female saliva samples (two with childhood autism and two healthy controls) by geNorm (A) and NormFinder (B) algorithms [2, 3]. The genes examined are ranked (left to right) from the least stable to the most. In phase II (D-F), four genes were taken for further analysis in a total of 13 female saliva samples (seven with childhood autism and six healthy controls). With the inclusion of the clinical group's identifier in the NormFinder analysis, *GAPDH* and *YWHAZ* were ranked as the best stable genes, in agreement with the geNorm ranking. However, based on the pairwise variation (V) analysis by geNorm, neither of the gene combinations were good enough as they all fell above the cut-off point of 0.15 (C and F).
