15 <u>Statistical analyses</u>

16 Estimating the number of imported cases

For each African country r, we denote the daily number of air passengers that arrived from an 17 epicentre country *e* by $v_{e \to r}^{(t)}$ ($t = t_e, t_e + 1, ..., T_{e \to r}$), where t_e refers to the start date of the 18 COVID-19 epidemic in the epicentre country e, and $T_{e \rightarrow r}$ refers to the last day that non-citizens and 19 20 non-residents travelling from country e were allowed to enter country r. Each day the probability that an air passenger travelling from country e to country r was an imported case is denoted by $p_e^{(t)}$, 21 22 which we assume to be dependent on both the origin country e and time t, but independent from the destination country r. Hence, the total number of COVID-19 cases imported from an epicentre 23 24 country *e* to an African country *r* by the time the travel ban came into force (denoted by $M_{e \rightarrow r}$ 25 below) can be expressed as the sum of the following independent binomial random variables (i.e. 26 daily number of infections imported from *e* to *r*):

$$M_{e \to r} = \sum_{t=t_e}^{T_{e \to r}} M_{e \to r}^{(t)}$$

$$M_{e \to r}^{(t)} \sim Bin\left(v_{e \to r}^{(t)}, p_{e}^{(t)}\right)$$

Given that in most cases the daily number of air travellers $v_{e \to r}^{(t)}$ before the travel ban came into force was reasonably large (≥ 20), the random variable $M_{e \to r}$ can be approximated using a Poisson distribution:

$$M_{e \to r} \sim Po\left(\sum_{t=t_e}^{T_{e \to r}} v_{e \to r}^{(t)} \cdot p_e^{(t)}\right).$$

33 We used the imported COVID-19 case data reported by Singapore as well as flight data to provide a 34 conservative estimate for $M_{e \rightarrow r}$, under the assumption that Singapore, being one of the countries 35 with the highest surveillance capacity¹, has detected all the imported cases. Owing to the delay from 36 infection to hospital admission, we considered all cases imported from country e to Singapore that 37 were *reported* by date $(T_{e \rightarrow r} + 9)$ (hereinafter denoted as $SG_{e,r}$) based on Linton et al.'s estimated 38 mean incubation period and time from illness onset to hospital admission². We assumed that the 39 ratio between the daily number of air travellers from epicentre e to country r and to Singapore 40 remained stable in the presence of the changes in flight pattern in response to the COVID-19 41 pandemic. Hence, the ratio between the expected numbers of cases imported from epicentre e to 42 African country *r* and to Singapore can be derived using the March 2017 flight data:

$$\frac{\mathbb{E}[M_{e \to r}]}{\mathbb{E}[SG_{e,r}]} = \frac{\sum_{t=t_e}^{T_{e \to r}} v_{e \to r}^{(t)} \cdot p_e^{(t)}}{\sum_{t=t_e}^{T_{e \to r}} v_{e \to SG}^{(t)} \cdot p_e^{(t)}} = \frac{\sum_{t \text{ in Mar } 17} v_{e \to r}^{(t)}}{\sum_{t \text{ in Mar } 17} v_{e \to SG}^{(t)}}$$

This allows us to model $M_{e \to r}$ (and $SG_{e,r}$) as Poisson random variables with mean parameters proportional to the numbers of air passengers travelling from epicentre e to country r (and to Singapore) using the March 2017 flight data:

$$M_{e \to r} \sim Po\left(\beta_{e,r} \cdot \sum_{t \text{ in Mar } 17} v_{e \to r}^{(t)}\right),$$

$$SG_{e,r} \sim Po\left(\beta_{e,r} \cdot \sum_{t \text{ in Mar } 17} v_{e \to SG}^{(t)}\right).$$

Here, $\beta_{e,r}$ refers to the proportionality constant to be estimated using the reported value of $SG_{e,r}$ and flight data, and was assigned a uniform prior with support (0, 1). We performed Markov Chain Monte Carlo to sample from the posterior distribution of $\beta_{e,r}$ using the JAGS software³, with 20,000 iterations burn-in and 150,000 iterations thinned for a posterior sample of size 5,000. The posterior sample for all the model parameters was then used to estimate the uncertainty distribution of the total number of COVID-19 cases imported from the 12 major epicentres to each country.

In March 2020, a spike in the number of cases imported from United Kingdom and United States was observed in Singapore, which was partly due to the increase in the number of returning Singaporean students studying overseas⁴. This change in flight patterns, however, may not be applicable to all African countries. Therefore, to be even more conservative, we also derived the imported case count estimates excluding United Kingdom and United States from the 12 epicentre countries previously considered. The resulting estimates were subsequently used in the simulations of the onward spread of SARS-CoV-2 to get our estimates of case numbers over time.

62 Simulating the onward transmission following importation

63 We performed 1,000 simulations drawing from our estimated distribution of the number of

64 imported cases to project the onward spread of SARS-CoV-2 in each country up to 31st May 2020 or

the date when we estimate 10,000 infections was reached, whichever was earlier. The time of

- infection for the cases imported from country e to country r was simulated via resampling from the
- 67 reporting dates of the $SG_{e,r}$ cases, which was then shifted backwards by 9 days to account for the
- 68 delay from infection to hospital admission based on Linton et al.'s estimates². To account for the
- 69 effect of quarantine measures on the onward transmission, we only included the estimated
- 70 imported cases who had acquired the infection prior to the mandatory quarantine of travellers
- 71 coming into force, so that the estimation of local SARS-CoV-2 spread is conservative. Hence,
- following Cori et al.⁵, in each simulation *s*, the total infectiousness of the infected individuals in a

73 country *r* on day *t* (denoted by $I_r^{(t)}[s]$) can be expressed as the weighted sum of the past incident 74 infections (considered up to 14 days prior to *t*):

75
$$\widetilde{I_r^{(t)}[s]} = \sum_{u=1}^{14} \omega_u \cdot I_r^{(t-u)}[s].$$

In the equation above, $I_r^{(t-u)}[s]$ denotes the number of incident infections in country r on day (t - u) generated in simulation s, which included both the number of incident local infections and the *effective* number of imported infections (i.e. after adjusted for the effect of mandatory quarantine measures, if applicable) whose *infection date* was (t - u). The weight parameter ω_u can be derived from the cumulative distribution function of COVID-19's serial interval based on Nishiura et al.'s estimate (denoted by $F(\cdot))^6$:

$$\omega_{u} = \int_{u-1}^{u} F(\tau+1) - F(\tau) \, d\tau$$

83 Following Pearson et al.⁷, we assumed the number of secondary cases produced by each COVID-19 case to follow a negative binomial distribution with mean 2.0 and dispersion parameter 0.58, before 84 85 stay-at-home order came into force. In the presence of stay-at-home order, we created two 86 scenarios for the percentage reduction of the reproduction number: (1) 25% reduction, and (2) 50% 87 reduction. To be conservative, we assumed that the stay-at-home order, once implemented, can be sustained up to the end date of our simulations. Hence, following the algorithm implemented by 88 89 Churcher et al.⁸, in each simulation *s* we generated the number of incident local infections in country r on day t $(A_r^{(t)}[s])$ as follows: 90

$$A_r^{(t)}[s] \sim NB\left(\widetilde{I_r^{(t)}[s]} \cdot 0.58, \left(1 + \frac{R_0_r^{(t)}}{0.58}\right)^{-1}\right)$$

The negative binomial distribution above modelled the number of failures before the $I_r^{(t)}[s] \cdot 0.58^{\text{th}}$ success in a Bernoulli process with a success probability $\left(1 + \frac{R_0 r}{0.58}\right)^{-1}$ for each trial, where $R_0 r^{(t)}$ denotes the instantaneous reproduction number in country r on day t as defined by Cori et al.⁵ Finally, based on the results obtained from the 1,000 simulations, we derived the estimated probability of reaching 10,000 infections by end of March, April, and May respectively for each African country.
