<u>Testing for nonlinear relationships:</u> We test on the presence of a nonlinear relationship between the number of confirmed cases per million inhabitants and latitude. The coefficients of the added quadratic terms are insignificant at the 5% significance level, indicating that higher order polynomials are not adding value to our estimation.

Robust standard errors are used to account for heteroscedasticity.

We also perform robustness test by using robust estimation based on the mm-estimator that is less sensitive to outliers. The coefficient estimate for latitude is slightly higher than in case of the OLS regressions in Table 1, and the parameter estimate of latitude remain significant.
