 $\P$  Blood cultures were obtained in 350 of 706 included patients. Isolated organisms from blood cultures were: staphylococcus aureus (n=7), staphylococcus epidermis (n=5), Corynebacterium (n=5), enterococcus fecalis (n=3), streptococcal species (n=2), and others (n=3). Invasive candidemia was diagnosed in one patient from the non-prisoner group.

Il Superimposed bacterial pneumonia is confirmed with sputum or tracheal aspirate cultures, which were obtained in a total of 109 patients (21 prisoners and 88 non-prisoners). Bacterial pathogens isolated from sputum/tracheal aspirate cultures were: staphylococcus aureus (n= 16), pseudomonas aeruginosa (n= 12), Escherichia coli (n= 3), klebsiella pneumonia (n= 3), streptococcus pneumonia (n=1) and others (n=9). In addition, candidal species grew in obtained cultures in 6 patients.

Provider was contacted immediately for consideration of transfer to the hospital, if any of the following: oxygen saturation on room air (after >1-minute walking/physical activity) <92%, oxygen requirement is now >2 liter/minute above pre Covid-19 baseline, or patient has three (3) or more points on the scoring system at any measurement (unless the three points are based on age alone).

I Transfer from the prisoner facility to the hospital does not necessarily translate into an admission to the hospital but indicates the need for further evaluation by the emergency department at the hospital to further assess eligibility for admission.
