

Integrative Genetics Analysis of Juvenile Idiopathic Arthritis Identifies Novel Loci

Fig. S1. The quantile–quantile (QQ) plot of the hsGWAS of JIA cases vs. the controls.

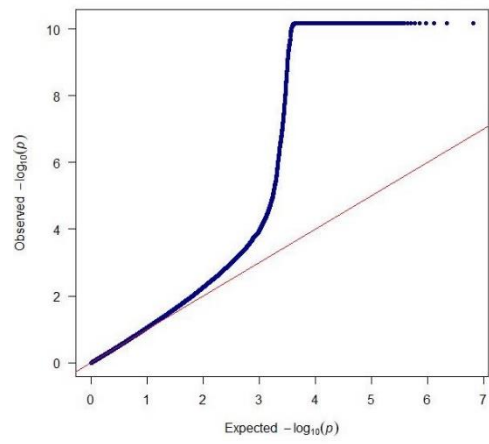


Fig. S2 Regional association plots of genetic loci previously reported to be associated with JIA or other autoimmune diseases.

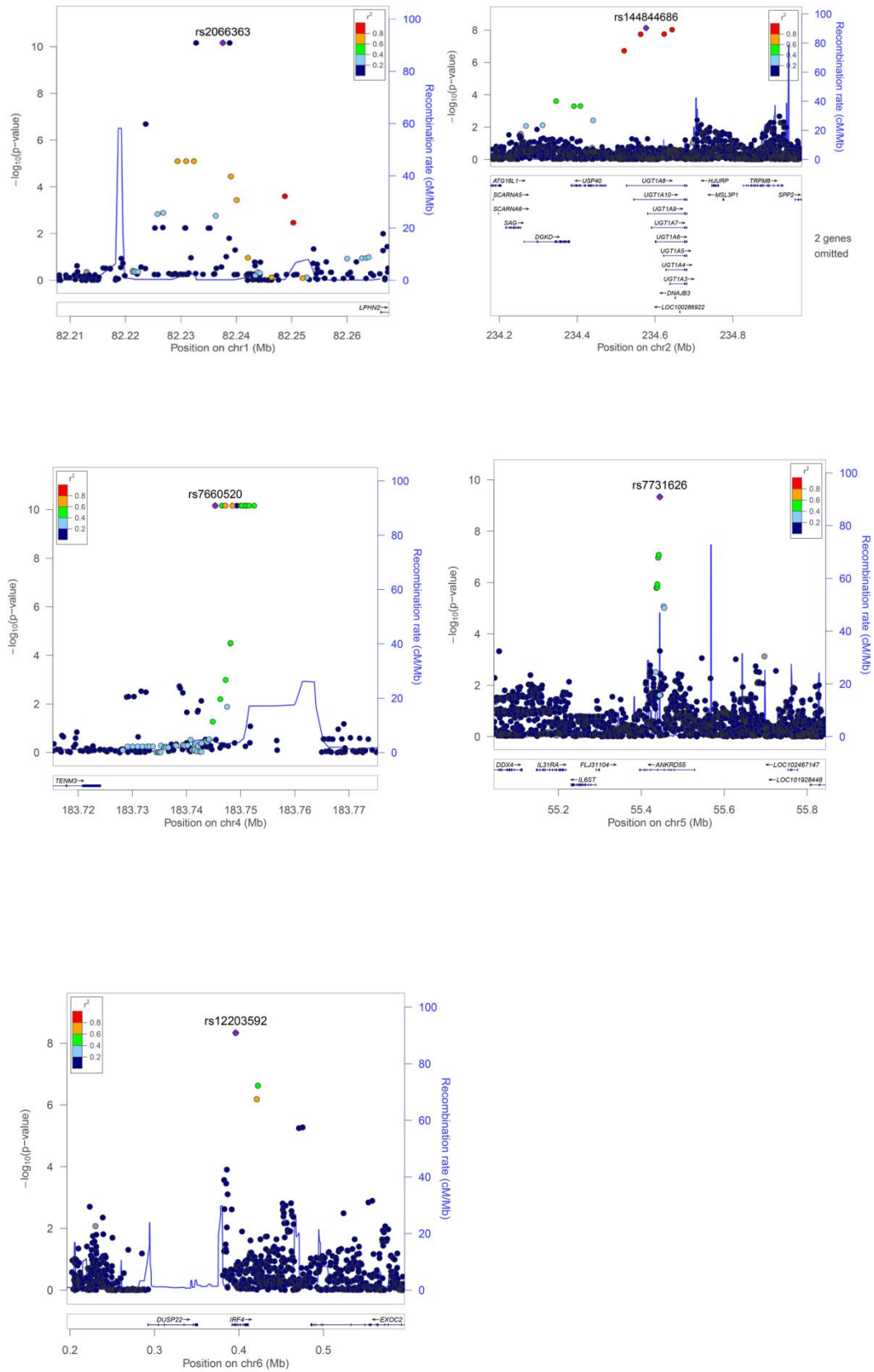


Fig. S3. Heatmap showing the association significance of each genome-wide significant SNP with each individual JIA subtype.

Fig. S5. The violin plot showing the significant correlation between the SNP genotype and the mRNA level of the gene in immune tissues based on GTeX data.

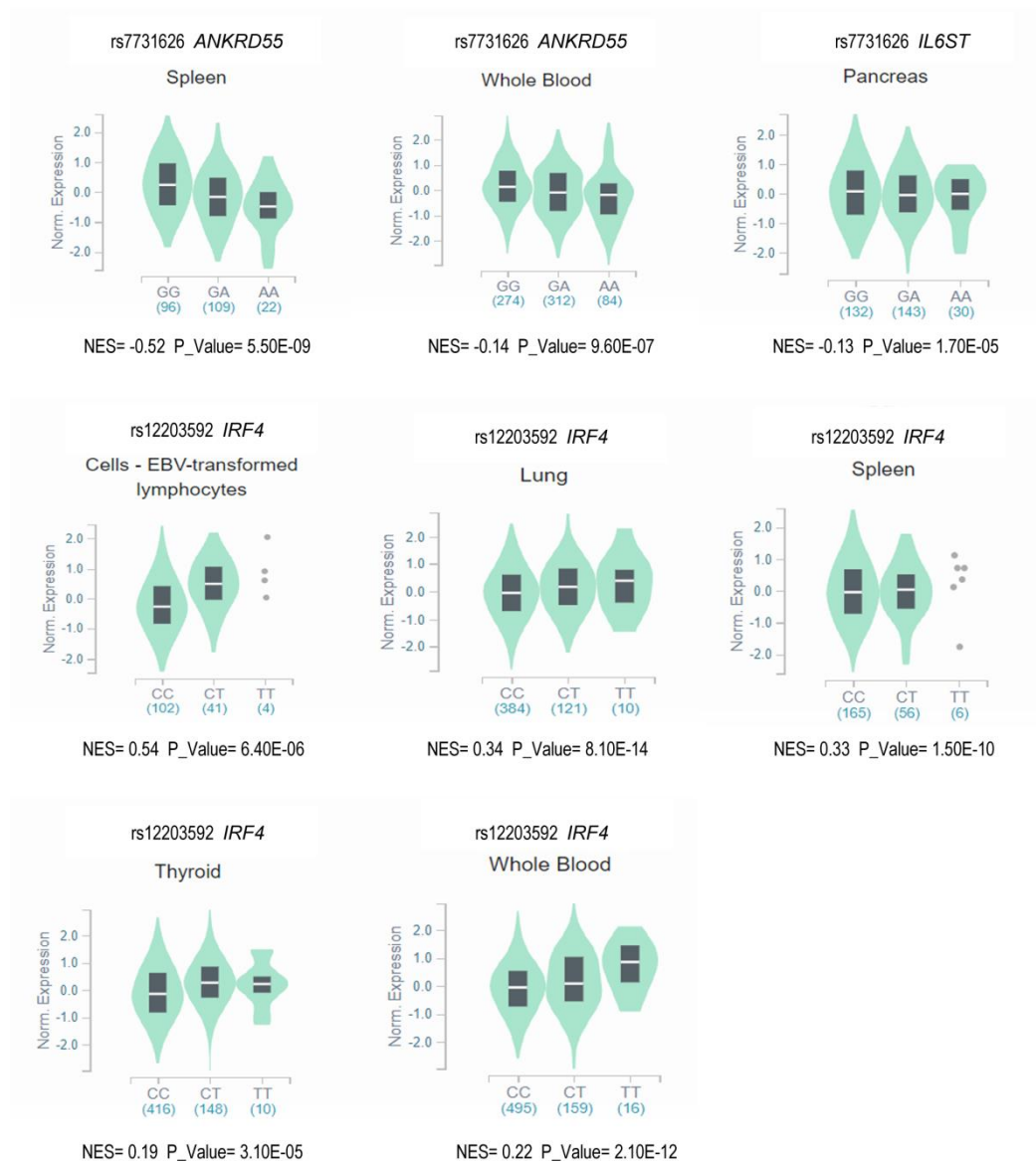
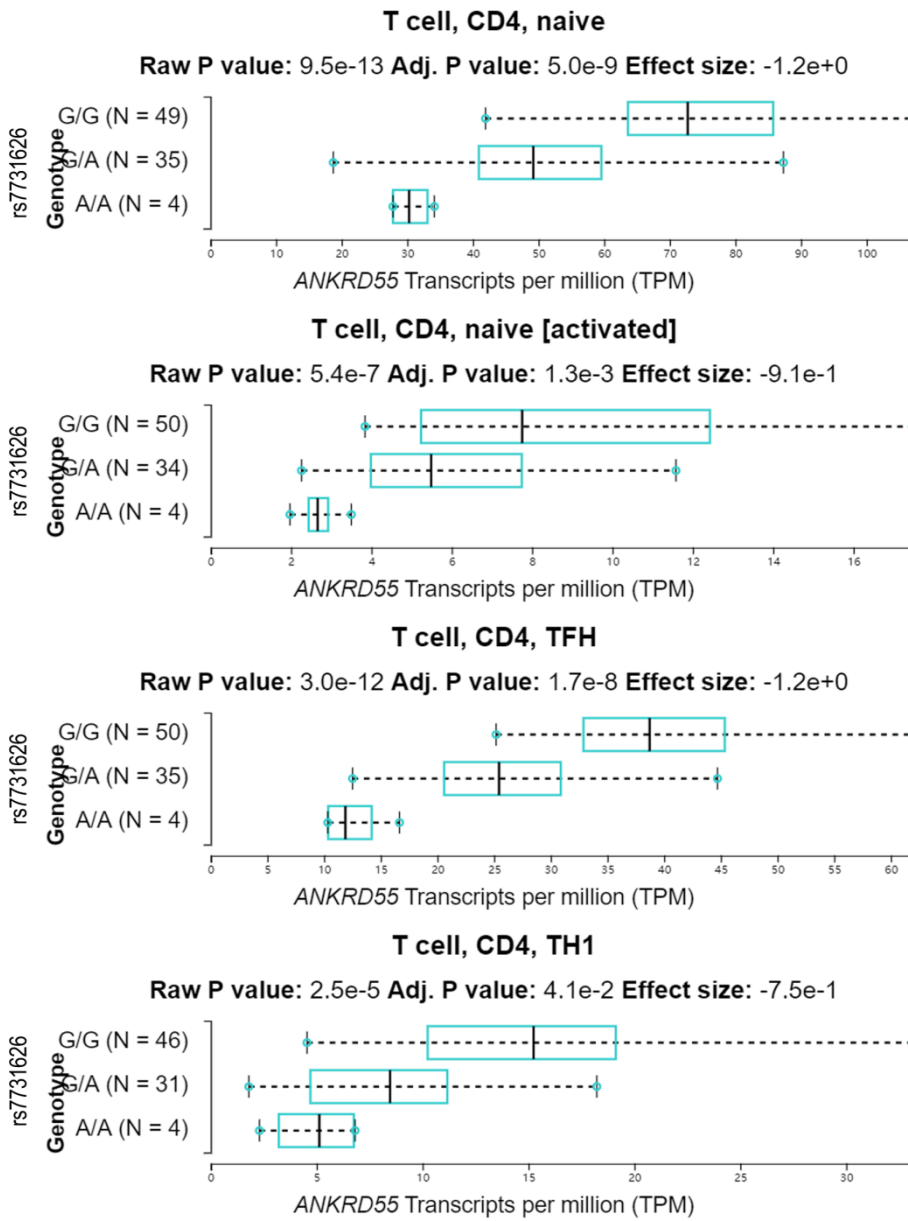
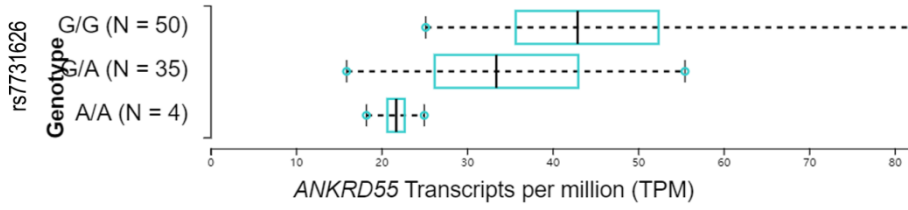


Fig. S6. Box plots showing the significant correlation between the SNP genotype and the mRNA level of the gene in immune cell types based on DICE data.



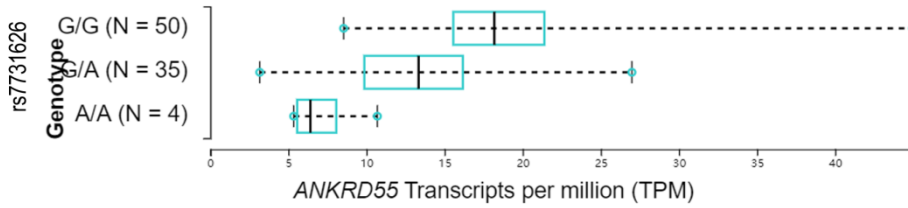

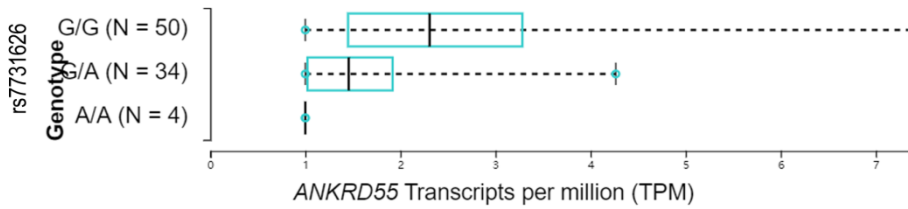

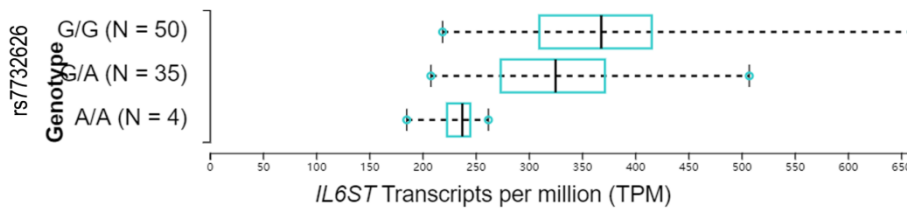

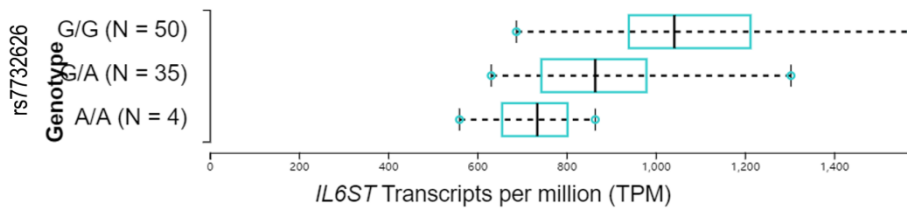
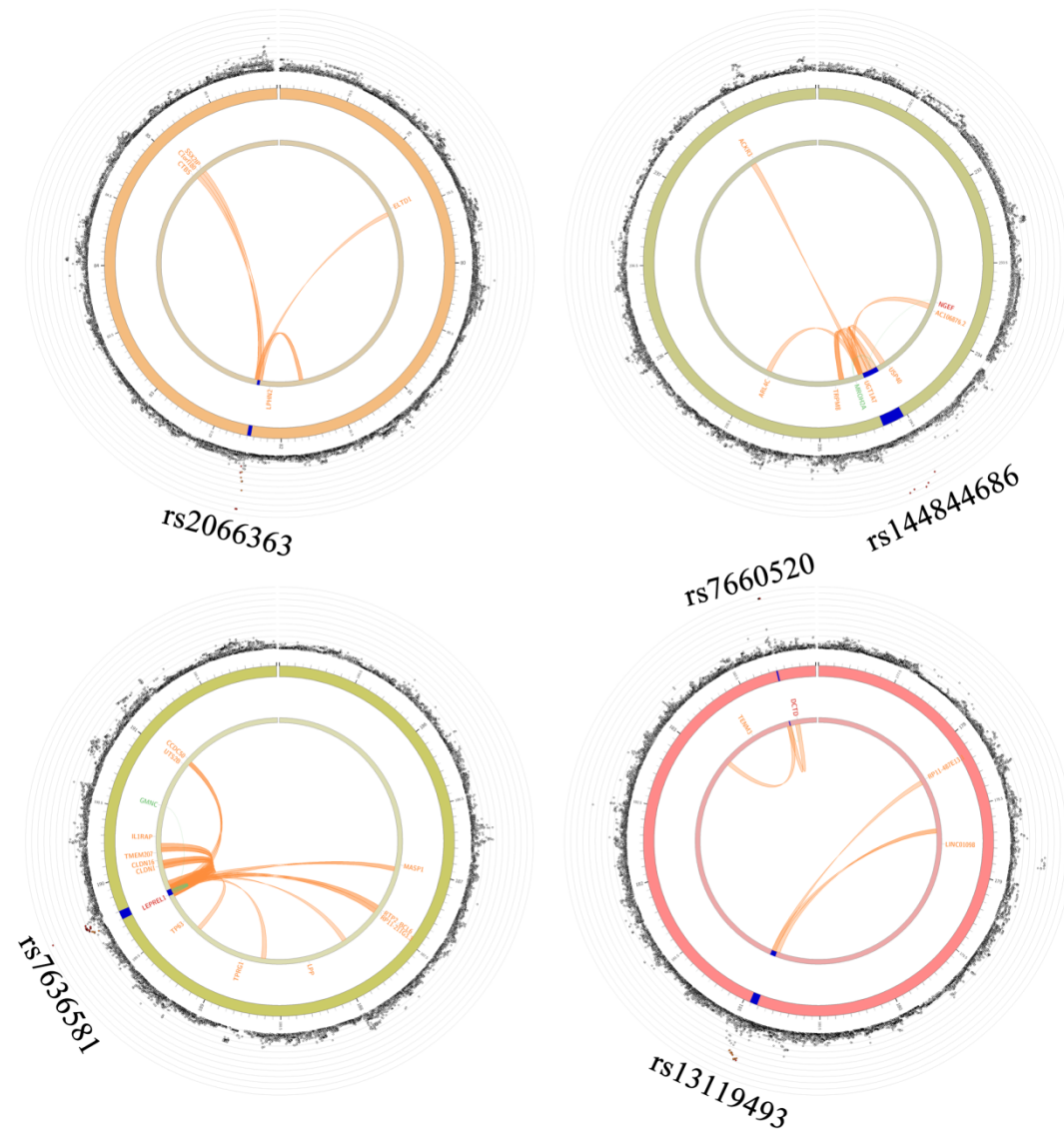
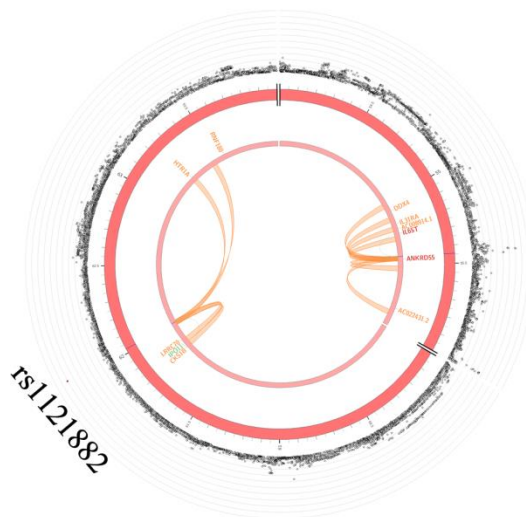
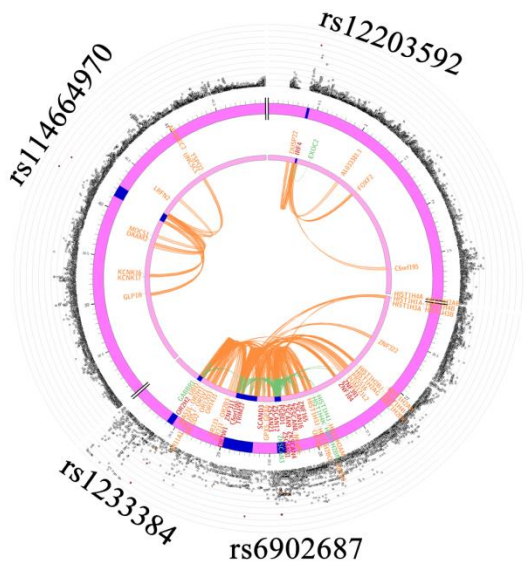


Fig. S7. The circus plots showing the chromatin interactions between each JIA locus and other chromatin regions.





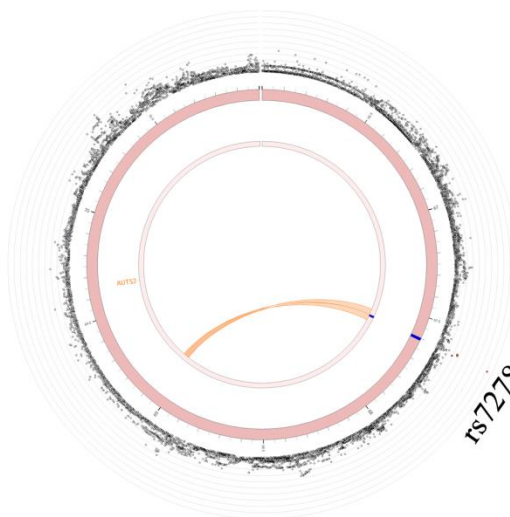

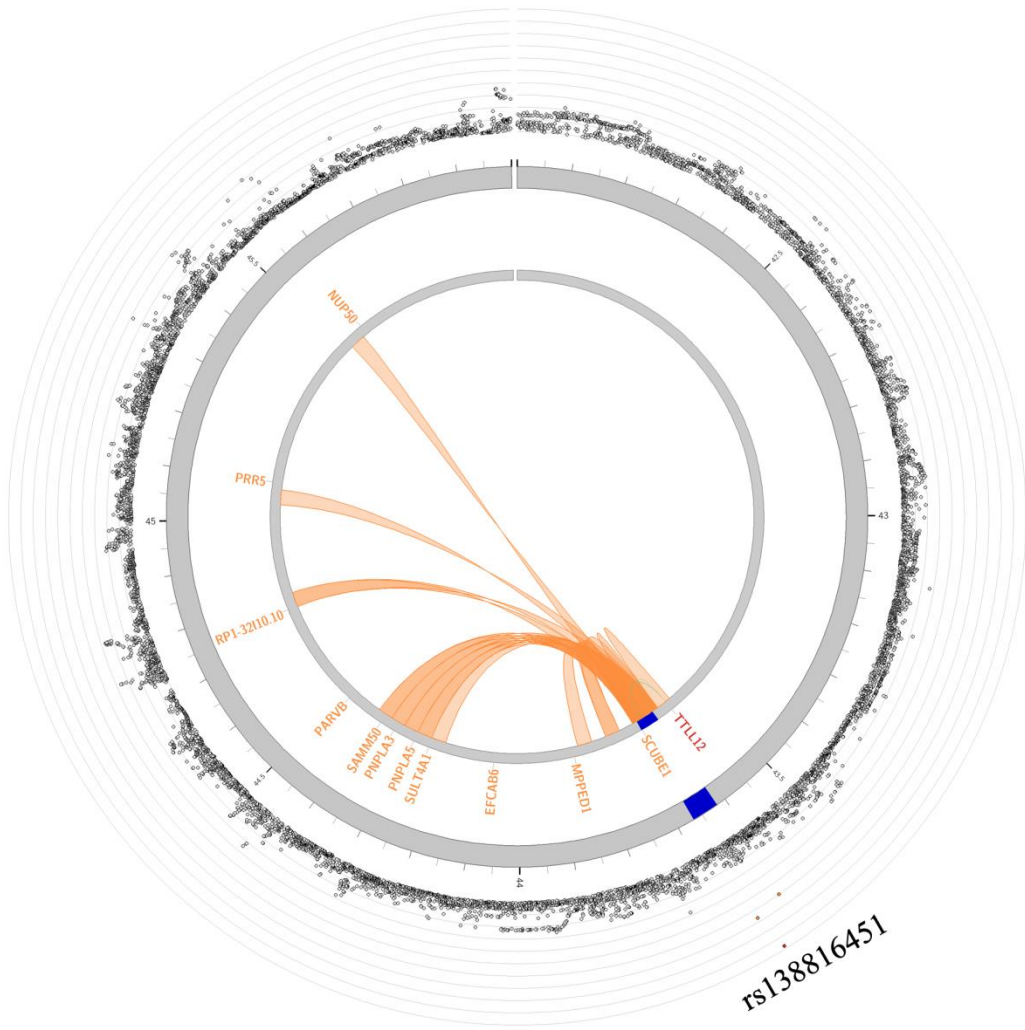
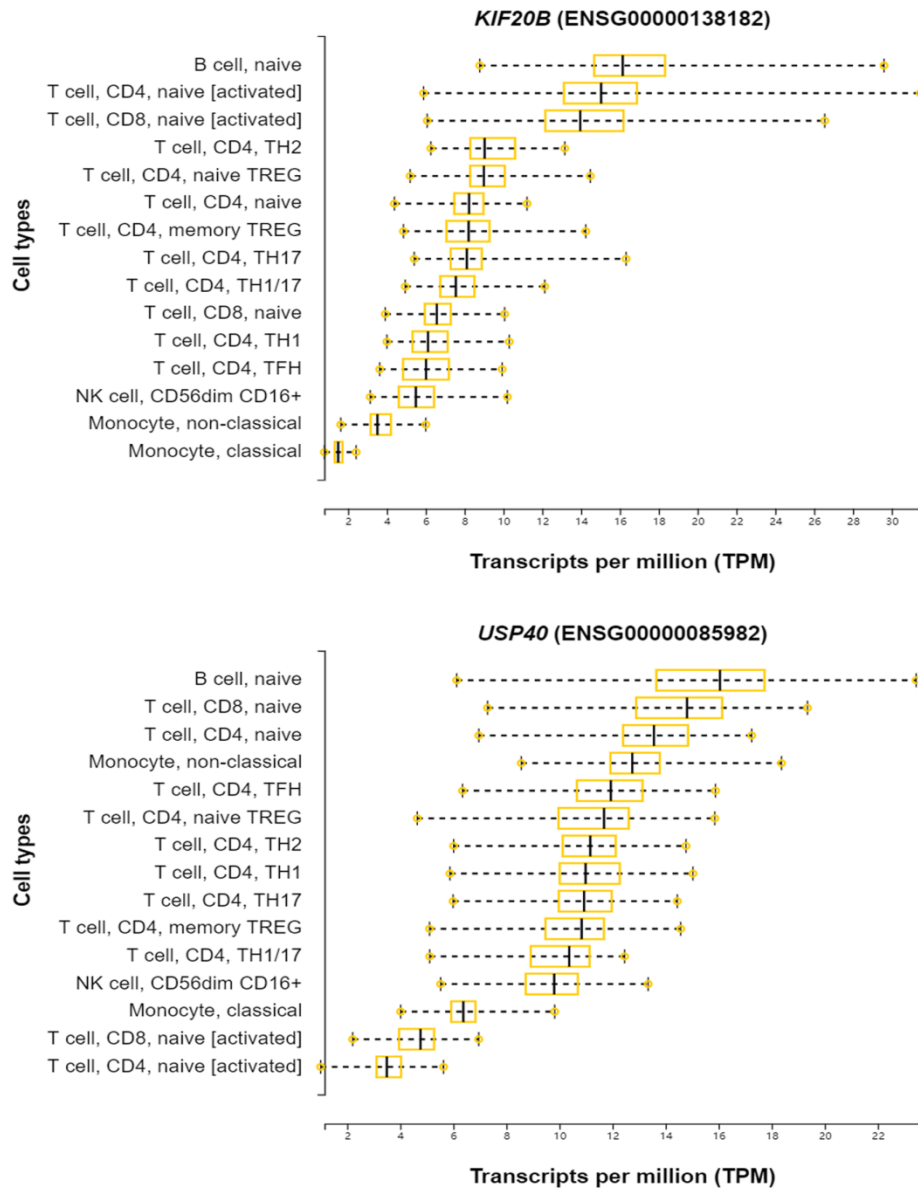
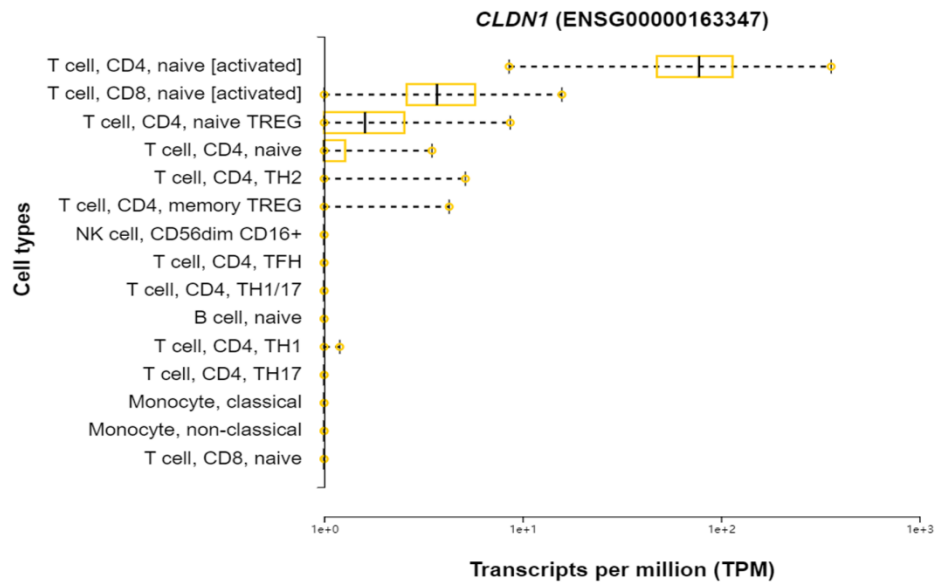
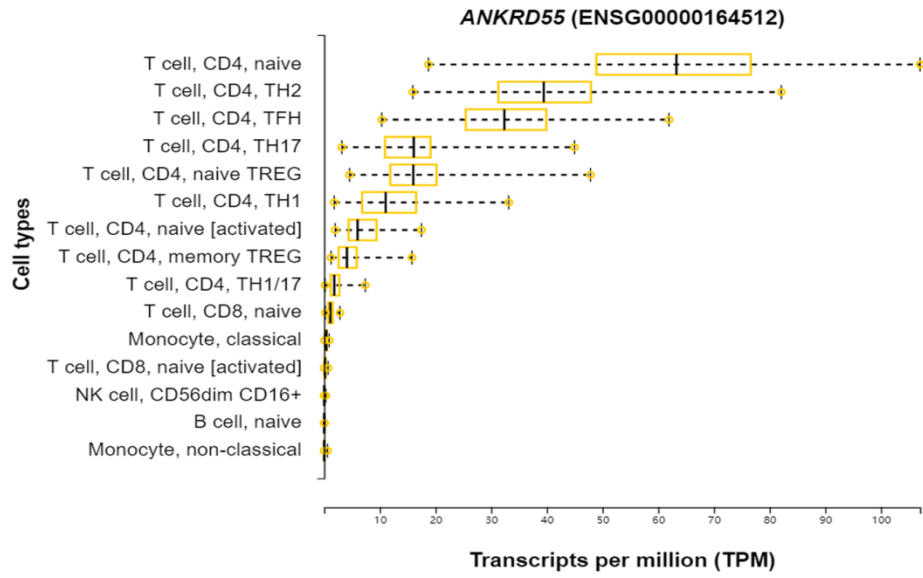
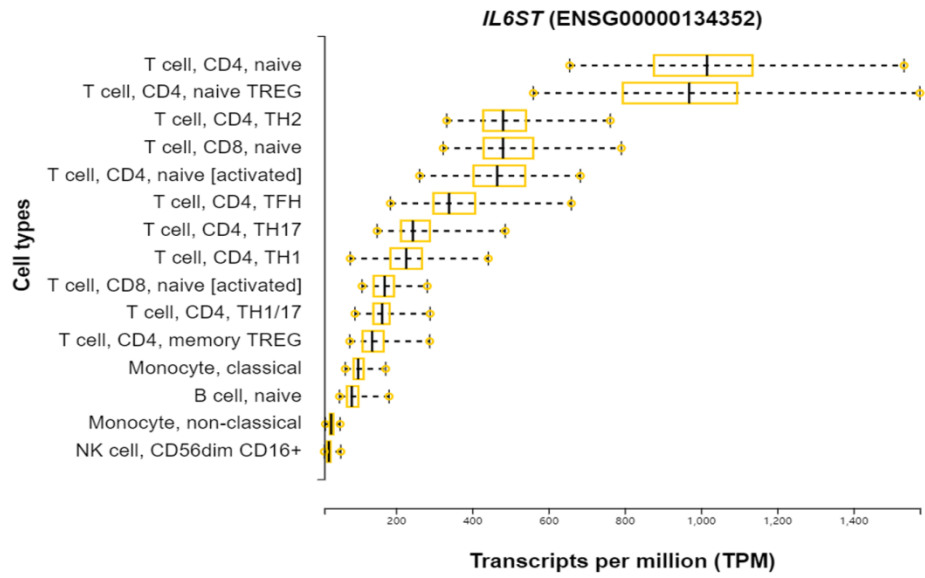
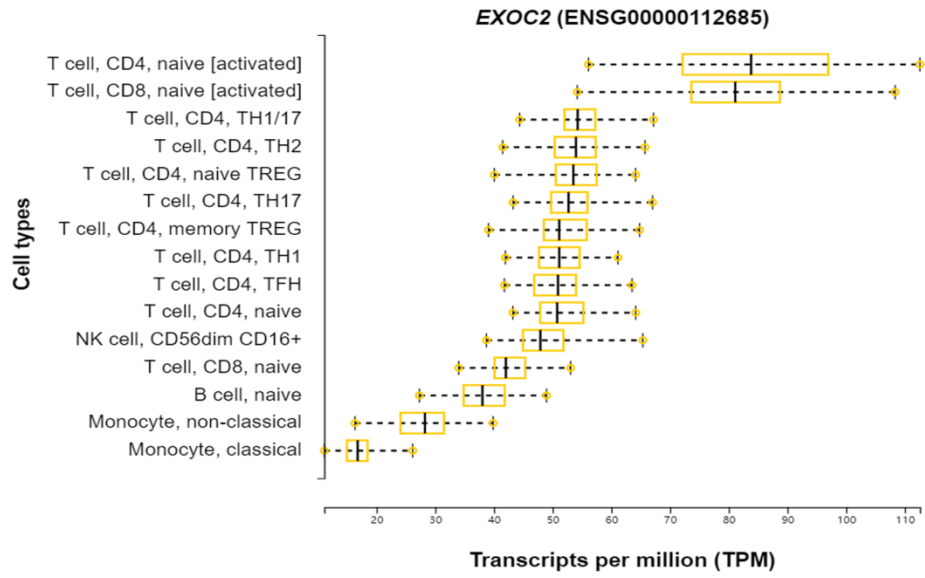
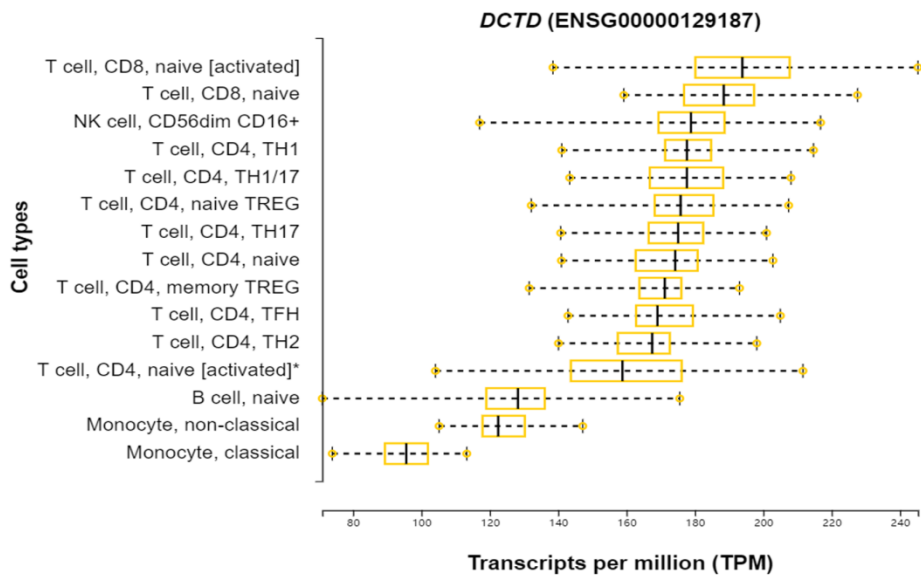
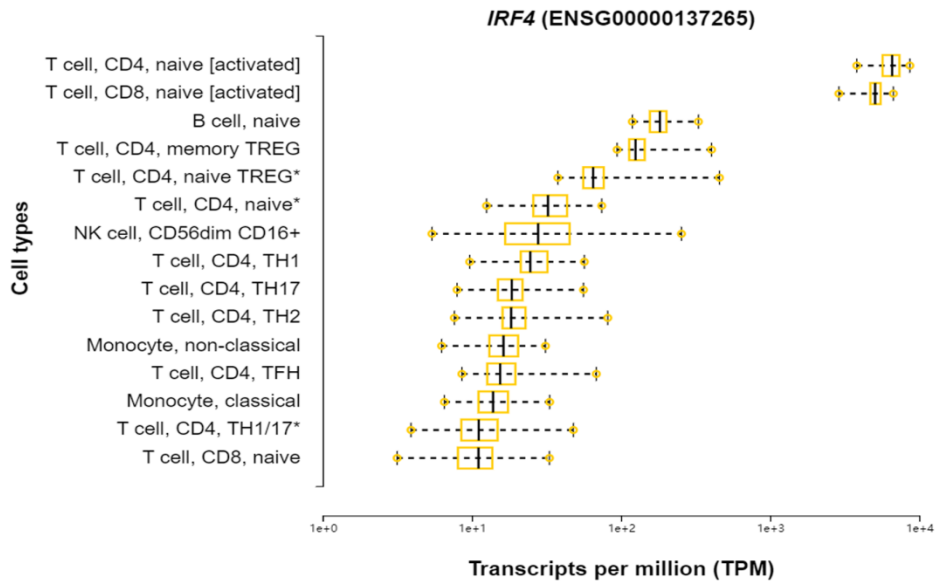


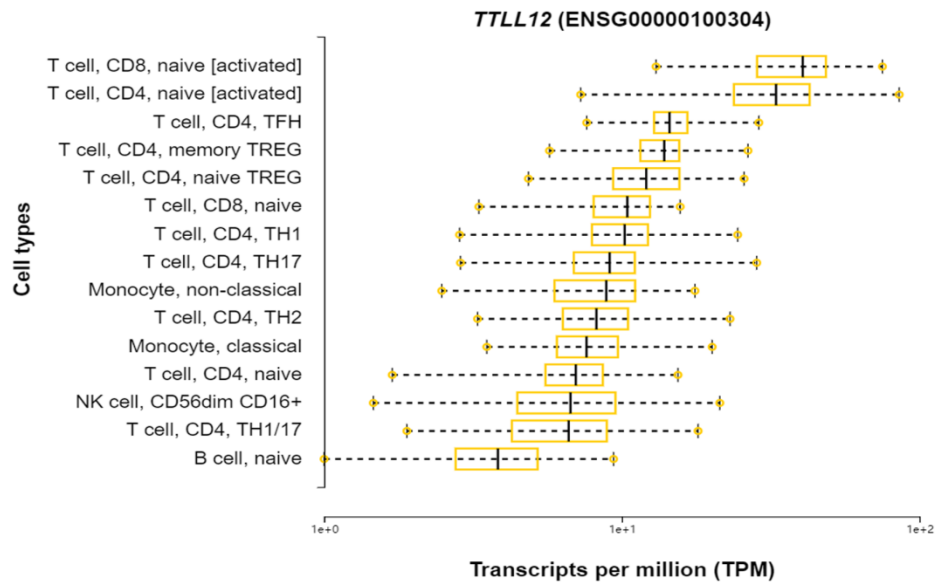
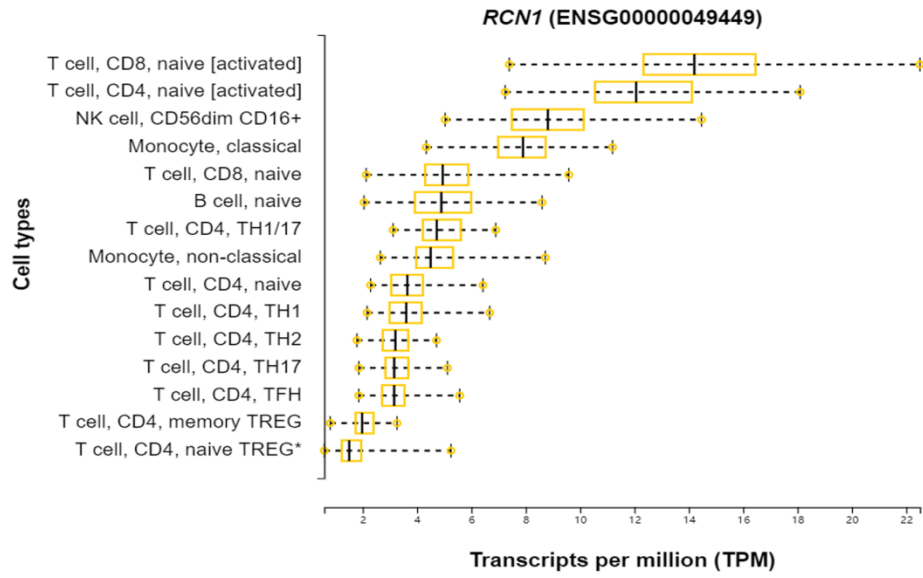
Fig. S8. Candidate genes at genome-wide significant loci are expressed at medium to high level in immune cell types.

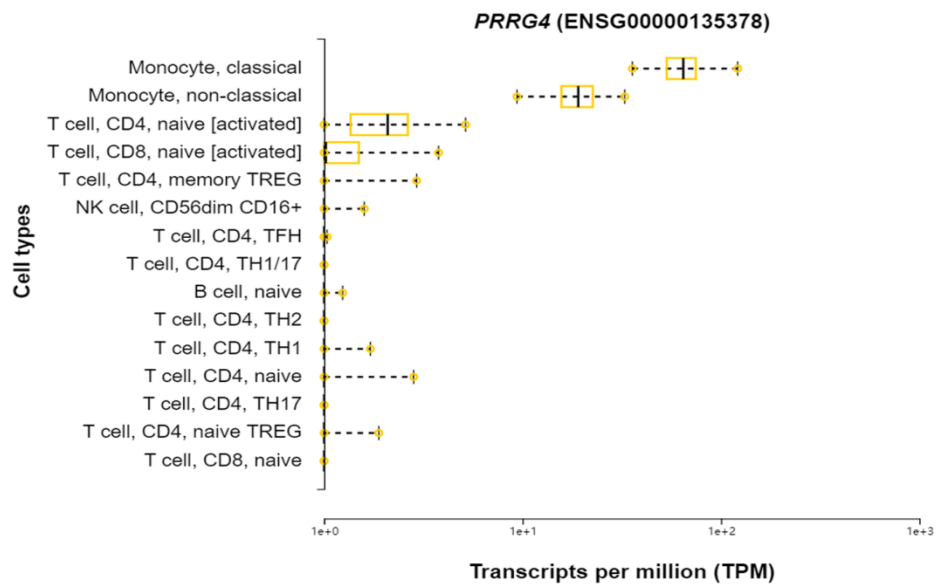
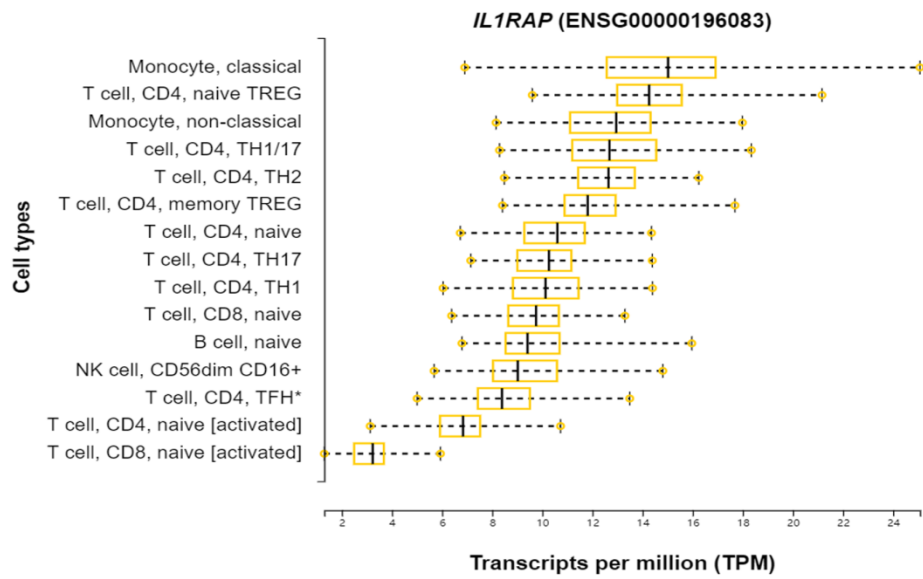












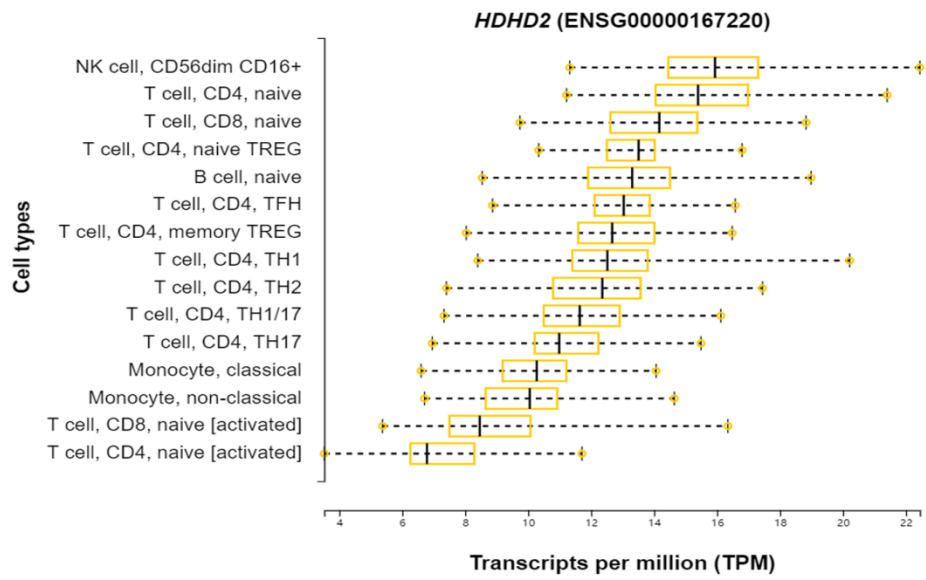
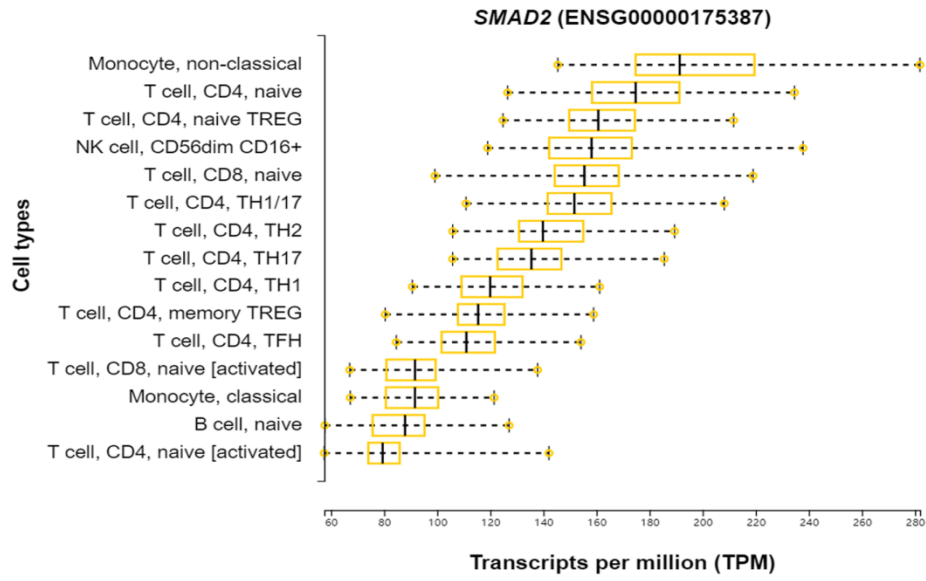


Fig. S9. PPI network constructed based on our JIA hsGWAS results.
