SI Experimental Materials and Methods

Sample Collection and Processing

Sampling crew members were outfitted with personal protective equipment consisting of N95 masks to protect against inhalation exposure. In addition, shower water was directed into a bucket to minimize splashing and aerosolization of the water.

Temperature and pH were measured with a handheld meter, and total chlorine was measured using the U.S. Environmental Protection Agency (EPA) DPD method (10070) and a DR900 colorimeter (Hach Company; Loveland, Colorado). Each hot water flush was initiated 20 min after starting the cold water flush. Flushes began by turning the valve to cold or fully hot, as appropriate. All valves were on/off type without flow-rate controls. Flow rates without shower heads ranged from 3.8 to 29.4 L/min (median 14.3 L/min), which would correspond to turbulent flow (Reynold's number >4000) in common 1/2 inch copper piping and which theoretically would have produced wall shear stresses of 1 to 40 N/m² (median 11.1 N/m²; Table S14). In contrast, a water-efficient shower head might release 9 L/min, giving an estimated shear stress of 4.9 N/m².

Microbiological samples were mixed by gentle inversion, and one to three aliquots (100 mL) were poured into individual graduated vessels with sodium thiosulfate ($Na_2S_2O_3$) for the Legiolert assays. The remaining sample volume was used for DNA extraction via vacuum filtration. After filtration, filter membranes were placed in separate microcentrifuge tubes with lysis buffer (500 µL), subjected to three freeze-thaw cycles and 90 min incubation at 70 °C, and then purified using the FastDNA Spin Kit (MP Biomedicals; Santa Ana, California), as previously detailed.^{S1}

Real-time qPCR

For 16S rRNA genes, sample amplification was differentiated from background amplification using the mean and 99.9 % confidence interval of the negative controls (n = 7). For the other gene targets, any amplification was considered a positive detect—no amplification was observed in negative controls—but the method quantification limit (MQL) was defined as the lowest calibration standard to amplify, normalized by sample volumes. All gene targets amplified at 10 copies/µL, with the exception of *ssrA* (100 copies/µL). Calibration curves are summarized in Table S15.

Data Analysis and Statistics

Neither culturable *Legionella pneumophila* nor *mip* and *wzm* genes were observed, so these were excluded from analysis. Furthermore, building E (St. Paul) was not statistically informative about *Mycobacterium avium* complex (MAC) 16S-23S internal transcribed spacer (ITS) regions (in context of flushing practices), as ITS were never observed in those samples, so the site was excluded from analyses pertaining to the ITS data.

The data contained left-censored observations, so appropriate statistical methods were selected to test experimental null hypotheses (H_0).^{S2,S3} Left-censoring was defined based on either non-significant amplification in contrast to negative controls (16S rRNA genes) or if no amplification was observed (*ssrA*, *atpE*, 16S-23S ITS).

Paired Difference Tests

To determine whether flushing was effective at reducing bacterial biomass in showers, paired gene concentrations were contrasted for all combinations of four different time-points: pre-flush, after 30 min flush, and then during the two subsequent follow-up events (6 contrasts total per gene target). An example null hypothesis is given:

 H_0 : At t = 0 (pre-flush) and t = 30 (after 30 min of flushing), the mean difference of all paired 16S rRNA gene concentrations is zero.*

Paired difference tests were employed to control for any confounding effects of city, building, shower room, and water supply line type and test the isolated effects of flushing and/or post-flush stagnation. To control for type I errors (false positives) among the multiple comparisons within each gene target, *p* values were adjusted for the false discovery rate using the procedure of Benjamini and Hochberg.^{S4}

Two paired difference tests were used. First, paired maximum likelihood estimation (MLE) was used via the 'survival' package in R, S5,S6 using procedures described by Helsel S2 and with supplemental R code adapted from Huston and Juarez-Colunga S3 to use the grammar and data structures of 'tidyverse' and 'magtrittr' packages S7,S8 (example provided in Code S1). Residuals were manually assessed for normality[†] using quantile-quantile plots. Occasionally, 'survival' did not converge to a solution, so Fong's modified sign test was used instead S9 (example provided in Code S2).

Multivariate and Univariate Correlation

To account for censored values, ranked gene concentrations^{S2} (ranked ascending, such that large values rank higher and with ties ranked equally) were assessed for correlation with water quality (total chlorine, temperature, and pH). An example null hypothesis is given:

 H_0 : 16S rRNA gene concentration ranks do not co-vary with the ranks of total chlorine[‡]

Using a multivariate approach, ranked gene concentrations were subjected to principal components analysis (PCA) with the R 'vegan' package.^{S10} Water quality data were fit to the biplot ordination using the *envfit* function, and p values were generated using 999 permutations.

As an alternative to the multivariate approach, all pairings of gene marker concentration were assessed for monotonic correlation with total chlorine, temperature, or pH using Spearman's rank tests.

Quantitative Microbial Risk Assessment

Inhaled doses were calculated with an adapted version of the equation of Hamilton et al. ^{S11} (Eq. 1).

where C_w is the pathogen concentration in water from the fixture (copies/L), *H* is a dose harmonization factor for conversion of colony-forming units (CFU) to concentration via quantitative polymerase chain reaction (qPCR) (CFU/copies), *B* is human breathing rate (m³/min), *t* is duration of human exposure while showering (min), $C_{a,i}$ is the concentration of aerosols (1/m³) in the air at specified aerosol sizes, *i* (ranging from 1 to 10 µm by increments of 1 µm), $V_{a,i}$ is the volume of individual aerosols at the specified aerosol size, F_i is the proportion of bacterial cells partitioned at the specified size, and D_i is the alveolar deposition efficiency of aerosols at the specified size. Notably, this adapted version includes a dose harmonization factor, *H*, which was not needed by Hamilton et al. ^{S11} Values for *H* are based on those reported by Lee et al. ^{S12} and Ditommaso et al. ^{S13} for *Legionella*. For MAC, *H* was assumed to be 1 (conservatively) due to a lack of data. ^{S14} All other values were adopted from Ahmed et al. ^{S15} and Hamilton et al. ^{S14}

Ingestion dose estimates were quantified using Eq. 2.

where V_i is the volume (L) of water accidentally ingested while showering. Values for V_i were obtained from Ahmed et al.^{S15} and were assumed to be independent of shower head type (i.e., conventional versus efficient).

SI Results

Relationships Between Water Quality and Microbiological Indicators

Initially, the potential confounding variables of city, building/site, and water supply type (i.e., cold versus hot water) were fit simultaneously (using the *envfit* function) with total chlorine, temperature, and pH. This initial analysis indicated that city and building site—but not water supply type—were significant confounding variables (Code S4). Subsequent data exploration, however, indicated temperature (and by extension, water supply type) had a non-monotonic relationship with all four marker genes (bell-shaped with a maximum of approximately 29 to 30 °C; data not shown), which can violate the method assumptions.

After segregating observations by water supply type (cold or hot), temperature was associated with the gene concentrations, particularly in the cold water supplies (Code S5 and S6). Because water temperature in the hot water systems was often observed below 30 °C, the non-monotonic relationship of temperature likely still existed for the hot water data set, consequently weakening the power of the multivariate analysis to determine an effect. During these analyses, PCA was performed with the effects of city and building site 'partialled out' using a conditioning matrix.^{S10}

Spearman's rank tests were performed on subsets by municipal water system (Minneapolis or St. Paul) and water supply type (cold or hot), to account for either the confounding effect of city or non-monotonic structure of temperature via water supply type. Results for Minneapolis and St. Paul are summarized, respectively, in Tables S8 and S9. The effect of building site within municipal system was assumed to be minimal.
